FirstLight Fiber, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the FirstLight Fiber, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1. Description of the Plan

The FirstLight Fiber, Inc. 401(k) Plan (Plan) was established on September 1, 2002. The Plan is sponsored by FirstLight Fiber, Inc. (FirstLight) and was most recently restated effective March 20, 2024.

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan provisions.

a. General

The Plan is a defined contribution plan covering all eligible employees of FirstLight and its wholly owned subsidiaries (collectively referred to as the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 20, 2024, Plan assets are held by Fidelity Management Trust Company, Trustee of the Plan. Prior to the change in service providers, Plan assets were held by MG Trust Company (d/b/a Matrix Trust Company), Custodian of the Plan. Company contributions, participant elective deferrals, and participant accounts are currently held by the Trustee, which invests cash received and income from investments based on written instructions from the Company and participants and makes distributions to participants. The Plan's Investment Committee and trustees are responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

b. Contributions

Each year, participants may contribute a percentage or fixed dollar amount of their pre-tax annual compensation. In addition, participants may contribute after-tax Roth elective contributions to the Plan. Contributions are subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). The maximum participant deferral was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions up to a maximum of \$7,500 for both years ended December 31, 2024 and 2023. Participants may also contribute rollover amounts representing distributions from other qualified retirement plans and individual retirement accounts.

Under the "safe harbor" election, the Company matches a portion of eligible employee contributions. The match is 100% for the first 3% of a participant's annual compensation contributed and 50% for the next 2% of the participant's annual compensation, for a maximum employer-matching contribution of 4% of the participant's annual compensation.

The Company, at its discretion, may also make profit sharing contributions. Such contributions are determined by the Company and are based on a permitted disparity formula. There were no profit sharing contributions for the years ended December 31, 2024 or 2023.

Participants direct their contributions and Company contributions made on their behalf into various investment options offered by the Plan.

c. Plan Eligibility

Employees of the Company are eligible to participate in the Plan after reaching 21 years of age. Employees may join the Plan on the date of their employment with the Company or following the employee reaching 21 years of age (if later). Prior to March 20, 2024, participants who were actively employed at the end of the Plan year shared in the allocation of the discretionary profit sharing contribution, if any, regardless of service. Terminated participants shared in the allocation if they completed 500 hours of service during the Plan year. Effective March 20, 2024, participants must complete 1,000 hours of service and be actively employed at the end of the Plan year to share in the allocation of the Company's discretionary profit sharing contributions. Participants who are not actively employed at the end of the year due to death, total and permanent disability, or early or normal retirement, but otherwise meet eligibility requirements, will share in the employer's discretionary profit sharing contribution. All eligible participants receive the Company's safe harbor matching contribution, regardless of hours of service during the year or employment status at year-end.

d. Participant Accounts

Each participant's account is credited with (1) the participant's contribution and the Company's safe harbor match, (2) allocations of the Company's discretionary profit sharing contribution (if any), and (3) Plan earnings (losses) (net of investment expenses and administrative expenses incurred by the Plan). Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their contributions, plus actual earnings (losses) thereon, and employee rollover contributions. Participants are also immediately vested in the Company's safe harbor matching contributions and profit sharing contributions (if any), plus actual earnings (losses) thereon.

f. Participant Notes Receivable

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. In addition, the \$50,000 limit is reduced by the highest outstanding loan balance (of any previous loans made) in the previous 12 months. Participant notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. In general, principal and interest are paid ratably over a period not to exceed five years through regular payroll deductions.

g. Payment of Benefits

Upon the termination of service due to death, disability, or retirement, a participant (or their beneficiary upon death) may elect to receive an amount equal to the value of the participant's vested interest in their account as a lump-sum distribution or as a rollover to another plan, withdraw a portion of their account, or defer distribution to a later date. If the vested portion of a participant's account balance is \$5,000 or less (\$7,000 as of January 1, 2024), this amount will be paid as a lump-sum distribution as soon as possible following termination, retirement or disability, or to the beneficiary following death.

Prior to termination, a participant may receive a distribution in the event of undue financial hardship, subject to the provisions of the Plan. The Plan also provides for in-service distributions for participants who have reached age 59½, subject to the provisions of the Plan.

h. Revenue-Sharing Credits

The Plan earns revenue-sharing credits from certain mutual funds based on the invested balances, which are included in Plan assets. The credits may be used to pay reasonable and permitted administrative expenses or be allocated to participant accounts. There were no credits used to pay Plan expenses during the years ended December 31, 2024 or 2023. The balance in the Plan's revenue-sharing account was approximately \$4,600 as of December 31, 2024. There was no balance in the Plan's revenue-sharing account as of December 31, 2023.

Note 2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) for defined contribution plans.

b. Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value, which is defined as the price that would be received to sell an asset in an orderly transaction between market participants on the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the Custodian or Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

d. Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year the employee contributions are withheld from compensation.

e. Participant Notes Receivable

Participant notes receivable are stated at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Loans treated as distributions totaled approximately \$47,100 and \$102,400 for the years ended December 31, 2024 and 2023, respectively.

f. Payment of Benefits

Benefits are recorded when paid.

g. Administrative Expenses

Administrative expenses of the Plan are paid by the Plan and the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses related to the administration of participant notes receivable and distributions are charged directly to the participant's account and included in administrative expenses. Investment advisory and asset management fees paid by the Plan are allocated proportionately to participants based on the value of their account balances. Investment-related expenses are included in net appreciation in fair value of investments.

h. Subsequent Events

The Plan has evaluated subsequent events for potential recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to cash, investments and participant notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash (noninterest-bearing), investments and participant notes receivable held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on participant notes receivable for the years then ended, was obtained by management and agreed to, or derived from, information certified as complete and accurate by the Trustee (as of and for the year ended December 31, 2023 and for the period January 1, 2024 through March 19, 2024) and the Custodian (as of December 31, 2024 and for the period from March 20, 2024 through December 31, 2024) of the Plan.

Note 4. Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 or 2023.

Cash held for investment: The carrying amounts of cash approximate fair value because of the short maturity of these investments.

Mutual funds: Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: The fund invested in a guaranteed separate account group annuity contract issued by Metropolitan Life Insurance Company through March 19, 2024. Effective March 20, 2024, the fund invests in a guaranteed separate account group annuity contract issued by T. Rowe Price. The NAV is used as a practical expedient to measure fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require 12 months' notification in order to ensure that the securities liquidation will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

Note 6. Tax Status

Prior to the Plan restatement on March 20, 2024, the Company had adopted a pre-approved plan document that received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Effective March 20, 2024, the Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party and Party-in-Interest Transactions

Administrative expenses incurred and paid by the Company totaled \$16,260 and \$14,500 for the years ended December 31, 2024 and 2023, respectively.

Certain Plan administrative functions are performed by officers or employees of the Company who do not receive compensation for such functions from the Plan.

Several Plan investments are managed by the Trustee of the Plan.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events that could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
