## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Arc of North Carolina, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Arc of North Carolina, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS

December 31, 2024

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the 401(k) Plan ("Plan") of the Arc of North Carolina, Inc. ("Organization") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of the Organization who are age eighteen or older and have completed one year of service and 1000 hours. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of The Arc of North Carolina, Inc. oversees governance of the Plan. The Plan was amended and restated, effective as of January 1, 2022 and has subsequently been amended.

#### **Contributions**

Each year, participants may contribute the maximum amount allowed by law, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed interest account as investment options for participants.

The Organization contributes 100% of each participant's contributions up to 3% of the participant's compensation and an additional 50% on the next 2% of compensation contributed by the participant. The employer matching contribution is invested in the same manner as the participant's contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's matching contribution and, (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions, the Organization's contributions, and actual earnings thereon.

#### **Forfeited Accounts**

At December 31, 2024, there were no forfeited non-vested accounts.

**NOTE 1 - DESCRIPTION OF PLAN (continued)**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 less outstanding loan principal and interest or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.5%, which are commensurate with local prevailing rates as determined by the Plan Administrator at the time of loan issuance. Principal and interest is paid ratably through biweekly payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments under the laws governing required minimum distributions. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Date of Management's Review**

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Payment of Benefits**

Benefits are recorded when paid.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Operating Expenses**

Expenses of maintaining the Plan are paid by the Organization, with the exception of transaction processing fees for loans and distributions that are paid by the participants.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means and Level 3 inputs are unobservable and significant to the fair value measurement. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 inputs were available to the Plan, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements* – The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

*Level 3 Fair Value Measurements* – The CMFG Stable Value Account is a Deposit Administration Group Annuity Contract with an insurance company, which provides a fixed, guaranteed rate of return. The fund seeks a high level of current income consistent with preservation of capital by investing primarily in corporate bonds, mortgage-backed securities, collateralized mortgage obligations, high quality commercial mortgage loans, municipal bonds and other high-grade fixed income securities. The Stable Value Account is guaranteed by CMFG Life Insurance Company.

**NOTE 4 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Arc of North Carolina, Inc., the plan sponsor, paid certain expenses on behalf of the plan. These include a contract with Apple, Koceja & Associates, PA to provide auditing services. Also, three officers of the Organization serve as trustees and plan administrator of the Plan.

The Plan's assets are administered under a contract with CUNA Mutual. The company invests funds received from contributions, investment sales, interest, and dividend income and makes distribution payments to participants.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service has determined and informed the Organization by a letter dated March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes has been recorded in the accompanying financial statements.

**NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8 – INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)**

Matrix Trust Company, as investment trustee, held the Plan's investments at December 31, 2024. The investments in the statement of net assets available for benefits, the investment income reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the information included in the supplemental schedules was certified by Matrix Trust Company as complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

**NOTE 9 – PARTIAL PLAN MERGER AND TRANSITION TO POOLED EMPLOYER PLAN (PEP)**

Effective October 1, 2024, The Plan commenced a transition of its retirement assets to The Arc PEP, a Pooled Employer Plan, ("PEP"), sponsored by The Arc of NC, Inc. This transition was executed pursuant to a formal plan of merger agreement approved by the Plan Sponsor and in accordance with applicable IRS and Department of Labor regulations.

Under the terms of the agreement, a portion of the Plan's assets and related participant accounts were transferred to the PEP as of October 1, 2024. The remaining assets will continue to be held and administered under the existing plan structure, with Matrix Trust Company continuing to serve as the trustee and/or custodian of those assets.

**NOTE 9 – PARTIAL PLAN MERGER AND TRANSITION TO POOLED EMPLOYER PLAN (PEP) (Continued)**

The transfer of remaining Plan assets is expected to occur in phased annual installments over a five-year period, concluding no later than September 30, 2029. This transition timeline was established to accommodate investment, administrative, and participant considerations. During the interim period, participants whose assets remain with the original Plan will continue to receive all services and investment options under the existing plan provisions, until their respective balances are transitioned to the PEP.

Participants whose balances were transferred as of October 1, 2024, are now subject to the terms and conditions of the PEP, including its investment lineup, administrative processes, and service providers.
