Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fairhope Hospice & Palliative Care, Inc. Profit Sharing & 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Fairhope Hospice & Palliative Care, Inc. NOTE A - DESCRIPTION OF PLAN

The following description of Fairhope Hospice & Palliative Care, Inc. Profit Sharing & 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) Profit Sharing Plan covering eligible employees of Fairhope Hospice & Palliative Care, Inc. (the Organization). Eligibility is met by full-time employees upon completing six months of service and attaining age 18, and by long-term, part-time employees who meet the minimum service requirements mandated by the Setting Every Community Up for Retirement Enhancement (SECURE) Act. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The SECURE 2.0 Act was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates. The Plan is required to operate in compliance with the mandatory provisions as of their effective date. The Plan Administrator will determine which optional provisions to elect and will amend the Plan document accordingly. As of December 31, 2024, the Plan Administrator has not adopted any optional provisions.

For the plan year ended December 31, 2023, the Plan implemented mandatory provisions of the SECURE Act 2.0, which included increasing the age for Required Minimum Distributions (RMDs) from 72 to 73 and reducing the excise tax for failing to take a timely RMD.

For the plan year ended December 31, 2024, the Plan operated in compliance with additional mandatory provisions. These included the elimination of pre-death RMDs for designated Roth accounts, the increase of the involuntary cash-out limit from \$5,000 to \$7,000, and the requirement to allow elective deferrals for long-term, part-time employees who meet specific service requirements, as originally mandated by the SECURE Act of 2019.

The Plan Administrator believes the Plan has been administered in all material respects in accordance with the effective dates of the applicable provisions of the SECURE Acts.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions and employer matching and profit sharing contributions in any of the investment options offered by the Plan.

Contributions

Participants may contribute up to 75% of their compensation, within the salary deferral limitations imposed by Section 401(k) of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. In 2024 and 2023, the employer made a discretionary matching contribution of 50% of the first 4% of compensation. They also made a discretionary profit sharing contribution based on a pro rata formula of each participants qualifying compensation to total compensation of all qualifying participants for the Plan year. The profit sharing contribution was 1% for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Organization's contributions and Plan earnings. Allocations are based on participant earnings, compensation, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service, provided the deferral percentage tests are satisfied. A participant is 100% vested after five years of service. In the event that the participant becomes disabled or dies, or the Plan is terminated, a participant becomes 100% vested in their account balance regardless of years of service

Payments of Benefits

Upon termination of service, death, disability, or retirement, a participant or their beneficiary may elect to receive their vested account balance as a lump-sum payment or in other forms permitted by the Plan. The Plan also allows for in-service distributions to be made to active participants under certain conditions, which vary by contribution source. Participants may withdraw funds from their rollover contribution account at any time. Distributions from a participant's salary deferrals are permitted upon attainment of age 59½, financial hardship, disability, or for qualified active military service. For vested amounts attributable to employer matching and other employer contributions, a participant may take an in-service distribution upon reaching the Plan's Normal Retirement Age or in the event of disability.

Forfeited Accounts

Forfeitures of nonvested funds from terminated participants are used to reduce employer contributions and pay plan administrative expenses. For the year ended December 31, 2024, \$5,621 in forfeitures and \$78 in investment earnings were added to the forfeiture account, while \$3,266 was used to offset employer costs. The remaining balance in the forfeiture account was \$4,133 and \$1,700 as of December 31, 2024 and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with generally accepted accounting principles.

Valuation of Investments and Income Recognition

Plan investments are stated at estimated fair values. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with U.S. generally accepted accounting principles. Those estimates and assumptions affect certain reported amounts and disclosures. Accordingly, actual result could differ from those estimates.

Income Taxes

The Organization has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by Department of Labor or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

NOTE C - CERTIFIED INVESTMENTS

The Custodian, Matrix Trust Company, has certified to the Plan Administrator that the annual account obtained by management, including the list of investments and investment income, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, is complete and accurate. A summary of information included in the financial statements, which has been certified, is as follows at December 31:

NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820 establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described in the table below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- **Quoted prices for similar assets or liabilities in active markets;**
- **Quoted prices for identical or similar assets or liabilities in inactive markets;**
- **Inputs other than quoted prices that are observable for the asset or liability;**
- **Inputs that are derived principally from or corroborated by observable market data by correlation or other means.**

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- ***Money markets:*** Valued at the net asset value (NAV) of shares held by the Plan at year-end. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market. (Level 1)
- ***Mutual funds:*** Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. (Level 1)
- ***Common collective trust funds:*** Valued at NAV per share as a practical expedient. In accordance with GAAP, since the common collective funds are measured using the NAV per share practical expedient, this fund is not classified in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PLAN TERMINATION

Although it has not expressed intent to do so, the Plan's management has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

NOTE F - ADMINISTRATIVE COSTS

The Plan's administrative fees are paid by the Plan. For the year ended December 31, 2024 the Plan incurred administrative expenses of \$35,406.

NOTE G - PARTY-IN-INTEREST

Certain transactions of the Plan are with parties in interest as defined by the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor (Fairhope Hospice & Palliative Care, Inc.) is a party in interest. The Plan Sponsor provides administrative services to the Plan at no cost.

Matrix Trust Company serves as the Custodian for the Plan's assets. As a fiduciary with discretionary control over the Plan's assets, the Custodian is also a party in interest.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
