Basis for Opinion

1. Plan Description

The following description of SafeSource Direct, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all eligible employees of SafeSource Direct, LLC ("Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Eligibility* – The Plan substantially covers all employees of the Company who have completed six months of service. The Plan excludes union, leased, and nonresident alien. Once an eligible employee has satisfied the eligibility, they may begin contributing on the first day of the next Plan quarter.
- c) *Contributions* – Each year participants may contribute to the Plan up to the maximum amount allowed by law, subject to certain limitation under the Internal Revenue Code ("IRC"). Contributions may be made pre-tax or post-tax (Roth). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans (rollover contributions).

The Company makes safe harbor matching contributions each pay period, the match is 100% of participant deferrals, up to 4%. The Company may, at its sole discretion, make additional matching contributions and profit sharing contributions on an annual basis for all eligible employees who have made contributions in the current year. For the year ended December 31, 2024, the Company made no such discretionary contributions.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or website.

- d) *Participants Accounts* – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances,

as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- e) *Vesting* – Participants are vested immediately in their contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is vested 20% after two years of credited service, and additionally every year thereafter, until fully vested at six years.
- f) *Notes receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at prime rate. Participants are allowed to have only one loan outstanding at any time. Principal and interest is paid ratably through payroll deductions.
- g) *Excess Contributions Payable* – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants on March 15, 2025.
- h) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution. In-service withdrawals may be taken from fully vested funds if age 59 ½ or older, or in the event of financial hardship.
- i) *Forfeited accounts* – Forfeitures of nonvested balances may be used to restore forfeitures, reduce Company contributions, or pay reasonable Plan expenses. At December 31, 2024, no forfeitures were used for these purposes by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, the Transamerica Stable Value Core Option, which is stated at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative costs of the Plan are paid directly by the Company.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value

hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts - Valued at the daily using publicly available quoted market prices. PSA's held by the Plan are based on the underlying mutual funds that are traded on an established market. The PSA's are unitized to match the current fair market value of the underlying assets.

6. Guaranteed Investment Contract (GIC) with Insurance Company

The Plan holds a benefit-responsive investment contract with Transamerica Retirement Solutions, LLC, named the Transamerica Stable Value Core Option. The contract underlying this investment is considered to be fully-benefit responsive and therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment contract is a general account product. Transamerica is the owner of the assets in the account, and guarantees a minimum interest rate.

7. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

8. Party-in-Interest Transactions

The Plan's investments are held and managed by the Plan custodian, Transamerica Retirement Solutions, LLC, and therefore these transactions qualify as party-in-interest transactions.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

10. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by Transamerica Life Insurance Company ("Transamerica"). Voya obtained its latest opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes

that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt.
