## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of

### Report on the Financial Statements

#### Opinion

We have audited the financial statements of IBEW Local 1245 Money Purchase Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023; the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to financial statements – modified cash basis.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of IBEW Local 1245 Money Purchase Pension Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with the modified cash basis of accounting as described in Note 1.

#### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of IBEW Local 1245 Money Purchase Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

#### Emphasis of Matter - Basis of Accounting

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

#### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 1, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

## Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. #### **1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **Basis of Accounting**

The financial statements of IBEW Local 1245 Money Purchase Pension Plan (the “Plan”) have been prepared using the modified cash basis of accounting. This basis differs from generally accepted accounting principles primarily because the Plan has not recognized contributions receivable from employers or accounts payable and their related effects on additions and deductions to net assets. The basis also differs from the cash basis of accounting as the Plan recognizes investments at fair value and prepaid expenses when incurred.

##### **Investment Valuation, Transactions and Income Recognition**

###### *General*

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

*Level 1* - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

*Level 2* - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

*Level 3* - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

*Inputs and Valuation Methods* - In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for the Plan’s investment classes are presented below.

*Mutual Funds*: Values are determined using quoted prices in active markets (Level 1).

*Common/Collective Trusts*: The fair value of the units in the common/collective trusts is estimated based on the net asset value per unit of the underlying investments. The net asset value is being used as a practical expedient to estimate fair value.

*Valuation Methods, Consistency* - The valuation techniques used in the accompanying financial statements have been consistently applied.

*Transactions and Income Recognition* - Purchases and sales of securities are recorded on a settlement-date basis rather than on a trade-date basis.

Interest income and dividends are recorded when received. The Plan presents, in the statements of changes in net assets available for benefits - modified cash basis, the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation of those investments.

#### **Cash**

Cash consists of monies held in demand-deposit checking accounts and interest-bearing accounts without withdrawal restrictions.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Administrative expenses are generally paid by the Plan.

#### **Estimates**

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan invests in mutual funds and common/collective trusts. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits - modified cash basis and the statements of changes in net assets available for benefits - modified cash basis.

## **2. DESCRIPTION OF THE PLAN**

The Plan is a defined contribution plan maintained under collective bargaining agreements by and between the unions affiliated with the International Brotherhood of Electrical Workers Local 1245 and participating employers under the terms of a trust agreement, which was originally dated January 1, 1984, and subsequently amended in 2012. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Employers make contributions on behalf of the participants, as set forth in the collective bargaining agreements and participation agreements.

#### **Vesting**

Effective January 1, 2020, all employees who have completed 1 hour of service for a participating employer in covered employment become Plan participants and are eligible to participate in the Plan. Once an employee becomes a Plan participant, the participant is 100% vested in their interest in the Plan.

#### **Participant Accounts**

A separate account is maintained for each employee based on employer contributions and an allocation of the Plan's investment yield, plus forfeitures, less expenses paid or accrued since the previous valuation date, prorated on the basis of individual account balances determined as of the previous valuation date.

If any benefits payable to a participant remain unclaimed for five years after notification or attempted notification, the Plan shall apply such benefits to the expenses of the Plan. If a participant reappears and files a benefit application, the Plan will provide such participant with the benefits in their individual account at the time the individual account was closed. A participant's individual account is valued on a quarterly basis.

**Payment of Benefits**

Participants of the Plan are entitled to distributions of their account upon attainment of normal retirement age of 65 following termination of employment within the industry; however, participants may also qualify for a distribution upon early retirement or permanent disability as described in the Plan. The methods of distribution of a participant's account in the Plan include a lump sum, a life annuity contract, or a series of equal monthly installments made over a period of years.

Participants should refer to the Summary Plan Description for more information.

**3. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees, subject to the provisions of ERISA. Termination shall not permit any part of the Plan assets to be used for, or diverted to, purposes other than the exclusive benefit of the pensioners, beneficiaries, and participants. In the event of termination, benefits would be distributed to the participants and their beneficiaries as if the Plan had not been terminated.

**4. TAX STATUS**

The Plan obtained its latest determination letter, dated January 19, 2016, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of the Internal Revenue Code as of the financial statement date. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. FUNDING POLICY**

The participating employers contribute such amounts as are specified in the collective bargaining agreement. All contributing employers, except for one, ceased participating in the Plan effective in the January 2020 work month in accordance with the collective bargaining agreements (refer to Note 8.)
