## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Matkin-Hoover Engineering, Inc. 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Matkin-Hoover Engineering, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**Note A – Description of Plan**

The following brief description of the Matkin-Hoover Engineering, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan’s document for complete information regarding the Plan’s definitions, benefits, eligibility and other matters.

General

The Plan is a IRC section 401(K) salary deferral plan covering substantially all employees of Matkin-Hoover Engineering, Inc. and related entities through common ownership (the “Company” or the “Employer”) who have reached age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The trustee and custodian of the Plan is John Hancock Insurance Company (the “Trustee”).

Eligibility

Participants are eligible to participate in the Plan upon completion of one year of service in which at least 1,000 hours were completed. Participants can then enroll in the Plan on the first day of the quarter succeeding their one year anniversary date of hire.

Contributions

*Employee*

Each year, participants may contribute to the Plan an amount up to 100% of their annual compensation as pre-tax or Roth after-tax contributions. However, each participant’s annual contribution shall not exceed the maximum amount allowed for deferral as set forth by the Internal Revenue Code (the “Code”), which was \$23,000 for 2024 and \$22,500 for 2023. In addition, participants over age 50 were allowed to contribute an additional \$7,500 for 2024 and \$7,500 for 2023. The amount of a participant’s annual compensation that may be taken into account for purposes of determining the Company’s matching contribution for any purpose under the Plan shall not exceed an amount prescribed annually by the Code.

*Employer Safe Harbor*

Employees are automatically eligible to receive a 3% safe harbor employer contribution upon completion of their eligibility requirements for entry into the Plan. This contribution is not subject to any vesting requirements and the employees retain this money upon termination or withdrawal.

*Employer Special Discretionary*

A special discretionary contribution, as determined by the Company, may be contributed, pro rata, based upon each participating employee’s compensation to the total compensation of all participating employees. Participants are eligible to receive the Company special discretionary matching contributions after meeting eligibility requirements for entry into the Plan, subject to vesting requirements. No special discretionary contribution was made in 2024 or 2023.

If a participant makes a contribution during any year in an amount which exceeds the maximum amount allowed under the Code pertaining to highly compensated employees, the contribution is refunded and the matching contribution is applied against future safe harbor or discretionary Company contributions.

Vesting

Participants are immediately vested in their contributions (including rollovers) and the safe harbor 3% employer contribution plus actual earnings thereon. Vesting in the special discretionary employer contribution is based on years of continuous service with the Company, which is determined as a twelve consecutive month period ending on each anniversary of a participant's date of hire. Participants become 25% vested in Employer contributions after two years, and an additional 25% each year thereafter until 100% vested upon five years of credited service. Participants of the Cash America International, Inc. 401(k) Savings Plan (the "Cash America Plan"), which merged into the Plan effective December 30, 2016, become 20% vested in Employer contributions after one year, and an additional 20% each year thereafter until 100% vested upon five years of credited service. A participant is also 100% vested in Employer contributions upon reaching retirement age or if employment ceases by reason of total and permanent disability or death.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's special discretionary contributions, if applicable. The various participant allocations are based on a percentage of the participant's elective deferral or compensation in relation to total compensation of participants, as defined in the Plan document.

Investment Options

Upon enrollment into the Plan, a participant may direct their contributions to purchase any of the investment options offered by the Trustee of the Plan. Participants may change the allocation of their existing funds and future contributions at any time.

Payment of Benefits

Participants whose employment terminates for any reason (except death or disability) are generally entitled to receive the vested portion of their account in the form of a lump sum distribution payable in cash. Upon termination, the participant may request a distribution be made or for their balance to be rolled into another plan as soon as is administratively feasible. Any balance under \$7,000 is automatically paid out as soon as administratively feasible. Hardship withdrawals are permitted if the participant meets the eligibility requirements of the Plan.

Expenses

Expenses relating to the purchase or sale of investments are included in the cost or deducted from the proceeds, respectively. Direct charges and expenses, including investment manager fees attributable to specific investment funds, may be charged against that investment fund and are allocated to participant accounts based on the total of the participant balance relative to the fund balance of the entire Plan. Administrative expenses such as Trustee transaction fees are allocated directly to the participant account who is responsible for the transaction.

Forfeitures

Participants who terminate employment prior to being fully vested in the Company’s special discretionary contributions forfeit the non-vested matching employer contributions and related earnings. At December 31, 2024 and 2023, there were approximately \$1,128 and \$1,931 of forfeited non-vested amounts. Forfeitures of Company matching contributions may be used to reduce future Employer’s matching contributions to the Plan.

Tax Status

The IRS has determined and informed the Company by a letter dated September 30, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Code. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America (“GAAP”) requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Subsequent Events**

The Plan monitors significant events occurring after the balance sheet date and prior to the issuance of the financial statements to determine the impacts, if any, of events on the financial statements to be issued. The Plan has evaluated subsequent events through October 3, 2025, the date which the financial statements are issued.

**Note B – Summary of Accounting Policies**

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with U.S. GAAP.

Valuation of Investments

The Plan’s investments are stated at fair value. Shares of mutual funds are valued at quoted market prices as of the last trading day of the Plan year. Investments in money market funds are valued using \$1 for the Net Asset Value (“NAV”) as a practical expedient. Reinvested income, accrued interest and dividends are reflected as additions to the cost basis of the investments. Investment transactions are recorded on a trade-date basis. Interest income is recorded when earned and dividend income is recorded on the ex-dividend date. The Plan did not record any interest or dividend income for the year ended December 31, 2024. The Plan presents in the statement of changes in net assets available for benefits the net depreciation in the fair

Value of its investments, which consists of net realized gains or losses on investments sold during the year and the unrealized net appreciation on those investments held at the end of the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP, as applied to defined contribution employee benefit plans, requires the Plan's management to make estimates and assumptions that affect the amounts reported in these financial statements and accompanying notes. Actual results could differ from those estimates.

Recent Accounting Pronouncements

The Plan is currently evaluating the implications of the Secure 2.0 Act and its effects on the Plan. Current implementation is being designed as necessary for applicable components of the Secure 2.0 Act.

**Note C – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

**Note D – Related Parties and Parties-In-Interest**

The Trustee of the Plan is a party-in-interest as defined by ERISA. The Trustee invests certain Plan assets in common/collective trust funds, mutual funds and money market funds managed by the Trustee or its affiliates, and such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. Amounts paid as compensation to the Trustee of the Plan for the years ended December 31, 2024 and 2023 was \$17,032 and \$15,038, respectively, amounts paid to registered investment advisors for the years ended December 31, 2024 and 2023 was \$14,017 and \$12,183, respectively. These transactions are party-in-interest transactions under ERISA.

**Note E – Information Certified and Provided by John Hancock Insurance Company**

The investment schedule included in Note F is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedules, that was prepared or derived from information certified and provided by John Hancock Insurance Company, the Trustee and custodian of the Plan. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedules related to the assets as listed in the investment schedule included in Note F.

John Hancock also certified as to the completeness and accuracy of \$617,680 of net appreciation in fair value of investments related to the aforementioned investments for the year ended December 31, 2024.

**Note F – Fair Value Measurements**

In accordance with GAAP, the Plan's assets and liabilities, which are carried at fair value, are classified in one of the following three categories:

Level 1 – Quoted prices in active markets for identical investments.

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3 – Unobservable inputs that are not corroborated by market data.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for instruments measured at fair value.

Money Market Funds

These investments are public investment vehicles valued using \$1 for the NAV, or its equivalent, as a practical expedient.

Mutual Funds

These investments are valued at quoted market prices as of the last trading day of the Plan year and are classified within Level 1 of the fair value hierarchy. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets or liabilities measured at fair value on a nonrecurring basis as of December 31, 2024 or 2023, and there were no changes in the valuation methodologies between these periods.
