INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
Pressmen Local 72 401(k) Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Pressmen Local 72 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Pressmen Local 72 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

We are required to be independent of the Pressmen Local 72 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Pressmen Local 72 401(k) Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. 1. DESCRIPTION OF THE PLAN

The following description of the Pressmen Local 72 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement or summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established on January 1, 1990. The Plan covers employees in jobs covered by collective bargaining agreements with the Washington Printing Pressmen, Assistants and Offset Workers Union Local 72-C (the Union) or Graphic Communication International Union Local No. 144-B (GCIU) who have attained the age of 18 and who have elected to participate. Effective August 1, 2007, GCIU Local 144-B is no longer considered a participating employer with respect to its employees and officers.

The Plan has been amended since the adoption with the most recent amendment on June 30, 2022. The amendment did not significantly change any Plan provisions. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”) and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, participants may elect to contribute up to 100% of their eligible compensation, subject to Internal Revenue Service (“IRS”) limits, on a pre-tax basis as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Certain participating employers provide benefits through employer contributions. These employer contributions consist of profit-sharing contributions as provided in the collective bargaining agreement with the participating employer. Employer contributions made to the Plan totaled \$116,297 for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their allocations on a daily basis. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollovers, employers’ contributions, if applicable, and earnings/losses from the participant’s investment accounts and charged with an allocation of the Plan administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer contributions plus earnings thereon is full and immediate, except as may be stated in the collective bargaining agreement, consistent with the IRC.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, provided certain limited circumstances were met. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates, as determined by the Board of Trustees. As of December 31, 2024, the interest rates on outstanding loans ranged from 4.25% - 9.50%. Principal and interest are paid ratably through payroll deductions. Participants may repay their loan in whole or in part without penalty.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's account balance. All benefit payments from the Plan are made in the form of a lump-sum. The Plan allows for automatic distribution of participant's benefits totaling \$1,000 or less. In-service hardship distributions are permitted if certain criteria are met.

Forfeited Accounts

Any forfeiture will be used to reduce administrative expenses. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. During the year ended December 31, 2024, no forfeited nonvested accounts were used to pay administrative expenses.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors and John Hancock Life Insurance Company (U.S.A.) ("John Hancock"), the certifying entity of the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Each participant's account is charged with a pro-rata share of the Plan's administrative expenses on a quarterly basis. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after December 31, 2024, for potential recognition or disclosure in the financial statements. The events and transactions were evaluated through October 8, 2025, which is the date the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Interest-bearing cash: Cash is recorded at cost, which approximates fair value. Classified as Level 1 investment. As of December 31, 2024 and 2023, interest-bearing cash totaled \$1,294 and \$6,347, respectively.

The Plan's investments are held in *pooled separate accounts* that are measured at fair value using the net asset value ("NAV") per share (or its equivalent) as a practical expedient. In accordance with Subtopic 820-10, these investments are not classified in the fair value hierarchy.

Aggressive Growth: Rapid growth and appreciation are the key objectives by utilizing domestic, international or emerging country equity markets and market capitalizations, including heavier concentrations or through riskier techniques than core growth strategies.

Asset Allocation

Lifestyle: A series of funds that seek a stable balance of risk-and-return potential. Each fund invests in a different combination of underlying funds, which are continually adjusted to capture opportunities and manage risks.

Target Date: A series of funds designed to provide high total returns until the target retirement date. Each fund invests in various asset classes using an asset allocation strategy designed for the investors expected to retire in the designated retirement year.

Conservative: Seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long-term.

Growth: Pursues capital appreciation foremost by investing in equity securities across domestic and international markets and across certain market capitalizations; may be exposed to all market risks.

Income: A high level of current income is sought by broadly investing in fixed income securities through various sectors of the bond market and gaining exposure to various types of credit and interest rate risk.

Participants should refer to each pooled separate account's individual prospectus on the John Hancock website for a more complete description of the fund's investment strategy.

The fair values of the investments in this class have been estimated using the NAV per share (or its equivalent) as a practical expedient. There are no participant redemption restrictions for these investments.

4. INFORMATION CERTIFIED BY JOHN HANCOCK LIFE INSURANCE COMPANY (U.S.A.)

The following is a summary of the Plan's information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by John Hancock Life Insurance Company (U.S.A.) (John Hancock), the certifying entity of the Plan. The Plan Administrator has obtained certifications from the certifying entity that information provided to the Plan Administrator by the certifying entity related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following:

5. PLAN TERMINATION

Although they have not expressed any intent to do so, the Board of Trustees of the Plan have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

6. TAX STATUS

The Plan obtained its latest determination letter from the IRS dated June 26, 2015, which ruled that the Plan is designed in accordance with the applicable sections of the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, two investments represented a concentration of greater than 10% of the Plan's net assets available for benefits.

8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock, the certifying entity of the Plan and, therefore, these transactions qualify as party-in-interest transactions for which a statutory exemption applies. During the year ended December 31, 2024, the Plan paid administrative fees of \$89,891 to John Hancock.

Retirement Planners & Administrators, Inc. is the third party administrator for the Plan and, therefore, a party-in-interest. During the year ended December 31, 2024, the Plan incurred administrative fees of \$12,832 for Retirement Planners & Administrators, Inc.

Gallagher Fiduciary Advisors ("Gallagher") is the investment advisor for the Plan and, therefore, a party-in-interest. The Plan paid advisory fees of \$13,000 to Gallagher during the year ended December 31, 2024.

O'Donoghue & O'Donoghue, LLP ("O'Donoghue") is the legal counsel for the Plan and, therefore, a party-in-interest. The Plan paid legal fees of \$6,435 to O'Donoghue during the year ended December 31, 2024.

WithumSmith+Brown, PC ("Withum") is the auditor of the Plan and, therefore, a party-in-interest. The Plan paid audit fees of \$11,232 to Withum during the year ended December 31, 2024.

The Plan also issues loans to participants, which are secured by the participant's vested account balance. These transactions qualify as party-in-interest transactions.
