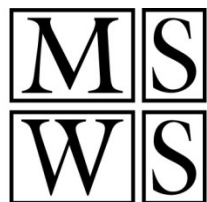

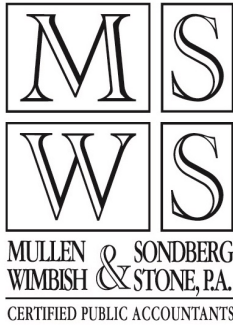

Note 1 - Description of Plan

The following description of the Calvert Internal Medicine Group, P.A. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established June 30, 1986 and amended effective January 1, 2016, is a defined contribution plan covering substantially all employees of Calvert Internal Medicine Group, P.A. (the Employer). Under the provisions of the Plan, an employee may become a participant after completing 1,000 hours of service and attaining age twenty-one. An employee may enter the Plan on either January 1<sup>st</sup> or July 1<sup>st</sup> each year after satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees may elect to defer up to 100% of their compensation and have such deferrals contributed by the Employer to their account under the Plan. Participants may also elect to make pre-tax or after-tax (ROTH) contributions. Participant contributions are subject to the annual Internal Revenue Code limits as adjusted each year. Employee contributions may be further limited so that the Plan complies with the 401(k) and 401(m) nondiscrimination tests. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the Employer will make an "ADP safe harbor" contribution equal to 3% of each eligible participant's compensation. The Employer may also elect to make a discretionary profit-sharing contribution each year. In addition to the basic eligibility requirements, participants must be employed by the Employer on the last day of the plan year to receive a discretionary profit-sharing contribution. The Employer's discretionary profit-sharing contributions are allocable to participants using a tiered system based on age and employment status with the Employer. Contributions made by the Employer for the years ended December 31, 2024 and 2023 were \$906,887 and \$835,153, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution, Plan earnings, and Plan expenses and fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Contributions are invested, at the discretion of the participants, in one, several, or all of the investment alternatives selected by the plan administrator. Participants may also invest their contributions in a self-directed brokerage account.

Note 1 - Description of Plan (Cont.)

Vesting

Participants are immediately vested in their contributions and in the Employer “ADP safe harbor” contributions plus actual earnings thereon. Vesting in the Employer “profit sharing” contributions is based on years of continuous service. A participant is 100% vested after six years of credited service. A year of credited service is a Plan year in which the participant is credited with at least 1,000 hours of service with the Employer. Upon termination of employment due to death or disability or attaining retirement age as defined by the Plan, a participant becomes fully vested in their account.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in either a lump-sum amount, or in annual installments over the life expectancy of the participant and/or designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are permitted under the Plan in accordance with Internal Revenue Service regulations.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,003 and \$450, respectively. These amounts are available to reduce future Employer contributions to the Plan. For the years ended December 31, 2024 and 2023, Employer contributions were reduced by \$3,003 and \$450, respectively, from forfeited non-vested accounts.

Notes Receivable from Participants

Under certain circumstances, as outlined in the Plan document, the Plan allows employees to obtain loans from the Plan. These loans are secured by the vested portion of the participants account and bear interest at 4.25% - 9.50%. Repayment of loans is provided through automatic payroll deductions.

Administrative Expenses

Certain administrative expenses related to the Plan are paid directly by the Employer. Administrative fees related directly to transactions initiated by participants are paid by the Plan and allocable to each participant’s account. Administrative expenses related to recordkeeping and plan administration are paid by the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with United States Generally Accepted Accounting Principles under the accrual basis of accounting. Consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Contributions and Related Receivables

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from the amounts paid. The Employer “safe harbor” and the Employer discretionary profit-sharing contributions are recorded in the year in which the Employer designated the contributions. All participant and employer contributions are participant-directed. The plan administrator has determined that all participant and employer contributions receivable are fully collectible; consequently, no amount has been recorded as an allowance for credit loss in the accompanying statement of net assets available for benefits.

Note 3 - Information Prepared and Certified by Trustee

Investment Data

All investment data contained in the statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ending December 31, 2024 and 2023, and the supplemental Schedule H, line 4i - schedule of assets (held at end of year) as of and for the year ending December 31, 2024, was summarized from information supplied and certified as complete and accurate by the Newport Trust Company, the Trustee of the Plan.

Schedule of Assets Held for Investment Purposes

The accompanying supplemental Schedule H, line 4i - schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of December 31, 2024.

Note 4 - Fair Value Measurements

*ASC 820-10 "Fair Value Measurements"* establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment company shares:* Valued at the daily closing prices as reported by the fund. Registered investment company shares held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment company shares held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Valued based on the quoted market prices of the assets held within the self-directed brokerage accounts.

Note 5 - Related Party and Party-in-Interest Transactions

Fees paid by the Plan to the Plan's Trustee for the investment, management, and administrative services amounted to \$82,906 and \$56,447 for the years ended December 31, 2024 and 2023, respectively.

Note 6 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the end of the year. During the Plan years ended December 31, 2024 and 2023, there were no reportable transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts.

Note 8 - Tax Status

Effective January 1, 1990, the Plan adopted a non-standardized form of prototype plan. The prototype plan obtained its latest approval effective June 30, 2020 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since the prototype received its opinion letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10 - Subsequent Events

The Plan has evaluated the impact of significant subsequent events. There have been no subsequent events through September 6, 2025, the date the Plan's financial statements were available to be issued, that require recognition or disclosure in the financial statements.
