Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TAK Broadband CA, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter-Plan Merger

As discussed in Note 2 to the financial statements, delegates from TAK Broadband CA, LLC, the plan sponsor, and the plan sponsor's majority owner, voted in June 2025 per the Delegation of Authority to merge the Plan into the TAK Broadband, LLC 401(k) Plan. Transfer of plan assets has not yet occurred. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Note to Financial Statements

Note 1. Description of Plan

The following description of TAK Broadband CA, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was established on January 1, 2019, and is a defined contribution plan covering qualified employees of TAK Broadband CA, LLC (the Company and Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan name change: Effective August 12, 2024, the name of the Plan was changed from TAK Communications CA, Inc. 401(k) Plan to TAK Broadband CA, LLC 401(k) Plan.

Eligibility: Employees are eligible to participate in the Plan upon completing three months of service. Employees are eligible for Company discretionary employer match and profit-sharing contributions if they have completed three months of service.

Entry date: Employees may enter the Plan on the first day of the calendar month coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions: Participants may elect to contribute to the Plan, in the form of pretax deferrals or after-tax (Roth) deferrals, up to 100% of their eligible compensation, as defined in the Plan documents, up to the maximum allowable by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company may make discretionary employer matching and profit-sharing contributions to the Plan. The Company approved a 3% discretionary match for participants contributing 6% or more for the year ended December 31, 2024. There were no profit-sharing contributions for the year ended December 31, 2024.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation which shall increase 1% per year on the first day of the plan year up to a maximum of 10%, unless otherwise elected by the participant. Automatically enrolled participants have their contributions invested in accordance with the default investment alternatives established under the Plan, unless otherwise elected by the participant.

Participant accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited or charged with the participant's contributions, allocations of the Company's discretionary matching and profit-sharing contributions, if any, investment results, and administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. Participants direct the investment of their contributions into various investment options offered by the Plan, which are more fully described in the Plan's literature. Participants may change their investment options daily. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of Plan (Continued)

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary employer matching contribution and profit-sharing contribution portion of their accounts is based on years of continuous service. Vesting is based on years of credited service as set forth in the following table:

Forfeited accounts: Forfeitures are used to fund future employer contributions or offset administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$108 and \$3,074, respectively. Forfeitures of \$57,105 were utilized to fund employer contributions and forfeitures of \$9,710 were utilized for administrative expenses during the year ended December 31, 2024.

Notes receivable from participants: Participants could borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note repayment terms generally could not exceed five years. Only one note per participant could be outstanding at a time. The notes are secured by the balance in the participant's account and bear interest ranging from 5.00% to 8.75% as of December 31, 2024, which is commensurate with local prevailing rates as determined by the Plan Administrator. Outstanding notes receivable are due through January 2028. Principal and interest is paid ratably through biweekly payroll deductions. The Plan was amended effective June 1, 2023, to no longer permit new loans to participants.

Payment of benefits: Upon retirement, termination of service, death or disability, a participant may elect to receive a lump-sum amount equal to the value of their vested balance, as defined in the Plan. Upon termination, a participant with a balance of less than \$1,000 will automatically be paid out by the Plan, participants with a balance between \$1,000 and \$7,000 can still be automatically paid out if their balance is rolled into a qualified individual retirement account. Distributions may be made at the participant's election prior to termination upon attainment of age 59½, military reservist called to active duty, disability, or hardship as defined in the Plan document.

Note 2. Significant Accounting Policies

Basis of presentation: The accompanying financial statements have been prepared on the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Note 2. Significant Accounting Policies (Continued)

Investment valuation and income recognition: The Plan's investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2024 and 2023. Delinquent participant notes are recorded as distributions on the basis of the terms of the Plan agreement.

Notes receivable from participants have been classified as investment assets for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefit payments are recorded when paid.

Administrative expenses: Operating expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment-related expenses are net against net appreciation in fair value of investments.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Effective June 1, 2025, the Plan has changed its third-party administrator from DWC—The 401(k) Experts to Blue Ridge Associates.

In June 2025, the merger of the Plan into the TAK Broadband, LLC 401(k) Plan was approved.

Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the net asset value (NAV) of the daily closing prices as reported by the funds, held by the Plan at year-end.

Collective trust funds: Collective trust funds are valued using the unit value based on the NAV of the underlying pool of securities for each fund. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract (GIC) with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Principal Life. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Principal Life is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract value of the investment contract was \$9,088 and \$9,327 as December 31, 2024 and 2023, respectively.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0.15% or greater than 3%.

As described in Note 2, because the GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) Plan Sponsor events (for example, divestitures or spin-off of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the participants are probable of occurring.

If the Plan Sponsor decides to terminate the Plan's interest in the investment contract, there will be a 12-month delay in the payment. The Plan Sponsor may request immediate payment subject to a 10% surrender fee. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 7. Tax Status

The Plan has adopted a nonstandardized preapproved plan sponsored by DWC—The 401(k) Experts. DWC—The 401(k) Experts has received an opinion letter from the IRS, dated September 6, 2023, as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has no uncertain tax positions that require adjustments to or disclosure in the financial statements. Therefore, no provision or liability for income taxes is included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds or a guaranteed investment contract managed by affiliates of Principal Trust Company and Principal Life Insurance Company, the custodians as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 10. Prohibited Transactions

During 2024, the Plan Sponsor inadvertently failed to deposit approximately \$13,000 of contributions within the required time frame as stated by the DOL's regulations. The Plan Sponsor has deposited lost earnings to correct this failure in 2025 and filed Form 5330 and paid applicable excise tax to the IRS. The correction and excise taxes were made from the Plan Sponsor's assets and not from the assets of the Plan.
