NOTE A - DESCRIPTION OF PLAN

The following description of The Glenridge on Palmer Ranch 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established on April 1, 2004. The Plan is a defined contribution plan covering substantially all employees of The Glenridge on Palmer Ranch, Inc. (The Company) who have completed six months of service and are age twenty-one or older, excluding union employees and nonresident aliens. The Plan is a defined contribution plan under section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 90% of their compensation on a pre-tax or after-tax (Roth) basis, subject to the limits of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes matching contributions equal to 50% of the first 4% of compensation that a participant contributes to the Plan. The Company may also make discretionary non-elective (profit-sharing) contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company did not make any discretionary profit-sharing contributions. Participants direct the investment of their employer matching and discretionary profit-sharing contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account.

Vesting

Participants are immediately vested in their contributions, including actual earnings thereon. Participants are also immediately vested in any corrective qualified nonelective employer contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary profit-sharing contribution portion of their accounts plus earnings thereon is based on the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of one-half of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan administrator based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon death, disability, termination of employment, retirement, or a qualifying withdrawal. Hardship withdrawals from the participants' account balance are permitted by the Plan. A participant may request an in-service withdrawal equal to the vested interest in their account if the participant has attained age 59 ½. Distributions greater than \$1,000 and less than \$5,000 are required to be rolled into an individual retirement account unless the participant elects otherwise. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts

Forfeited amounts from a terminated participant do not become available to the Company until the terminated participant requests a distribution of his or her account. These accounts are used to pay administrative expenses and to reduce employer contributions. Forfeitures in the amount of \$1,750 and \$1,536 were used to pay administrative expenses for the years ended December 31, 2024 and 2023. Forfeitures in the amount of \$0 and \$284 were used to pay employer contributions for the years ended December 31, 2024 and 2023, respectively. The forfeited non-vested accounts totaled \$6,084 and \$825 at December 31, 2024 and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expenses

Included in administrative expenses are amounts paid by participants for processing loans, administrative fees, and investment management fees. To the extent expenses of administering the Plan are not paid by the Plan, the expenses are paid by the Company, and therefore, are not included in the accompanying financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE E - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are investments managed by Charles Schwab Trust Bank, the trustee of the Plan. Ameritas Life Insurance Corporation is the third-party administrator and recordkeeper for the Plan. OneDigital Investment Advisors, LLC (formerly Resource Investment Advisors, LLC) is the investment advisor for the Plan. Fees paid to Charles Schwab Trust Bank, Ameritas Life Insurance Corporation, and OneDigital Investment Advisors, LLC are included in administrative expenses and qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules. Notes receivable from participants and related interest income are also considered party-in-interest transactions, which are exempt from the prohibited transactions rules.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE G - INTERNAL REVENUE SERVICE STATUS

The Plan obtained its latest determination letter as a volume submitter, on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE H - RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

Certain amounts included on the Schedule H Part I and II on the Annual Return/Report of Employee Benefit Plans (Form 5500) have been grouped differently for purposes of presentation in the financial statements.

No reconciliation of net assets available for benefits per the financial statements to the Form 5500, or of the changes in net assets available for benefits per the financial statements to the Form 5500, is required for the years ended December 31, 2024 and 2023.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued. Following the end of the Plan year, the Plan Sponsor initiated a transition to a new recordkeeper and third-party administrator (TPA). This transition is currently underway and is anticipated to improve administrative efficiency, enhance participant services, and lower costs for Plan Participants. Concurrently, the Plan is in the process of merging with the Praxeis 401(k) Retirement Plan. As a result of the merger, future reporting periods are expected to reflect higher levels of plan contributions and total plan assets due to the inclusion of additional Praxeis, LLC 401(k) plan participants. The specific financial impact of these changes has not yet been determined. Any such impact will be reflected in future reporting periods as the transition and merger are finalized.
