Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of MB Healthcare 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

Note 1 - Description of the Plan

The following brief description of the MB Healthcare 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more information and a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan generally covering all full-time employees of Greenwich Woods Rehabilitation, LLC, Hamden Rehabilitation, LLC, and Candlewood Valley Health and Rehab (the Companies) who have completed one-half year of service and are age twenty-one or older. Greenwich Woods Rehabilitation, LLC serves as the sponsor and administrator of the Plan. Empower Trust Company, LLC (Empower) serves as the recordkeeper and custodian of the Plan. Empower Annuity Insurance Company of America (EAICA) serves as custodian of certain Plan assets. Two members of Greenwich Woods Rehabilitation, LLC, serve as trustees to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible participants are entitled to defer, with no plan imposed limits on the amount, a portion of their annual salary into the Plan as a qualified pre-tax contribution, an after-tax contribution, or a combination of the two, up to the maximum annual dollar contribution allowed by ERISA and the Internal Revenue Service of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, into the Plan as a qualified contribution. If a participant is age 50 or over, the allowable contribution was \$30,500 and \$30,000 for the years ended December 31, 2024 and 2023, respectively. The Companies may make a profit-sharing contribution to the plan each year and in such amount, if any, as they may determine. Eligible participants who are employed on the last day of the year are eligible to receive the profit-sharing contribution.

Participant Accounts

Each Participant's account is credited with the participant's contribution and an allocation of (a) the Companies' contribution and (b) plan earnings/losses. Allocations of the Companies' contributions are based on participants' compensation for the year. Plan earnings/losses and administrative expenses are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Direction

The Plan permits participants to direct their investments at their discretion into any combination of the funds maintained by Empower as selected by the custodian of the Plan.

Note 1 - Description of the Plan (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings/losses thereon. Vesting in the Companies' contribution portion of their accounts is based on years of continuous service. Participants vest in employer contributions at 25% after two years of service, and vest an additional 25% after each additional year of service until fully vested after 5 years of credited service.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are limited to two at any given time. The loans are payable in their entirety upon the occurrence of a distributable event and bear interest at a rate of prime plus 1%. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount or annual installments equal to the value of the participant's vested interest in their account. Participants may withdraw any part of their vested account which does not result from discretionary contributions after reaching the age of 65. The Plan allows for participants to receive benefits in cases of hardship.

Forfeitures

Forfeitures balances of terminated participants' non-vested accounts are used to pay plan expenses or reduce employer contributions. \$4,800 and \$36,001 of forfeitures were used to reduce employer contributions or pay plan expenses in 2024 and 2023, respectively. Unapplied, forfeited, non-vested accounts totaled \$939 and \$3,005 at December 31, 2024 and 2023, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Investments

Investments are reported at fair value, except for its guaranteed investment contract which is valued at contract value (Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefit of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Note 2 - Summary of Significant Accounting Policies (Continued)

Investments (continued)

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are classified as notes receivables from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balance and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The quarterly administrative fees for the Plan are paid for by the Plan. The Companies pay the annual audit fee and also provide certain administrative services to the Plan, at no cost to the Plan. These expenses are excluded from the financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 3 - Investment Contract with Insurance Company

The Plan has a guaranteed investment contract through EAICA. EAICA maintains the contributions in its general accounts. The account is credited with earnings/losses on the underlying investments and charged for plan withdrawals and administrative expenses charged by EAICA. Because the guaranteed investment account is fully benefit-responsive and directly held, contract value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment account. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings/losses, less participant withdrawals, and administrative expenses. The guaranteed investment account balance at December 31, 2024 and 2023 was \$1,125,216 and \$1,243,709, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value. There are no reserves against contract value for credit risk or the contract issuer or otherwise.

The contract held by the Plan is a guaranteed investment account. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 1% or more than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC,
2. Premature termination of the contracts,
3. Plan termination or merger,
4. Changes to the Plan's prohibition on competing investment options,
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No known events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 3 - Investment Contract with Insurance Company (Continued)

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines,
2. A breach of material obligation under the contract,
3. A material misrepresentation,
4. A material amendment to the agreements without the consent of the issuer.

Note 4 - Certified Investment Information

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information was certified as accurate and complete by EAICA and Empower Trust Company, LLC, the custodians, as of and for the years ending December 31, 2024 and 2023, and is included in the accompanying financial statements and supplemental schedule at December 31:

Note 5 - Fair Value Measurements

Accounting Standards Codification (ASC) topic 820 establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Note 5 - Fair Value Measurements (Continued)

Level 3: Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The assets or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes to valuation methodologies in 2024 or 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by their Plan are deemed to be actively traded (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 - Party In-Interest Transactions

Transactions between Empower, as custodian and recordkeeper, and the Plan qualify as party-in-interest transactions. In addition, transactions involving notes receivable from participants qualify as party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 - Income Tax Status

The Plan has adopted a Volume Submitter agreement for the DATAIR 401(k) Profit Sharing Plan and Trust. The IRS has determined and informed DATAIR by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the advisory opinion letter, the plan administrator and the plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Note 9 - Reconciliation to Form 5500

While total net assets available for benefits and the total change in net assets available agree between the financial statements and Form 5500 for 2024 and 2023, certain classifications may differ between the financial statements and Form 5500.

Note 10 - Subsequent Events

Management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued, and is not aware of any material subsequent events that would have a negative impact on the financial statements.
