### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Food Sciences Corporation Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### (1) Description of Plan

The following description of the Food Sciences Corporation Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees of Food Sciences Corporation (the Company) who have completed six months of service and attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustee Committee is responsible for oversight of the Plan. The Trustee Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### ***Contributions***

Each year, participants may contribute up to 100% of pretax annual compensation, subject to Internal Revenue Service (IRS) limitations and as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company, at its sole discretion, may match participant contributions. Participants must have completed one year of service and attained age 21 to be eligible for matching contributions. For the year ended December 31, 2024, the Company contributed an amount equal to 50% of the first 4% of base compensation that a participant contributed to the Plan. The 2024 employer matching contribution net of forfeitures was \$87,456. In addition, the Company, at its discretion, may also make a profit sharing contribution on behalf of eligible active participants. No discretionary year end profit sharing contribution was made in 2024. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary profit sharing contribution portion of their account plus earnings thereon is determined as follows:

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms are for a period not to exceed five years unless the loan qualifies for the purchase of a principal residence. The loans are secured by the balance in the participants' accounts and bear interest at rates that range from 4.25% to 9.50%. The interest rates are prevailing interest rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### *Payment of Benefits*

Upon termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive either a lump-sum amount equal to 100% of the value of the participant's account or annual installments over a period of not more than the participant's assumed life expectancy. A life annuity form of payment is also available.

The distribution to which a participant is entitled is the participant's vested account balance, including net realized and unrealized investment gains and losses. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,953 and \$9,994, respectively. These amounts may be used to offset the Plan's administrative expenses or used to reduce employer matching or profit sharing contributions. During the year ended December 31, 2024, forfeitures of \$6 were utilized to offset administrative expenses and forfeitures of \$11,607 were used to reduce employer matching contributions.

### (2) Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at their estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustee Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the plan custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's dividends and capital gain distributions and gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Contributions***

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

#### *Subsequent Events*

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

### (3) Financial Information Certified by a Qualified Institution

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year), including pooled separate accounts at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of pooled separate accounts and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (John Hancock U.S.A.), a qualified institution. The common stock and related net appreciation in fair value of the common stock was not certified.

### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common stock:* Valued at the closing price reported on the active market on which the individual security is traded.

*Pooled separate accounts:* Valued at the net asset value (NAV) of units held by the Plan at year end based on the market value of its underlying investments. Although the pooled separate accounts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market.

#### (5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of pooled separate accounts managed by John Hancock U.S.A. John Hancock U.S.A is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transactions rules of ERISA. Fees paid by the Plan for investment management and other recordkeeping services amounted to \$46,813 for the year ended December 31, 2024.

#### (6) Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

#### (7) Tax Status

The Plan uses a non-standardized pre-approved plan by the FIS Business Systems, LLC (FIS). The IRS has determined and informed FIS by a letter dated June 30, 2020, that the pre-approved plan document is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (8) Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### (9) Nonexempt Transactions

As required by ERISA Section 2510.3-102, the plan sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. During 2024 and 2023, certain employee deferrals and loan repayments were not remitted to the Plan within the timeframe required by the Department of Labor under the plan asset rules. These transactions are considered prohibited transactions, as defined by ERISA. As of December 31, 2024, there are \$600 of delinquent contributions that the Company intends on correcting by remitting the lost earnings during 2025.
