We have performed an audit of the accompanying financial statements of HTI Cybernetics, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024 AND 2023****NOTE 1 – PLAN DESCRIPTION**

The following description of (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan was adopted on July 1, 1984, and is a defined contribution plan of HTI Cybernetics, Inc. (the “Company”). The Plan is subject to applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Eligibility** – Eligible employees who have attained age 18 and completed one month of service may participate in the Plan. Employees become participants in the Plan on the first day of the month following satisfaction of the eligibility requirements.

**Contributions** - The Plan provides for employee salary deferral contributions up to a maximum of 60 percent of the eligible compensation subject to maximum limitations established by the Internal Revenue Code. Salary deferrals consist of pre-tax and Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively made an election to participate in the Plan or election not to participate in the Plan. Automatically enrolled participants have their deferral amount set at five percent of eligible compensation and is invested in a designated fund until changed by the participant.

The Company has adopted a safe-harbor matching contribution program requiring the Company to match 100% of voluntary participant contributions up to 3% of compensation, and to match 50% of the next 2% of compensation to a maximum 4% matching contribution. The Company may make discretionary matching contributions equal to a uniform percentage of each participant’s elective deferral contributions. The exact percentage, if any, is determined by the Company on an annual basis. Each year, the Company may also make discretionary profit-sharing contributions to the Plan. During the plan year ended December 31, 2024, the Company made no discretionary matching or profit-sharing contributions to the Plan. Total contributions to the Plan are subject to certain statutory limitations.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a guaranteed investment contract as investment options.

**Participant Accounts** - Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

**Vesting** - Participants are immediately vested in their elective deferral contributions, plus actual earnings thereon and contributions made by the employer under the safe-harbor provision of the Plan. The vesting in the employer’s discretionary matching contribution or profit-sharing contribution portion of their accounts, plus earnings thereon, is based on years of service. A participant is 100% vested after six years of credited service.

**Forfeitures** - Forfeited contributions are used to pay reasonable administrative expenses of the Plan, with the balance being used to reduce current matching or discretionary contributions from the Company. Forfeiture of \$4,025 were used to reduce employer contributions during the year ended December 31, 2024.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to maximum amount as prescribed in the Plan and in the Internal Revenue Code. The notes are secured by the balance in the participant's account. The loan interest is determined on the day the loan is issued by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits** - Upon termination of service due to death, disability, or retirement, a participant may elect to receive any amount up to the value of his or her individual account balance, payable in a lump sum or in installments. Upon reaching the age of 59½, a participant may elect to take in-service distribution, any amount up to the value of his or her individual participant contributions, prior to separation from employment, payable in a lump sum.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates** - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. See Note 5 for fully benefit-responsive investment contract disclosures.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of the maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for custodial and record keeping services are paid by the Plan. Fees for the administration of notes receivables from participants and distribution costs are charged directly to the participant's account. Total direct expenses paid by the plan for certain record keeping cost and participant-initiated transactions totaled \$35,076.

**Date of Management's Review of Subsequent Events** - Subsequent events were evaluated through October 4, 2025, which is the date the financial statements were available to be issued.

**DECEMBER 31, 2024 AND 2023****NOTE 3 – UNAUDITED INFORMATION CERTIFIED BY THE TRUSTEE**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company has certified the completeness and accuracy of the investment information reflected on (1) the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and (2) the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024. Principal Trust Company has also certified the completeness and accuracy of the investments reflected in Schedule H, line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Plan management determines the Plan's valuation policies. Although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

**Mutual Funds:** The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**Common Collective Trust:** The fair value of the common collective trust is based on net asset value (NAV) of the underlying securities. The NAV of the common collective trust represents the Plan's fair value since this is the amount at which the Plan transacts with the fund. A participant's ownership in the common collective trust is represented in units. Units are issued and redeemed daily at NAV of \$1.00 per unit. Although it is the policy of the trust for management to use its best efforts to maintain a stable NAV of \$1.00 per unit, there is no guarantee the trust will be able to maintain that value.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has a Guaranteed Investment Contract with Principal Life Insurance Company. The contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets of an investment entity attributable to fully benefit-responsive investment contracts because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As required by GAAP, the statements of net assets available for benefits and the statement of changes in net assets available for benefits present the investment contracts on a contract value basis.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The contract is presented on the face of the statements of net assets available for benefits at contract value in arriving at net assets available for benefits. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administration expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract value of the fully benefit-responsive investment contract at December 31, 2024 and 2023 was \$2,231,976 and \$1,911,705, respectively. The funds were administered by Principal Life Insurance Company and invested in a Guaranteed Investment Contract with Principal Life Insurance Company. If all participants were eligible for a distribution of their full accounts from the Plan on the reporting date, the amount payable on demand on the reporting date would be at “contract value”. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

In the event that the full value of the account could not be paid upon demand, such as amounts subject to the Market Value Adjustment, the “fair value” estimates are based upon “demand value” for the contracts. The “demand value” is the amount due to the contract holder under the surrender provisions of the contracts.

Certain events limit the Plan’s ability to transact at contract value with the issuers of the Guaranteed Investment Contracts. Such events may include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan) or (b) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan. Furthermore, certain events would allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events may include: (a) an uncured breach of the Plan’s investment guidelines, (b) a material amendment to the contracts without the issuer’s consent, (c) a violation of a material obligation under the contracts, or (d) a material misrepresentation. The Plan Administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with plan participants or the issuer are probable of occurring.

**NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST**

Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to the trustee, record keeper, investment advisors, and auditor of the plan totaling \$35,076 for the year ended December 31, 2024, which was not covered by revenue sharing. All these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 8 – TAX STATUS**

The Plan is based on the Non-Standardized Pre-Approved Profit Sharing Plan with CODA of Principal Life Insurance Company, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan was designed in accordance with the provisions of the Internal Revenue Code (IRC). The Plan has not filed for its own determination letter from the IRS. Plan management believes the Plan is designed to operate in compliance with the applicable requirements of the IRC and therefore, Plan management believes the Plan is qualified and the related trust was tax-exempt as of the financial statement date.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### NOTE 8 – TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
