***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements***

We have performed an audit of the financial statements of the Austin Fire Systems, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (2024 Financial Statements).

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

#### **Note 1 - Description of Plan -**

The following description of the Austin Fire Systems, LLC 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### Description of Plan

The Plan is a defined contribution plan covering eligible employees of Austin Fire Systems, LLC (the Company). Employees of the Company who have obtained the age of 18 and completed 3 months of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

#### Contributions

Participants may elect to defer a percentage of their annual compensation as defined up to the maximum amount allowed by IRS limitations. Participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company shall make a safe harbor contribution to the Plan of 100% of salary deferrals up to 3% of compensation plus 50% of the next 2% of compensation up to the maximum amount allowed by IRS limitations. The Company contributed \$351,146 in safe harbor contributions for the year ended December 31, 2024. For the years ended December 31, 2024 and 2023, the Company safe harbor contribution was over-funded by \$17,972 and \$12,280, respectively, for a total amount of \$30,252. The total amount of \$30,252 is included in forfeiture credits and will be used to reduce future safe harbor contributions.

In addition, the Company may make a discretionary matching contribution. For the year ended December 31, 2024, no discretionary matching contribution was made.

#### Participant Accounts

Each participant's account is charged or credited with the participant's contribution, the Company's contributions, the Plan's investment earnings or losses, certain plan administration costs not covered by the Company, and forfeitures of terminated participants' nonvested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and safe harbor matching contributions and actual earnings thereon. Vesting in the Company's discretionary contributions is based on a graduated scale beginning at 20% vesting after two years of eligible service and becoming fully vested after six years of eligible service.

## Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purpose of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates. Principal and interest are paid through payroll deductions based upon the prescribed repayment schedule.

## Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the participant's vested interest in his or her account in the form of a lump-sum amount or annual installments based on a predetermined length of time. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

## Forfeited Accounts

Forfeited accounts may be used to pay administrative expenses and reduce future company contributions. During 2024, the Company used \$- of forfeitures to reduce its contributions or pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$76,057 and \$53,001, respectively.

## **Note 2 - Summary of Accounting Policies -**

### Basis of Accounting

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting. As of December 31, 2024 and 2023, all assets of the Plan are participant directed.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. As of December 31, 2024 and 2023, the Plan had no fully benefit-responsive investment contracts.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates, and such differences may be material.

### Investment Valuation and Income Recognition

Investments are reported at fair value which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the Plan's trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net investment income (loss) includes dividends, gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year. Benefits are recorded when paid.

### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

### Risks and Uncertainties

The Plan provides for various investment options in any combination of investments of selected funds held by the trustee. The funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of the funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees for certain transactions, such as withdrawals and loan processing, are charged directly to the account of the participant reporting such a transaction and included in administrative expenses while expenses for items such as recordkeeping are allocated to participants. Fees related to participants with self-directed investments are charged directly to the accounts of these participants.

### Reclassifications

Certain items in the 2023 financial statements may have been reclassified to conform to the presentation in the current year financial statements. Such reclassifications had no effect on the previously reported change in net assets available for benefits.

### Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the date which the financial statements were available to be issued.

### **Note 3 - Plan Termination -**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### **Note 4 - Tax Status -**

The Plan has executed an adoption agreement using the Fidelity Basic Plan Document No. 17 and relies on the opinion letter dated June 30, 2020, issued for the standard plan. The Plan has been amended since receiving the letter. However, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations for years prior to 2021.

### **Note 5 - Fair Value Measurements -**

The fair value measurement accounting literature provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and are based on assumptions market participants would utilize in pricing the asset.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds and Exchange-Traded Funds** - These funds are valued at the quoted closing price in the active market as reported by the funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

**Common Stock** - The fair values of investments in common stock are based on the closing price reported on the active market on which the individual securities are traded.

**Interest Bearing Cash and Non-Interest Bearing Cash** - The fair values of these funds are based on preserving the net asset value of \$1.00 per share based on the underlying assets invested in treasury securities, when applicable.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7 - Related Party and Party-In-Interest Transactions -**

Certain plan investments are managed by Fidelity Management Trust Company. Since this entity is the trustee as defined by the Plan, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Company, a related party, may also directly pay other fees related to the Plan's operations. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 8 - Delinquent Participant Contributions -**

During the year ended December 31, 2023, employee deferrals of \$5,883 were not timely remitted to the Plan in accordance with the requirements of the Department of Labor. The contributions were remitted to the Plan upon discovery of the error. The Company computed lost earnings and filed the required Form 5330 in 2024.
