Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TMI Enterprise, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

1) Description of plan

The following brief description of TMI Enterprise, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for more complete information.

(a) General

The Plan is a 401(k) defined contribution plan adopted January 1, 1996. It covers all eligible employees of TMI Enterprise, LLC; L&B Transport, LLC; Transporter Maintenance and Inspection, LLC; Trailer Management International, LLC; TMI Security, LLC; Krawdaddy’s LA, LLC; Grand Paradise, LLC; Lucky Louie’s Truck Stop, LLC; Super Lucky Louie’s, LLC; Monicarlo Casino, LLC; Trans Matic, Inc; and Breaux Bridge Gaming, LLC; (the Company or Employer) who are at least 21 years of age and have one year of service as defined in the Plan articles, provided that they have worked at least 1,000 hours during the Plan year. The Plan excludes employees covered by collective bargaining agreements and non-resident aliens. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Participants may contribute an amount equal to a percentage of their compensation earned during the Plan year not to exceed the limits imposed by the Internal Revenue Code. Employees are 100% vested in their contributions. In 2024 and 2023, matching contributions are made by the Company equal to 100% of the elective deferral contributions of each employee, disregarding any elective deferral contribution in excess of 4% of the employee’s compensation. The Company may also elect to make a discretionary contribution, however, there were no discretionary contributions for 2024 or 2023.

(c) Participant accounts

Each participant's account is credited with the participant's contribution and allocation of the Company contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Investment options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions in a variety of investment options. Participants may change their investment allocations any time via telephone, internet or written instructions.

(e) Payment of benefits

Upon termination of service, death, disability, or retirement, a participant will receive either a lump-sum amount or installments, equal to the value of the vested interest in his or her account. Under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. Balances under \$1,000 may be paid out at the discretion of the Company.

(f) Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as follows:

(g) Forfeitures

Forfeitures of Employer matching contributions are used to reduce Employer contributions in the following year. There were \$4,111 and \$3,373 in forfeitures available at December 31, 2024 and 2023, respectively, to offset future Employer contributions. Employer contributions were reduced by \$3,432 and \$769 from forfeited non-vested accounts for December 31, 2024 and 2023, respectively.

2) Summary of accounting policies

(a) Basis of accounting

The accompanying financial statements have been prepared on an accrual basis of accounting.

(b) Investment valuation and income recognition

The Plan's investments are stated at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 10 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid. There were no amounts allocated to accounts of participants who have elected to withdraw from the plan but not yet paid as of December 31, 2024 and 2023.

(d) Estimates

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Guaranteed investment contract

Contributions under a group annuity contract can be allocated to guaranteed interest accounts, which are not, by definition, an investment contract, but rather are an investment option offered under the Lincoln National Life Insurance Company contract. The group annuity contract is a non-fully benefit-responsive investment contract. The guaranteed investment accounts guarantee the return of principal plus compound interest earned over a defined term, less any applicable contract or participant-level recordkeeping charges, provided all contributions remain in the account until the end of the guaranteed period.

Interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed account in that month. For each reporting year in which a participant makes a contribution to a guaranteed account, a new account is established at the end of the contract year which applies for the remainder of the guaranteed term for that account. Inter-account transfers from guaranteed interest accounts may be subject to a market value adjustment, depending on the withdrawal amount and the reason for the withdrawal. A contract charge may be applied at contract termination, per the contract specifications. The investment in the contract is included in the financial statements at contract value which approximates fair value as reported to the Plan by Lincoln National Life Insurance Company.

During the years ended December 31, 2024 and 2023, the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated in value by \$736,992 and \$711,488, respectively.

4) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

5) Plan administrative costs

The Plan allows certain administrative expenses to be paid from Plan assets, unless otherwise paid by the Company. Administrative expenses recorded in the Plan represent custodian fees, audit fees, and other record keeping fees that are deducted from participant's accounts and paid directly to the trustee. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net investment appreciation (depreciation) from investments, as they are paid through revenue sharing, rather than a direct payment. Distribution fees are charged directly to the participant's account. These fees qualify as party-in-interest transactions.

6) Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7) Federal income tax status

The Plan adopted a prototype plan document. The prototype plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the letter, including amendments made to comply with recent law changes. The Plan itself has not separately applied for a determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

United States generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the Internal Revenue Service and Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to United States federal and state income tax examinations by tax authorities for a period of three years beyond the filing of those returns.

8) Related party transactions

Certain plan investments are held in pooled separate accounts offered and managed by Lincoln National Life Insurance Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9) Information prepared and certified by the trustee

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 and 2023, was obtained by the plan administrator and agreed to or derived from information certified as complete and accurate by Lincoln National Life Insurance Company, a qualified institution.

10) Fair value measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Guaranteed investment contract: Valued at fair value which approximates contract value.

Pooled separate accounts: Valued at net asset value (NAV), which is fair market value, as the assets are marked-to-market on a daily basis.

10) Fair value measurement (continued)

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

11) Investment contract with insurance company

The Plan invests in a group annuity contract with Lincoln National Life Insurance Company, which is a non-benefit responsive investment contract. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is non-benefit responsive, fair value is a relative measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contracts at December 31, 2024 and 2023 was \$63,207 and \$52,165, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

12) Compensation definition and contribution error

For the plan year ended December 31, 2024, the Plan failed to include performance bonuses in eligible compensation for one payroll period at one of the eleven entities participating in the Plan. Management evaluated this matter and determined that certain employee contributions were understated for the affected payroll. Subsequent to year-end and as of the date of the auditor's report, in accordance with the Department of Labor's Voluntary Fiduciary Correction Program (VFCP) and/or the Internal Revenue Service's Employee Plans Compliance Resolution System (EPCRS), as applicable, the Plan sponsor has deposited corrective contributions and lost earnings in the amount of \$599.

13) Prohibited transactions

Participant contributions of \$387 were withheld from participants' pay during 2023, but were not remitted to the Plan's trust within the time frame required by the Department of Labor under the Plan asset rules. As of the date of the auditor's report, the lost earnings for these contributions have been remitted to the Plan.

Participant contributions of \$8,607 were withheld from participants' pay during 2022, but were not remitted to the Plan's trust within the time frame required by the Department of Labor under the Plan asset rules. As of the date of the auditor's report, the lost earnings for these contributions have been remitted to the Plan.

14) SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. While most of the significant provisions became effective in 2024 and thereafter, there was no material impact to the Plan's financial statements in 2024 or 2023.

15) Subsequent events

The Plan has evaluated subsequent events through the date of the independent auditor's report, the date which the financial statements were available to be issued. There were no other material subsequent events that required recognition or additional disclosures in these financial statements.
