**Note A - Description of Plan**

The following description of the Goldsboro Milling Company (Company) 401(k) Profit Sharing Plan & Trust (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering employees of the Company and its affiliates who have six consecutive months of service. Union employees and certain non-resident aliens are excluded from participating in the Plan. Certain employees who become employees due to an asset or stock acquisition, merger, or similar transaction involving a change in the employer are also excluded from participating in the Plan. The Plan is subject to the provisions of ERISA. The Retirement Committee is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.
2. *Contributions.* Each year, participants may contribute up to 92% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution Plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may elect to make a safe harbor contribution equal to 100% of a participant's deferral contributions that do not exceed 3% of the participant's compensation and 50% of a participant's contributions from 4% to 5% of the participant's compensation. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. A participant is not eligible to share in the allocation of the Company's discretionary profit-sharing contribution unless he is an employee of the Company on the last day of the Plan year.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan provides for automatic increases in the amounts withheld by automatically enrolled participants. In the absence of contrary elections made by the affected participants, the deferral rates of automatically enrolled participants will be increased by 1% up to a maximum of 6% of eligible compensation per year.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

3. *Participant Accounts.* Each participant's account is credited with the participant's contributions and Company safe harbor contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific

participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. *Vesting.* Participants are vested immediately in their contributions and the Company's safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts is based on continuous years of service. A participant is 100% vested after six years of credited service.
5. *Payment of Benefits.* On termination of service, a participant with a vested balance greater than \$5,000 may elect to receive the value of the vested interest in his or her account, or the participant may have his or her account balance remain in the Plan, unless certain minimum distributions are required. For benefits less than \$5,000, a lump-sum payment will be made to the participant. In-service withdrawals are allowed by participants who have reached the age of 59 ½.
6. *Forfeited Accounts.* As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$10,294, respectively. These accounts may be used to pay Plan expenses or reduce employer contributions, or they may be allocated to participants. In 2024, the Company used \$695 of forfeitures to pay Plan expenses and \$10,294 to reduce employer safe harbor contributions. In 2023, the Company used \$23,192 of forfeitures to pay Plan expenses and \$17 to reduce employer safe harbor contributions.

## **Note B - Summary of Significant Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net

appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the safe harbor contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**Note C – Certified Investments**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company, a qualified institution. **Note D – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Account:* Valued at the net asset value ("NAV") of units of a group annuity contract. The NAV, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment assets held through sub-accounts of a separate account of an insurance company, less its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participants may deposit and withdraw on a daily basis. Participants may also transfer to other investment options in the

Plan. However, transfer restrictions may exist if a Plan offers competing funds. If the Plan were to initiate a full redemption of the account, a market value adjustment may be assessed against the Plan's balance in the account unless the Plan were to provide 12 months advance written notice of termination to the contract issuer. Aggregate participant withdrawal requests resulting from an employer-initiated event may be subject to an annual limit based on the Plan's contract balance at the beginning of the year. If these withdrawals exceed the Plan's designated percentage in any given year, the withdrawals will be paid. However, the excess over the annual limit may be subject to a market value adjustment. There are currently no unfunded commitments on these investments.

**Note F – Related-Party Transactions and Party in Interest Transactions**

Certain Plan investments are shares of mutual funds held by Mid Atlantic Trust Company, which serves as the nondiscretionary trustee of the Plan. Paychex is the third party recordkeeper for the Plan and CAPTRUST is the investment advisor to the Plan. Therefore, these transactions qualify as party in interest transactions.

The Plan or Plan Sponsor may make a payment to the trustee, recordkeeper, and investment advisor for administrative expenses. As described in Note B, the Plan made direct payments for recordkeeping and investment advisory services totaling \$122,634 and \$115,912 during 2024 and 2023, respectively. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**Note G – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note H - Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated August 31, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note I – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of the net assets available for benefits.
