Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of HAHL Companies 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HAHL Companies 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements of information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTE 1. DESCRIPTION OF PLAN

The following description of the HAHL Companies 401(k) Plan (formerly Dem-Con Companies 401(k) Plan) (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan. HAHL Companies, LLC (formerly Dem-Con Companies, LLC) (the Company) is the administrator and sponsor of the Plan. The Plan was established on January 1, 2012 and uses Principal Trust Company as the Plan custodian. Effective January 1, 2024, the Plan sponsor, Dem-Con Companies LLC completed an organizational restructuring whereby a new holding company, HAHL Companies, LLC was established as the parent company and became the Plan sponsor. The Plan was most recently restated January 1, 2024. The participants are responsible for the direction of their account balances into specific investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan amendments and restatements:

Effective January 1, 2024, the Plan was amended and restated to change the Plan name to HAHL Companies 401(k) Plan and decrease the eligibility service requirement from one year to three months of service. The Plan also replaced the Company's traditional safe harbor contribution with a Qualified Automatic Contribution Arrangement (QACA) safe harbor contribution. The Company provides a QACA safe harbor matching contribution to eligible participants of 100% of deferrals up to 3% of their compensation, plus 50% of deferrals up to the next 2% of their compensation, up to 4% of their compensation as defined in the Plan. Effective January 1, 2024 newly enrolled participant's QACA safe harbor contributions are fully vested after two years. Employees participating in the Plan prior to January 1, 2024 are 100% vested in all safe harbor contributions. The Plan restatement also increased the automatic deferral percentage from 5% percent to 6% for all newly eligible participants.

Eligibility:

Employees of the Company who are not Members of International Union of Operating Engineers Local No. 49, who are not non-resident aliens, who have attained the age of 18 years or older, and who have performed three months of service (prior to January 1, 2024, one year of service) are considered eligible to participate in the Plan. For the discretionary profit-sharing contributions, employees must also complete 500 hours during the Plan year and be employed at the Plan year end to remain eligible. Employees of the Company who are Members of Teamsters Local Union No. 120 are excluded for purposes of discretionary profit-sharing contributions only. For the Plan entry dates are the first day of each plan quarter, coincident with or next following the date in which the eligibility requirements are met.

NOTE 1. (CONTINUED)

Contributions:

Each year, participants may elect to contribute to the Plan up to 100% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan contains an automatic enrollment feature for employees where pre-tax deferrals of 6% (5% prior to January 1, 2024) of eligible compensation will be made. The Plan is a QACA employer safe harbor plan where the Company provides matching contributions to eligible participants of 100% of deferrals up to 3% of their compensation, plus 50% of deferrals over 3%, up to 5% of their compensation as defined in the Plan. Prior to January 1, 2024, the Company provided matching contributions to eligible participants of 100% of deferrals up to 3% of their compensation, plus 50% of deferrals over 3%, up to 5% of their compensation as defined in the Plan. The Plan also provides for discretionary profit-sharing contributions. For the Plan years ended December 31, 2024 and 2023, the Company did not make any discretionary profit-sharing contributions. Contributions are subject to certain IRS limitations.

Participant accounts:

Each participant's account is credited with participant pre-tax deferrals, employee post-tax Roth contributions, employee rollover contributions, employer safe-harbor matching contributions, and employer discretionary profit-sharing contributions, an allocation of Plan forfeitures and Plan earnings. Allocations of the Company discretionary contributions are based on participant compensation, as defined in the Plan. Participant accounts are valued at the end of each business day. The benefit the participant is entitled to is the benefit that can be provided from the participant's vested account.

Vesting:

Participants who were eligible to participate in the Plan as of January 1, 2024 are vested immediately in their contributions and safe harbor matching contributions plus actual earnings thereon. Employees who did not become eligible until after January 1, 2024 are subject to a 2-year cliff vesting schedule for QACA safe harbor matching contributions. Vesting in the employer discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested in employer discretionary profit-sharing contributions after completing four years of service.

Forfeited accounts:

There were no unallocated forfeiture balances at December 31, 2024 and 2023. Forfeitures of non-vested account balances are used to restore forfeitures, to reduce Company contributions, or to pay plan administrative expenses. During the years ended December 31, 2024 and 2023, forfeitures of \$16,221 and \$7,482 were used to reduce employer contributions, respectively.

NOTE 1. (CONTINUED)

Payment of benefits:

Distributions to terminated or retired participants are made in a single lump-sum payment to the participant (or in the case of death, the participant's beneficiary), or periodic installments over a period specified by the Plan. If terminated/retired participants do not voluntarily elect to receive a distribution, vested account balances between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) are rolled into an IRA on the employee's behalf. If a participant terminates employment and the participant's vested account balance does not exceed \$1,000, the plan administrator can authorize the benefit payment without the participant's consent.

Active participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan and withdrawals are limited pursuant to the Plan's provisions.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are maintained on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for the discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits:

Benefits are recorded when paid.

NOTE 2. (CONTINUED)

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in the administrative expenses. Certain investment advisory expenses are charged directly to the participant accounts while other investment-related expenses are included in the net appreciation of investments.

Subsequent events:

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3. CERTIFICATION OF INVESTMENT INFORMATION

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Principal Trust Company, the custodian of the Plan, has certified as to the completeness and accuracy of all investment information reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ending December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets and liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4. (CONTINUED)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Mutual Funds held by the Plan are deemed to be actively traded.

Collective trust funds: The collective trust fund investments are valued at NAV per share, which is a practical expedient used to estimate the fair value of each respective fund. The investments underlying the collective trust fund include other publicly traded investment funds and are valued at the respective fund's NAV. The collective trust fund does not have a finite life, unfunded commitments, or significant restrictions on redemptions. Accordingly, these investments have been excluded from the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company, the custodian for the Plan and, therefore, these transactions qualify as party in interest transactions. The Company pays fees to SuperiorUSA Corporation and TSC, Inc. for administrative services. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020 received from the Internal Revenue Service (IRS) on TSC, Inc. Non-Standardized Pre-Approved Profit Sharing Plan with CODA indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under the current income tax law. The Plan has been amended since receiving the advisory letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9. SECURE ACT 2.0

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and administratively adopted an increase to the mandatory distribution limit for terminated participants (see Note 1, Payments of benefits sub note). Plan management will determine other optional provisions to elect in the future.
