Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Pegasystems Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. Notes to Financial Statements

Note 1 - Description of the Plan

The following brief description of the Pegasystems Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan covering substantially all employees of Pegasystems, Inc. (the “Employer”). The Plan covers all employees of Pegasystems, Inc., OpenSpan, Inc., and Pega Government LLC (collectively referred to as the “Employer”), who are age 18 or older except for non-resident aliens, employees covered by a collective bargaining agreement, leased employees, and interns. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant directed.

Participant Contributions

Participants may defer from 2% to 75% of their annual compensation, as defined by the Plan, subject to a dollar limit set by Federal law. Participants may also contribute up to 100% of their annual compensation as Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Rollovers”).

Employer Contributions

Matching Contributions

Each year, at the discretion of the Employer’s Board of Directors, the Employer matching contribution is determined, subject to certain limitations. The Employer matching contribution is made on a quarterly basis. In order to be eligible for a matching contribution made each quarter, an employee must be employed on the last day of the Plan quarter, unless separated due to death, disability or reaching normal retirement age.

For the Plan years ended December 31, 2024 and 2023, the Board voted the Employer matching contributions to be 50% of the first 6% of eligible compensation deferred by each participant amounting to \$7,937,333 net of forfeitures used of \$438,479 for the 2024 Plan year and \$8,198,212, net of forfeitures used of \$507,423 for the 2023 Plan year.

Profit Sharing Contributions

Each year, the Employer may make a profit sharing contribution to the Plan, subject to certain limitations. Participants must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to be eligible for the profit sharing contribution. Allocations are made to eligible participants based on their eligible compensation to total eligible compensation. For the Plan years ended December 31, 2024 and 2023, no profit sharing contributions were made.

Notes to Financial Statements

Note 1 - Description of the Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's match and profit sharing contributions, if any, and earnings/losses and reduced with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always fully vested in their deferral and rollover contributions plus earnings thereon. Vesting in the Employer's contributions to the participants' accounts, if any, is based on years of continuous service. A year is defined as 1,000 hours of service within a calendar year. A participant is fully vested in the Employer's contributions after four years of credited service, vesting at 25% per year.

The Plan also maintains frozen participant accounts in regards to the accounts merged into the Plan from the Chordiant Software 401(k) Profit Sharing Plan ("Chordiant"). Participants are fully vested in their frozen Chordiant employee contribution account and frozen Chordiant qualified non-elective account, plus actual earnings thereon. A participant became fully vested in their frozen Chordiant prior Employer matching contribution account after three years of credited service.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$406,135 and \$178,692, respectively. These amounts can be used to reduce Employer contributions or Plan administrative expenses. During 2024, a total of \$365,411 of forfeitures was used to reduce Employer matching contributions, of which \$267,722 and \$97,689 was used for the 2024 and 2023 Plan years, respectively. Also, during 2024 and 2023, \$25,822 and \$24,990, respectively, of the forfeiture balance was used to pay certain Plan expenses. Subsequent to year end, an additional \$170,757 of the forfeiture balance was used to reduce a portion of the 2024 Employer matching contribution funded in 2025.

Payment of Benefits

The Plan allows for in-service withdrawals from all participants' vested accounts once a participant has reached age 59½. Hardship withdrawals (minimum amount of \$1,000) are permitted from a participant's deferral contribution account only. A participant is entitled to an in-service withdrawal of their after tax or rollover account at any time. Participants are entitled to their vested account upon death, disability, retirement or termination of employment. A participant can only receive a lump-sum amount or installment payments equal to the vested value of his or her accounts. Upon termination, if a participant's vested account is less than \$7,000, the Plan administrator, after notification, may distribute the entire non-forfeited account balance to the participant. Hardship withdrawals may be taken from any account without respect to earnings.

Note 1 - Description of the Plan (Continued)

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balances, whichever is less. Participants are allowed one loan outstanding at a time. The loans are secured by the balances in the participants' accounts and bear interest at rates that range from 4.25% to 9.50% at December 31, 2024 and 2023, which are commensurate with local prevailing rates as determined by the Plan administrator. Loan terms may range from 1 to 5 years or up to 15 years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

Administrative and Management Expenses

Administrative expenses of the Plan are paid by either the Plan or the Employer, as provided in the Plan document. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Unit Values

Individual participant accounts for the pooled separate investment accounts and common/collective trust funds are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units which are valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Note 2 - Summary of Significant Accounting Policies (Continued)

Contributions

Contributions from Plan participants and the discretionary Employer matching contributions are recorded in the year in which the contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date that the financial statements were available to be issued. No significant matters for disclosure were identified during the evaluation.

Note 3 - Information Certified by Trustee and Custodian

Plan investments are held by the Plan's trustee and custodian, Empower Trust Company, LLC ("Empower"). Empower has certified to the completeness and accuracy of the fair value of all the investments and notes receivable from participant transactions as of and for the years ended December 31, 2024 and 2023. Investment transactions include interest and dividends and net appreciation in fair values of investments. Information included in the supplemental Schedule of Assets (Held at End of Year) has also been certified as complete and accurate by Empower.

The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on a participant's risk tolerance. Participants may direct contributions to any of the investment options that consist of shares of mutual funds, pooled separate investment accounts, a stable value fund and a common/collective trust sponsored by Empower.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units in a Stable Value Common/Collective Trust

Valued at the NAV of units of a collective trust. The NAV, as provided by the trustees and custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The investment's objective is the stability of principal and high current income. To achieve its investment objective, the common/collective trusts invest in high-quality guaranteed investment contracts and synthetic investment contracts which underlying assets consist of security-backed investment contracts, synthetic separate account guaranteed investment contracts (includes fixed income investments) and short-term investments. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Fair Value Measurements (Continued)

Pooled Separate Investment Accounts

Units of participation in pooled separate investment accounts are reported at the daily Net Asset Value (“NAV”) of units owned. The NAV, as provided by Empower, is used as a practical expedient to estimate fair value. Participant transactions may occur daily. NAV of units is based upon the quoted market values of the underlying assets in the separate accounts less its liabilities. Individual participant accounts for the pooled separate investment accounts are maintained on a unit value basis. These units are not traded on securities exchanges but are redeemable only by the issuer. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Related-Party Transactions and Exempt Party-In-Interest Transactions

Plan investments are held by Empower, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid from the Plan to Empower and other service providers for the years ended December 31, 2024 and 2023 amounted to \$431,371 and \$435,008, respectively. Notes receivable from participants also qualify as party-in-interest transactions. The Plan also received revenue credits (which can be used to pay Plan expenses) from Empower totaling \$297,123 and \$272,616 for 2024 and 2023, respectively.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

Note 9 - Tax Status

The Plan has adopted the Empower Non-Standardized Prototype Defined Contribution Plan which received a favorable opinion letter on June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that, therefore, the Plan continues to qualify under Section 401(a) and the related trust continues to be tax-exempt. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
