**Note 1. Description of the Plan**

The following description of The Bionetics Corporation 401(k) Savings Plan (the "Plan") provides only general information. Reference should be made to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan available to substantially all employees of The Bionetics Corporation (the "Company"), who are not participating in a collective bargaining agreement. All employees, except those hired as part-time, temporary and seasonal employees, are immediately eligible and subject to automatic enrollment at a 3% deferral rate unless they positively elect not to participate. Part-time, temporary, and seasonal employees who work less than 1,000 hours in a Plan year are also excluded from participation in the Plan. Part-time, temporary, and seasonal employees who work more than 1,000 hours within their first twelve months of service or within a subsequent Plan year may participate immediately after these determination periods transpire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and was established January 1, 1987.

***Administration***

The Company is the Plan sponsor and Plan administrator. Certain administrative functions are performed by employees of the Company. These employees do not receive compensation from the Plan. The Benefits Committee outsourced the recordkeeping function of the Plan to Transamerica Retirement Solutions, LLC. State Street Bank and Trust Company (the "Trustee") holds the assets of the Plan.

***Contributions***

Participants may make pre-tax contributions to the Plan in any percent of their base wages to the Plan, up to the maximum permitted by law subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also transfer amounts representing distributions from other qualified plans. The Plan has an automatic contribution arrangement where an initial 3% will be required, and annually, an increase of 1% will occur, up to a maximum of 9%. Participants direct their investment of their contributions into the various investment options offered by the Plan. The Company makes employer matching contributions at a rate of 50% of the first 2% of the Participant's compensation contributed, and 30% of the next 7% of the Participant's compensation contributed. The Company may also make discretionary non-elective contributions as determined by the Company in a nondiscriminatory manner. No such contributions were made for 2024. Company contributions are invested as directed by the participants. Contributions are subject to certain limitations.

***Participant Accounts***

Participant accounts are adjusted daily for contributions, withdrawals, interest, dividends, and adjustments to reflect changes in the market value of investments. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings are allocated to individual participant accounts based on end of day account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions and actual earnings thereon. Employer matching contributions, employer discretionary non-elective contributions, and earnings thereon are fully vested after one year of service.

***Forfeitures***

The portion of a participant's account attributable to employer contributions which is forfeited by a participant as a result of termination of participation in the Plan will be used to reduce the Company's contributions or the Plan's administrative expenses. Forfeited amounts available as of December 31, 2024 and 2023 were \$14,361 and \$3,573, respectively. For the year ended December 31, 2024, \$3,788 of forfeited accounts were used to reduce employer contributions.

***Expense Budget Account***

An Expense Budget Account was established within the Plan to account for funds received under a revenue-sharing agreement with the Trustee. This account will be used to reduce Plan expenses. Any unused amounts may be allocated to participant accounts or retained in the account for future use. At December 31, 2024 and 2023, the account totaled \$125,363 and \$102,444, respectively. During 2024, the Plan received \$92,861 in revenue sharing payments which were deposited into this account. Revenue sharing payments are reported as "other investment income" in the statement of changes in net assets available for benefits. During 2024, the Plan used \$73,936 from this account to pay Plan expenses.

***Notes Receivable from Participants***

Each participant may borrow from their fund accounts between \$1,000 and the lesser of \$50,000 or 50% of their vested account balance. Loan terms may range from one to five years or may exceed five years for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at a fixed rate established on the date of the loan at prime plus 1% (4.25% to 9.50% at December 31, 2024). Principal and interest are paid ratably through monthly loan payments.

***Payment of Benefits***

On termination of service due to retirement, other termination of employment, death, or permanent disability, the participant or beneficiary is entitled to receive the vested interest in his or her account in a lump sum payment, partial payments, or annuity payments. Participants that have reached age 70½ may be required to take certain minimum distributions, which are paid in annual installments, and which shall not extend beyond the participant's life expectancy. Participants may also withdraw all or any part of their vested account balance after having attained age 55 and five years of service for early retirement distributions, attained age 59½ for in-service distributions, incurred a disability, or incurred a safe harbor hardship in accordance with the Plan provisions.

***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan offers mutual funds and an investment contract with insurance company (guaranteed interest account) as investment options for participants. The interest-bearing cash fund is used for unallocated accounts.

**Note 2. Summary of significant accounting policies**

***Basis of Presentation***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for the investment contract with insurance company, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

The Plan invests in investment contracts through a guaranteed interest account. Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments according to the agreed-upon repayment schedule, and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

***Payment of Benefits***

Benefits paid to participants are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Expenses relating to specific participant transactions (notes receivable and distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds**

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Interest-Bearing Cash**

This investment is valued by the Trustee, and it is not traded publicly. Because the investment is cash, the input is still considered observable, and a Level 1 classification is appropriate.

The Plan's financial instruments carried at fair value are classified by the following fair value hierarchy levels as of December 31:

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Certification of Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 5. Investment Contract with Insurance Company**

The Plan is invested in the New York Life Guaranteed Interest Account ("GIA"), which consists of a guaranteed investment contract issued by New York Life Insurance Company ("NYL"). Contributions to the GIA are held in the NYL general account.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The account is included in the financial statements at contract value as reported to the Plan by NYL.

Because the GIA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by NYL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a bi-annual basis for resetting, but will typically fall within a range of 1.00% and 3.00%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-off of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

## **Note 6. Exempt Party-in-Interest Transactions**

Certain Plan investments are managed by Transamerica Retirement Solutions, LLC and State Street Bank and Trust Company. Transamerica Retirement Solutions, LLC is the third-party administrator of the Plan and State Street Bank and Trust Company is the Trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to these service providers totaled \$81,808 for the year ended December 31, 2024.

## **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in accordance with the provisions of the Plan.

## **Note 8. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the non-standardized pre-approved plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020 that the non-standardized pre-approved plan document was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the

applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Non-Exempt Party-In-Interest Transactions**

During the year ended December 31, 2023, the Company inadvertently failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) from its assets within the required time period as specified by the Department of Labor. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Company made the deposit after the required time frame, and has deposited, or will deposit, additional amounts to the affected participants' accounts to compensate those participants for potential lost income due to the delay.

**Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
