## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Continental Refining Company 401(k) Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Continental Refining Company 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. The Plan was formed on January 1, 2014, and restated January 1, 2022.

*General* – The Plan is a defined contribution 401(k) plan and cover most full-time employees of Continental Refining Company, LLC (the “Company”) who have completed one year of service (1,000 hours) and are 18 years of age or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is a single employer plan with additional participating employers as part of a controlled group as follows: Hemisphere Limited, LLC, Warner Fertilizer Company, Inc., Midland Farms, Inc., Plaza 23 Leasing Corp, 1038 Champlain Leasing Corp, 1038 Champlain QSR, Inc., 954 South Highway 27 Leasing, LLC, 1990 Somerset KY, LLC, Liquor Emporium, LLC, 1830 Somerset KY, LLC, and 3002 Somerset KY, LLC. The Midland Farms, Inc. portion of the Northeast Dairy Foods Association, Inc. 401(k) Plan was merged into this surviving plan as of January 1, 2022.

*Contributions* – Subject to applicable limitations, each year, participants may contribute up to 100% of pretax annual compensation before certain fringe benefits, as defined in the Plan. Entry dates are quarterly coinciding with or next following satisfaction of the minimum age and service requirements. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual fund accounts for participants. Additional amounts may be contributed by the Company at the option of the board of directors.

*Safe Harbor Contributions* – The Company provides a safe harbor match contribution equivalent to 100% of employee elective deferrals up to a maximum of 3% and 50% of elective deferrals up to 5% for a maximum of 4% for each participant meeting eligibility requirements for employee contributions.

*Employer Non-Elective Contributions* – The Company may offer an additional employer matching contribution for employees meeting aforementioned eligibility requirements at the employer’s discretion. There was no additional employer contribution for the years ended December 31, 2024 and 2023.

*Participant Accounts* – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Accounts are adjusted daily for any change in the fair values of the account’s investments. The participants may transfer existing assets between investment options.

*Vesting* – Participants are immediately 100% vested in their qualifying elective deferrals, employee contributions, safe harbor contributions, and rollover contributions. Additional employer matching contributions are subject to a vesting schedule as follows: Years of service less than one year vested 0%; One year vested 20%; Two years vested 40%; Three years vested 60%; Four years vested 80%; Five years vested 100%.

NOTE 1 – DESCRIPTION OF PLAN - continued

*Payment of Benefits* – On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

*Participant Investment Rollovers* – Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

*Forfeitures* – The Company may decide at its discretion how to treat forfeitures under the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19 and \$0, respectively. During 2024 and 2023, \$0 and \$2,041 of forfeitures was used to pay plan expenses, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participants' contributions are recorded by the Plan as of the date such participants' elected contributions are withheld by the Company. Sponsor contributions are recorded by the Plan when committed by the Sponsor.

Payment of Benefits

Benefits are recorded when paid.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - continued

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for administration are included in administrative expenses and charged directly to the participant's account.

Date of Management's Review

Subsequent events were evaluated through September 8, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – UNAUDITED INFORMATION CERTIFIED BY CUSTODIAN

Substantially all information pertaining to the Plan's investments included in the financial statements, including the associated investment income (loss), was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American Trust Company, the custodian of the Plan. This information has not been audited by independent accountants.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 – FAIR VALUE MEASUREMENTS - continued

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at NAV of shares held by the Plan at year end based on quoted market price (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the bank or investment company. The NAV, as adjusted, approximates fair market value. The investments are redeemable at the adjusted NAV under agreements with the bank or investment company. Due to the nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of the collective trust funds, and consequently, the fair value of the Plan's investments.

NOTE 5 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain administrative expenses, indirect fees, and costs of the Plan are paid to American Trust Company, the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

As of December 31, 2024 and 2023, the Plan has a fully benefit-responsive investment contract with Metropolitan Life Insurance Company (MLIC). MLIC maintains the contributions in a stable value fund. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by MLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$437,515 and \$313,748, respectively. The crediting interest rate was 2.10% and 1.95% as of December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with MLIC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 7 – INCOME TAX STATUS OF THE PLAN

The Plan uses a prototype plan document sponsored by AT Retirement Services, LLC. AT Retirement Services, LLC received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan has analyzed its tax positions taken and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations generally for three years after filing.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan provides for various participant-directed investment options, which are exposed to various risks, such as interest rate, credit risks and market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.
