Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Elwyn California Defined Contribution 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Auditor's Responsibilities for the Audit

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Notes to Financial Statements

1. Description of Plan

The following description of the Elwyn California Defined Contribution 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established on January 1, 2009 and covers all eligible employees of Elwyn California (the Organization). American United Life Insurance Company (AUL) provides recordkeeping services for the Plan and also serves as custodian of the Plan's investments. The Organization, as Plan administrator, is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan document, immediately upon being hired by the Organization. The Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollover) from other qualified defined benefit or defined contribution plans.

The Organization contributes an employer nonelective contribution equal to 3% of eligible participants' compensation. A participant must complete 1,000 hours and remain employed on the last day of the Plan year to be eligible for the employer nonelective contribution. The employer nonelective contribution is made once a year and is recorded as an employer contribution receivable in the accompanying statements of net assets available for benefits.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's contribution and (b) plan earnings or losses and is charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the vested portion of their accounts.

Vesting

Participants are vested immediately in their individual deferral, rollover contributions and the allocated earnings thereon. Vesting in the Organization contribution portion of their accounts, plus earnings thereon, is based on years of continuous service. A participant is 100% vested after three years of credited service.

Notes to Financial Statements

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment period may not exceed five years, unless it is for the purchase of a principal residence which increases the period to 30 years, and participants may not have more than one loan outstanding at a time. The loans are secured by the balance in the participant's account. The interest rate for notes receivable from participants is the prime interest rate plus one percent and will be determined on a quarterly basis by the Plan administrator. Principal and interest are primarily paid ratably through payroll deductions. Participants have the option of making principal and interest payments directly to the Plan outside of payroll.

Payment of Benefits

Upon separation of service due to death, disability, retirement or other reasons, a participant may elect to receive a distribution equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installment payments. In-service withdrawals are allowed from a participant's accounts in which they are 100% vested upon attainment of age 59 ½. The involuntary small balance cash-out limit is \$5,000 for participants who terminate employment with the Organization.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$187,497 and \$84,125, respectively. These accounts will be used to reduce future employer contributions or pay reasonable Plan expenses. During the year ended December 31, 2024, \$84,125 was utilized to reduce the 2023 employer nonelective contribution, which was funded in September 2024. The forfeiture balance as of December 31, 2024 was utilized to reduce the 2024 employer nonelective contribution funded in October 2025.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive (FBR) investment contract, which is reported at contract value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Notes to Financial Statements

The Plan administrator determines the valuation policies utilizing information provided by AUL. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion of the FBR contract.

Investment transactions (purchases and sales) are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

Contributions Receivable

Participant contributions are recognized in the period during which the Organization makes the respective payroll deduction from the participant's compensation. Non-elective contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses, Net

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Certain transactional fees are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

The Plan's service agreement with AUL provides for a revenue sharing account which is maintained by AUL and is funded through revenue credits generated by the investments within the Plan. The revenue sharing account is to be used to pay the Plan's administrative expenses. During the year ended December 31, 2024, the Plan received credits in the amount of \$13,230, which was used to pay certain administrative expenses. Administrative expenses are presented net of revenue sharing credits in the statement of changes in net assets available for benefits.

Reclassifications

Certain reclassifications have been made to the prior year's financial statements to conform to current year presentation. These reclassifications had no impact on previously reported net increase in net assets available for benefits.

3. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of

December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts - Valued at the net asset value (NAV) of units held by the Plan at year end based on the market value of its underlying investments. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV per unit is used as the practical expedient to estimate fair value.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) *Target Date* - The objective of these portfolios is to seek a high total return by the fund's target retirement date under normal market conditions.

(b) *Equity* - The equity funds aim to achieve long-term capital growth and income through diversified investments in stocks, balancing risk and return in line with the fund's investment strategy.

(c) *Bond* - The bond funds seek to provide income and capital preservation by investing primarily in a diversified portfolio of fixed-income securities consistent with prudent risk management.

(d) *Real Estate* - The real estate fund seeks total return through capital appreciation and current income by investing primarily in publicly traded real estate companies and real estate investment trusts (REITs).

5. Investment at Contract Value

The Plan entered into a fully benefit-responsive guaranteed investment contract with AUL. AUL maintains the contributions in the Fixed Option Account (the Account) which is invested in a Fixed Interest or Stable Value Account that is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Account is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Account is an interest-earning investment option, backed by AUL's general account assets. AUL guarantees that interest will be credited at the higher of the rate guaranteed in the group variable annuity contract and the current rate declared by it. The guarantee is based on the continued claims-paying ability of the AUL.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of this investment was \$942,284 and \$795,800 as of December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with AUL. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit AUL to terminate the agreement prior to the scheduled maturity date.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by AUL or its subsidiaries and affiliates. Participant loan and distribution processing fees are paid to AUL by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all contributions will be discontinued, and all Plan participants will become fully vested in their account balances.

8. Tax Status

The Plan uses a pre-approved plan document sponsored by OneAmerica Financial Partners (OneAmerica). OneAmerica received an opinion letter from the IRS, dated November 22, 2017, which states that the pre-approved Plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

10. Delinquent Participant Contributions

During 2023, certain participant loan repayments for one pay period totaling \$30 were not remitted by the Organization within the appropriate time period as prescribed by the Department of Labor (DOL) Regulations. This transaction constitutes a non-exempt party-in-interest or prohibited transaction as defined by ERISA. The Organization self-corrected this transaction during 2024 by remitting related lost earnings to the Plan.

11. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025 the date the financial statements were available to be issued.
