1. Description of the Plan

The following brief description of the United Heating and Cooling 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective January 1, 1997. The Plan sponsor is United Heating and Cooling Incorporated (the Company). The Plan covers all employees of the Plan sponsor who have at least two months of service. Employee participation in the Plan is voluntary. The Plan was restated effective January 1, 2021.

Contributions

Employees may contribute up to 100 percent of their eligible compensation or the amount permitted by Internal Revenue Service (IRS) regulations, which was limited to \$23,000 in 2024. Employees who meet certain age requirements are also permitted to make catch up contributions. The Plan also permits employee Roth contributions, as well as rollover contributions. The Company may make discretionary matching contributions as outlined by the Plan agreement. During 2024, the Company made matching contributions of fifty percent of employee deferrals up to four percent of eligible compensation. All contributions are subject to maximum amounts as permitted by the Internal Revenue Service (the IRS).

Once meeting eligibility requirements, employees are automatically enrolled in the plan with an initial deferral rate of four percent (4%) of base salary unless the participant makes a contrary election or opts out of participation.

Participant Accounts

All Plan investments are participant directed. Plan participants have the option of having their contributions invested in a variety of mutual funds or a stable value fund. Each participant's account is credited with the participant's contributions, and allocations of (a) the Company's contributions, (b) Plan earnings or losses, and (c) charged with loan or distribution fees and other administrative expenses, if applicable. Allocations are based on participant earnings or account

balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at two percentage points over the prime interest rate. Principal and interest is paid ratably through payroll deductions.

Vesting

Under the provisions of the Plan, participants are immediately 100 percent vested in their contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant vests in increments over a six year period, with twenty percent vesting after two years, and one hundred percent vesting after six years of credited service for the matching contributions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,768 and \$843, respectively. Any forfeiture balances will be used to reduce employer contributions or to pay plan expenses, in accordance with Plan provisions. During 2024, forfeitures of \$12,674 were used to pay plan expenses.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account or a partial distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account. If the participant's balance is below \$5,000, the vested account balance may only be distributed in lump sum payment. The Plan permits in-service withdrawals under certain conditions.

Administrative Expenses

Costs of administering the Plan such as investment advisory and custodial fees are paid by the Plan and are included in the financial statements. Other costs of administering the Plan are paid by the

Company and are not included in the financial statements. Certain costs such as loan and distribution fees are allocated directly to the specific participants.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants would be immediately vested in their account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest from investments is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued but unpaid interest. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect

the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants or distribution fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Investment Information Certified by Custodian

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income, interest on participant notes receivable, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the custodian, Newport Trust Company. All investments are participant directed.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to

unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the quoted market prices which represent the net asset value of shares held by the Plan at year end. There are no restrictions on the redemption of these investments.

The Plan invests in a common collective trust ("CCT"), the Reliance Stable Value Fund. The investment uses the net asset value (NAV) reported by the issuer as a practical expedient to establish the value. The primary investment objective of the stable value fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. The Fund invests entirely in the MetLife Group Annuity Contract 25053 which consists of separately managed investment portfolios directed by Reliance Trust Company. There are no redemption restrictions for participant directed investments and there are no unfunded commitments. Participant transactions may occur daily.

5. Income Tax Status

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no

provision for income taxes has been included in the Plan's financial statements. The plan sponsor has indicated they will take any necessary steps to maintain the tax qualified status of the Plan.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position more likely than not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Administration of Plan Assets

The Plan's assets are held by the custodian of the Plan. Employee contributions are held and managed by the custodian, which invests cash received, interest, and dividend income and makes distributions to participants. The record keeper of the plan administers the payment of interest and principal on the participant notes receivable.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Related Party Transactions

As noted in Notes 1 and 6, the Plan has a number of service providers. Such parties are parties-in-interest under ERISA.
