NOTE A - PLAN DESCRIPTION

The following description of the Faith Technologies Incorporated 401(a) Plan (the Plan) is based on the Plan document and provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Faith Technologies Incorporated (the Company or Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Restatement of Previously Issued Financial Statements

During the preparation of the Plan's 2024 audited financial statements and notes thereto, it was concluded there was an error related to an employer contribution receivable which was not recorded in its previously issued audited financial statements as of and for the year ended December 31, 2023. This error resulted in an understatement of the employer contributions receivable, employer contributions, and net assets available for benefits. The impact from the restatement on the individual line items of the financial statements as of December 31, 2023 are as follows:

Participation and Contributions

Each year the Company can elect to make contributions into the plan at the discretion of the board of directors. Participant contributions into the Plan are prohibited.

Non-union employees of the Company are eligible to participate in the Plan after attaining the age of 18 years. Employees are automatically enrolled in the Plan upon date of employment. Employees must be employed as of the date of the contribution.

Participants direct the investment of Company contributions into various investment options offered by the Plan.

For the year ended December 31, 2024, the Company elected to contribute to each regular, part-time and full-time hourly field and Excellerate employee who has been employed with the Company for at least 30 days and is employed at the time of payment. For every 30 days the Company worked without a recordable safety incident the aforementioned employees received a contribution of \$50. Each payout increased by \$50 for each 30 day milestone worked incident free.

The Company also elected to \$3,000 to all employees for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with company contributions, investment earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in employer contributions plus earnings after a period of three continuous years of service. However, a participant will become fully vested in employer contributions once they reach the age of 55 regardless of the three continuous years of service requirement.

Payment of Benefits

Distribution of benefits, whether by reason of termination, death, disability or retirement, will be made at the election of the participant but are subject to the following:

If the vested account balance is greater than \$1,000 but less than \$5,000 and the participant does not elect to have their distribution paid in a single lump sum, the Plan Administrator can direct the distribution to be made in a direct rollover to an eligible individual retirement account designated by the Plan Administrator.

If a participant's vested balance is less than \$1,000, the participant will receive an amount equal to the value of the vested interest in his or her account in a lump-sum distribution.

The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment, installments or an annuity. Participants experiencing financial hardship may withdraw a portion of this account balance as defined in the Plan.

Forfeiture Accounts

Forfeited nonvested accounts from Employer contributions reduce non-elective contributions to the Plan and plan expenses. Forfeitures of terminated participants' nonvested account balances used to reduce employer contributions totaled \$522,339 for the year ended December 31, 2024. At December 31, 2024 and 2023, the outstanding balance of forfeited nonvested accounts totaled \$1,242,116 and \$72,299, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As required, the accompanying statements of net assets available for plan benefits present the contract value of the fully benefit-responsive investment contracts, and the statements of changes in net assets available for plan benefits are prepared on a contract value

basis. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain administrative expenses are paid by the Company. All other administrative expenses are paid by the Plan and expensed when incurred.

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE C - RISKS AND UNCERTAINTIES

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) provides a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; and
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts

Valued at the net asset value (NAV) of shares, as a practical expedient to fair value, which is calculated based on the valuation of the fund's underlying investments at fair value at the end of the year.

Mutual Funds

Valued at the NAV of shares held by the Plan at year end, as based on quoted market data.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INCOME TAXES

The Internal Revenue Service (IRS) has determined and informed the Plan, which adopted the Prudential Prototype Plan, by a letter dated April 29, 2014, that the Plan is designed in accordance with the applicable section of the Internal Revenue Code (IRC). The Prototype Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to provisions of ERISA.

NOTE G - RELATED-PARTY TRANSACTIONS

Certain plan investments are managed by Empower Retirement, LLC (Empower) and Prudential Bank and Trust F.S.B (Prudential). In October 2023, the Plan's trustee changed from Prudential to Empower as part of the sale of Prudential Financial Inc.'s full-service retirement business to Empower executed in April 2022. Empower and Prudential are the trustees as defined by the Plan and, therefore, any transactions with the trustees qualifies as party-in-interest transactions.

During 2024 and 2023, the Plan engaged Alpha Investments to consult with the Plan on which assets to invest in; therefore, any transactions with Alpha Investments qualify as party-in-interest transactions.

NOTE H - INFORMATION CERTIFIED BY TRUSTEES

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustees have certified that the following data included in the financial statements and supplementary schedule are complete and accurate:

- Investments at fair value and contract value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary schedule.

NOTE I - GUARANTEED GENERAL ACCOUNT CONTRACTS

The Plan has a contract with Empower Annuity Insurance Company, formally known as Prudential Retirement Insurance and Annuity Company (the contract). Participants may ordinarily direct the withdrawal or transfer of all or a portion of their account balance at contract value. Contract value represents contributions made under the Contract, plus earnings, less participant withdrawals and fees. The Contract is considered benefit responsive by the trustees. If discontinuance of the Contract was to occur, fair value would equal contract value.

Interest is credited on contract balances using a single “portfolio rate” approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the Contract regardless of the timing of the contributions. Interest crediting rates are reviewed on a semi-annual basis for resetting. When establishing the interest crediting rates, the trustees consider current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the trustees’ general account.

Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or over time. There are not any events that allow the trustees to terminate the Contract and which require the Company to settle at an amount different than the Contract value paid either within 90 days or over time.

NOTE J - SUBSEQUENT EVENTS

The Company evaluated its December 31, 2024 financial statements for subsequent events through October 10, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

SUPPLEMENTAL INFORMATION
