***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Sagis 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan was amended and restated effective January 1, 2024 to adopt a new pre-approved basic plan document sponsored by Nova 401(k) Associates. There were no changes to Plan provisions as a result of the restatement.

**General**

The Plan is a defined contribution plan adopted effective January 1, 2019 covering all employees of Sagis, PLLC (the “Company”), except leased employees and nonresident aliens. Employees are eligible to participate in the Plan on the first day of the month coinciding with or next following completion of two months of service and attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration of the Plan**

Effective February 16, 2024, the trustees for the Plan are John Hancock Trust Company and an officer of the Company. John Hancock Retirement Plan Services is the recordkeeper. For the period prior to February 16, 2024, the trustee for the Plan was Ascensus Trust Company and the Vanguard Group (Vanguard) was the recordkeeper. Vanguard retained Ascensus, LLC as a subcontractor to provide recordkeeping services on behalf of Vanguard.

All Plan net assets were transferred into funds comparable to those offered by Vanguard. The conversion initiated a blackout period beginning February 9, 2024 that continued through March 18, 2024. During this period, participants could not access their accounts and could not initiate transactions such as contribution changes, investment transfers, withdrawals or loans. Participant contributions continued to be withheld through payroll deductions.

**Contributions**

Participants may elect to make pre-tax and/or Roth salary deferral contributions up to 90% of eligible compensation and not to exceed the maximum allowed under the appropriate sections of the Internal Revenue Code (IRC). The Plan has adopted a qualified automatic contribution arrangement (QACA). Eligible employees who have not enrolled in the Plan or declined participation will be automatically enrolled at a pre-tax salary deferral rate of 3%. Participants automatically enrolled under QACA will have their deferrals increased by 1% on the first day of each plan year up to a maximum of 10%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows rollover contributions from other qualified retirement plans.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

The Company will make a QACA ADP safe harbor nonelective contribution equal to 3% of each eligible employee's eligible compensation for the plan year. The Company may also make a discretionary QACA ACP safe harbor matching contribution calculated on a plan year basis. A discretionary profit sharing contribution may be made each plan year and allocated based on the ratio of each eligible participant's eligible compensation over the total eligible compensation for all qualifying participants for the plan year. A participant must complete one year of service, attain age 18 and be employed on the last day of the plan year to be eligible for all employer contributions. The last day requirement will be waived in the event of a participant's death or termination of employment due to incurring a disability or reaching normal retirement age. The Company did not make any discretionary QACA ACP safe harbor matching or profit sharing contributions for 2024.

The Plan is participant directed. Participants may change their contribution rates each pay period and investment options daily.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, QACA ADP safe harbor nonelective contributions, discretionary QACA ACP safe harbor matching and profit sharing contributions, and earnings, including realized and unrealized gains and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are at all times fully vested in their contributions and appreciation or depreciation thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of service. Participants become 100% vested in their QACA ADP safe harbor nonelective contributions after two years of service. Participants vest in their discretionary QACA ACP safe harbor matching and profit sharing contributions 20% per year after two years of service and are 100% vested after six years of service. A participant shall be immediately vested upon death, normal retirement age or termination of employment due to total and permanent disability.

**Forfeitures**

Forfeitures of nonvested contributions shall be used to pay administrative expenses or to reduce Company contributions to the Plan. The forfeiture balance was \$22,323 and \$13,007 at December 31, 2024 and 2023, respectively. The amount of forfeitures used to pay Plan administrative expenses and reduce Company contributions was \$1,550 and \$38,639, respectively, during 2024.

**Payment of Benefits**

Normal retirement age under the Plan is 65. Upon a participant's retirement, disability, death, or termination of employment, the vested funds in the participant's account may be distributed in a lump-sum or partial payments as elected by the participant or beneficiary. Participants who terminate with an account balance of \$5,000 or less will be cashed out of the Plan as soon as administratively feasible. Effective January 1, 2024, in conjunction with the Secure 2.0 Act, the account balance threshold was raised to \$7,000. The Plan also allows in-service withdrawals at age 59½ and hardship distributions from a participant's elective deferral and vested profit sharing contribution account balance.

**Notes Receivable from Participants**

Plan participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000, reduced by the excess of the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan, or 50% of their vested account balance in the Plan, excluding Roth deferrals. Loans are repaid in level installments through payroll deductions for periods ranging up to five years, or longer for the purchase of a primary residence. The loans bear interest at prime plus 1% as determined at the date of the loan and are secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest. Participants may only have one loan outstanding at any time.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested and receive benefits based on their account balances accumulated to the date of termination of the Plan.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Contributions**

Contributions from Plan participants and the QACA ACP safe harbor matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation. The QACA ADP safe harbor nonelective contribution and discretionary profit sharing contribution are recorded in the plan year in which participant compensation is paid.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investments**

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to recordkeeping, notes receivable from participants and withdrawals are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Mutual Funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**NOTE 4 - INFORMATION CERTIFIED**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC as agent for Ascensus Trust Company, the trustee of the Plan as of December 31, 2023 through February 15, 2024, and John Hancock Trust Company, the trustee of the Plan beginning February 16, 2024, have certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments held from December 31, 2023 to February 15, 2024 were in mutual funds managed by Vanguard. Vanguard was the recordkeeper of the Plan during that period. Transactions in such investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

**NOTE 6 - TAX STATUS**

The Plan has adopted a non-standardized pre-approved plan, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the document satisfies the applicable provisions of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - OPERATIONAL ERRORS**

Management determined that there were operational errors during the plan years 2019, 2021, 2022, 2023, and 2024. These errors resulted from improperly following Plan provisions related to the calculation of salary deferral and matching contributions, determination of eligibility service requirements and timeliness of automatic enrollment. Management is in the process of analyzing the effect these errors will have on the Plan.

**NOTE 9 - DELINQUENT CONTRIBUTIONS**

During 2023 and 2024, there were unintentional delays by the Company in submitting participant contributions to the Plan in the total amount of \$335,572. The Company intends to compensate the affected participants for any lost earnings resulting from these delinquent contributions in 2025.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan was amended and restated effective January 1, 2025 to increase the QACA automatic enrollment contribution rate to 10% and remove the automatic 1% increase.

Management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
