As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of Special People in Northeast, Inc. 403(b) Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

As described in Note 11, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirement for 403(b) Plans*. If the identified contracts as reported by the custodians, were included, net assets available for benefits would increase approximately \$1,426,862 and \$1,250,293 as of December 31, 2024 and 2023, respectively. Further, investment gains of approximately \$202,969 and distributions and expenses of approximately \$26,401 related to such accounts, as identified by the custodians of these accounts, have also been excluded in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Special People in Northeast, Inc. 403(b) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Special People in Northeast, Inc. 403(b) Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Special People in Northeast, Inc. 403(b) Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of or for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

(1) Description of Plan

The following description of the Special People in Northeast, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution plan covering all employees of Special People in Northeast, Inc. (the Company). Employees are eligible to make elective deferrals upon their date of hire and are eligible to receive employer matching contributions and non-elective contributions, subject to certain additional eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Company has engaged Haverford Trust Company to provide investment advisory services, including monitoring the plan assets and overseeing the Plan.

Effective December 31, 2016, the Special People in Northeast, Inc. 403(b) Custom Retirement Plan for Non-Union Employees (Non-Union Plan) was merged with the Special People in Northeast, Inc. 403(b) Custom Retirement Plan for Union Employees (Union Plan). The merged plan was amended and restated effective January 1, 2017 and was renamed the Special People in Northeast, Inc. 403(b) Plan.

Contributions

Each year, participants may contribute a portion of their annual compensation, as defined by the Plan, up to the Internal Revenue Service (IRS) limitation. Participants may elect to have their deferrals be either pre-tax 403(b) contributions or after-tax Roth contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly hired employees are automatically enrolled at 3% in the Plan unless they affirmatively elect not to participate. Additionally, the Plan includes an auto-increase provision whereby for each plan year beginning in the second year following the Non-Union employee's initial enrollment, the participant shall be deemed to have made an annual election to increase their deferral by an additional 1%, up to a maximum of 6%. Automatically enrolled participants may elect not to participate in the auto-escalation provision, which can be done when a participant changes their election by contacting the recordkeeper of the Plan. Automatic annual increases are effective November 1 of each year.

Contributions, Continued

Employer matching contributions are allocated to eligible employees' accounts semi-annually. Only participants who are actively employed on the last day of the allocation period shall be eligible to share in the matching contribution for such allocation period. Non-Union eligible employees may receive a match up to 6% of their salary. Union eligible employees may receive a match from 1% to 5% of their salary, based on years of employment, after completion of one year of service. An additional non-elective employer contribution of 1% is made annually after 5 years of service for eligible Union employees, if they have set up their account in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their employee contributions plus actual earnings thereon. Union employees shall be fully vested in their matching contribution accounts at all times.

Vesting in the Non-Union employer contributions is based on years of service according to the following schedule:

2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%

6 or more	100%

Participants become immediately vested upon termination of employment due to death or disability.

Notes Receivable from Participants

Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The interest rate on a loan is the prime rate plus 1% per year. The loans are secured by the balance in the participants' accounts and bear interest at rates that range from 3.25% to 8.50%. Loans must be repaid over a period not extending beyond five years or up to a reasonable time if such loan was for the purchase of a primary residence. All loans are administered through the My Plan Loan program offered by Benefit Plans Administrative Services, LLC (BPAS), the recordkeeper for the Plan. Participants repay the loans monthly, directly to BPAS, rather than through payroll deductions. Participants may only have two loans outstanding at any time.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum amount, or in installments over a period of time, as defined. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, the forfeited nonvested account totaled \$37,280 and \$30,165, respectively. This account will be used to reduce future employer contributions or administrative expenses. During 2024, the forfeited nonvested account was used to reduce employer contributions and pay plan administrative expenses in the amounts of \$30,104 and \$89, respectively.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of revenue and expenses during the reporting periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

(3) Financial Information Certified by a Qualified Institution

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Line 4i- Schedule of Assets (Held at End of Year), including investments at fair value, fully benefit-responsive investment contract at contract value, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Hand Benefits & Trust Company (HB&T), a qualified institution.

(4) Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

(5) Guaranteed Investment Contract

The Plan has a benefit-responsive guaranteed investment contract with Standard Insurance Company (Standard) totaling \$818,259 and \$1,859,517, as of December 31, 2024 and 2023, respectively. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. The interest rate is reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), or (2) reduction in number of participants. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

(6) Related Party Transactions and Party-In-Interest Transactions

The Plan's investments include an insurance company general account contract and shares of registered investment companies managed by HB&T. HB&T is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt under the prohibited transaction rules.

(7) Prohibited Transactions

As required by ERISA Section 2510.3-102, the Plan sponsor is required to segregate employee contributions from its general assets as soon as practicable. During 2024, certain employee deferrals amounting to \$400,495 were not remitted to the Plan within the timeframe required by the Department of Labor under the plan asset rules. The Company estimated the amount of corrective lost earnings payments due to the Plan was approximately \$600. The Company intends on correcting these transactions in 2025.

(8) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

(9) Tax Status

The Plan uses a prototype plan document sponsored by BPAS. The plan terms have been drafted to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in accordance with the Internal Revenue Code (IRC) to maintain the tax exempt status for plan participants under Section 403(b). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for the tax periods in progress.

(10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
