1. Description of the Plan

The following description of the O'Neil & Associates, Inc. Profit Sharing and Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a salary reduction and profit sharing plan covering employees who are at least 21 years of age and have completed 1,000 hours of service within a 12 month period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 50% of their compensation to the Plan on a pre- and after-tax basis through payroll deductions. Participants who have attained age 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company may contribute a matching contribution to the Plan. For the years ended December 31, 2024 and 2023, the Company elected to make matching contributions equal to 50% of the first 6% of compensation deferred by the participant. In addition, the Company may make an additional profit sharing contribution on behalf of all employees who are eligible to participate in the Plan. For the years ended December 31, 2024 and 2023, the Company elected not to make an additional contribution. Contributions are subject to certain statutory limitations.

Eligible participants will have automatic elective deferrals withheld from their compensation at 6%. Participants have the option to change their automatic elective deferral amount or opt out of the automatic elective deferral.

Payment of Benefits

On termination of service due to termination of employment, death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. If the benefit is less than \$1,000, a participant will automatically receive the value of the vested interest in his or her account as a lump-sum distribution. If a terminated participant's balance exceeds \$1,000 but is less than \$5,000, and the participant fails to make an election to receive a lump sum amount or a direct rollover to a participant selected plan, a distribution will be paid by the Plan administrator as a direct rollover to an individual retirement account designated by the administrator. In addition, hardship, early retirement, and in-service distributions are permitted if certain criteria are met.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and forfeited vacation pay plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on the number of years of credited service. A participant is 100% vested after six years of credited service.

1. Description of The Plan (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through bi-weekly payroll deductions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,312 and \$769, respectively, which can be used to reduce future employer contributions or plan expenses. During 2024 and 2023, employer contributions were reduced by \$0 and \$36,484, respectively, from forfeited nonvested accounts. During 2024 and 2023, expenses were reduced by \$15,500 and \$0, respectively, from forfeited nonvested accounts.

Investments

Upon enrollment in the Plan, a participant may direct employee contributions in various investment options. Employer contributions follow the same investment options elected. Participants may change their investment options daily. The investment options are diversified in conformity with the ERISA diversification requirement.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fully benefit-responsive investment contracts are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (Continued)

Payment of Expenses

All expenses of administration may be paid out of the Plan unless paid by the Employer. Such expenses shall include any expenses incident to the functioning of the Administrator, including but not limited to, fees of accountants, counsel, and other specialists and their agents, and other costs of administering the Plan. The Company elected to pay a portion of the expenses of the Plan during 2024 and 2023.

3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

4. Tax Status

The Company adopted a volume submitter plan which received an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel and sponsor believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets.
- Level 2 - Inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies the Plan used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. Mutual funds are required to publish their daily net asset value and to transact that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Investment with Insurance Company

The Plan has a fully benefit-responsive stable value fund with Transamerica Life Insurance Company (Transamerica). Transamerica maintains the contributions in a general investment account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value, as reported to the Plan by Transamerica, represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. This type of investment is considered a deposit liability with no defined maturities and is fairly valued at contract value; therefore, the contract value is estimated to be the fair value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan is changed so as to significantly affect Transamerica's obligations to the contract, (2) the contract can no longer be treated as a pension plan contract, (3) the Plan is terminated, (4) failure to comply with the contract requirements or (5) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Investment with Insurance Company (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The investment has a portfolio investment rate design in which all deposits in the investments are credited with the same interest rate on a daily basis, with no set maturity. Such interest rates are reviewed on a semi-annual basis for resetting and are effective on the first day of the first and seventh months of the year. Average yield and crediting rate for the years ended December 31, 2024 and 2023 was 1.65% and 1.25%, respectively.

7. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplementary schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company (a Trustee of the Plan through June 30, 2024) and Transamerica Trust Company (a Trustee for the period July 1, 2024 through December 31, 2024) and Transamerica Financial Life Insurance Company (a Trustee for the years ended December 31, 2024 and 2023).

8. Risks and Uncertainties

The Plan invests in various investment options. These investment options are exposed to various risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Party-In-Interest Transactions

Certain Plan investments are funds managed by Transamerica Financial Life Insurance Company, a third party administrator of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

10. Subsequent Events

Management evaluated the activity of the Plan through October 10, 2025 (the date the financial statements were available to be issued) and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
