## Independent Auditor's Report

To the Participants and Administrator of  
Pure Source, LLC Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pure Source, LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

#### 1. Description of the Plan

The following description of Pure Source, LLC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution retirement plan covering all eligible employees of Pure Source, LLC (the “Company”) who have completed at least one year of service and have attained twenty-one years of age. Employees enter the Plan on the first day of the quarter of the plan year coinciding with the month or the month following the date on which they meet the eligibility requirements. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### **Plan Administration**

Empower Annuity Insurance Company of America serves as the trustee of the Plan. The Trustee is responsible for oversight of the Plan. The Plan utilizes Definiti, LLC as the third-party administrator.

##### **Elective Deferrals and Company Contributions**

Each year, participants may elect to defer a percentage of their base compensation or a specific dollar amount and have that amount contributed to the Plan on a pre-tax basis as a salary deferral (“elective deferrals”). For any calendar year, a participant’s elective deferrals may not exceed a certain dollar amount as determined by the Internal Revenue Service (“IRS”). Participants 50 years of age or older can make an additional “catch-up” deferral of up to an additional \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

Each year, the Company may make a discretionary qualified non-elective profit-sharing contribution to eligible participant’s account. The contribution is allocated based on a uniform percentage of each eligible individual’s compensation, subject to limits and in accordance with the contribution defined for each group of employees. The Company elected to not contribute for 2024. The participant must complete a year of service hours during the Plan year and be actively employed on the last day of the Plan year to share in any employer’s contributions. The participants will have completed a year of service for purposes of sharing in the employer discretionary profit-sharing contribution if they are credited with at least 1,000 hours of service during the Plan year.

##### **Participants’ Accounts**

Each participant’s account is credited with the participant’s elective deferrals and allocations of (a) the Company’s qualified non-elective profit-sharing discretionary contributions, and (b) investment earnings or losses, and (c) charged with an allocation of administrative expenses if the expenses are not paid by the Company. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Participants may change their investment allocation at any time.

##### **Vesting and Forfeitures**

Participants are immediately vested in their elective deferrals and amounts rolled over into the Plan plus actual investment earnings thereon. Vesting in the Company’s non-elective discretionary profit-sharing portion of their account is based on years of continuous service. A participant is fully vested after six years of credited service. A participant becomes 100 percent vested upon death, disability or retirement.

Non-vested portions of Company contributions are forfeited as of a participant's termination date. Forfeitures are available to be used to reduce future Company contributions and may be used to offset administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,664 and \$7,424, respectively. Also, in 2024, Company utilized forfeited non-vested accounts to pay administrative expenses of \$5,525 and did not utilize to reduce the contributions.

#### **In-service and Hardship Withdrawals**

A participant over the age of 59 1/2 may make withdrawals of the vested portion of the Company contributions, subject to certain restrictions. Participants may request a hardship distribution from the Plan prior to the participant's termination of employment in any one Plan year up to the lesser of 100% of the participant's elective salary deferrals and the participant's transfer/rollover account value as of the last valuation date or the amount necessary to satisfy the immediate and heavy financial need of the participant. In order to request a hardship distribution, the participant must meet one of six conditions related to a financial hardship as defined by the Internal Revenue Code.

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a single lump-sum amount equal to the value of the participant's vested interest in their account, or installments that are distributed in accordance with the Plan. A participant with less than \$5,000 in vested benefits may only be distributed a single lump sum. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or if the Plan offers an investment option contract that provides a life income feature, then distributions from this investment may be in any form permitted by the contract. If the vested balances are less than \$5,000 and no choice is made, the Plan will automatically pay out their vested balance in a lump-sum distribution.

## **2. Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 8 for additional information on fair value measurements.

Purchases and sales of units are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to distributions

are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in the net appreciation or depreciation in fair value of investments.

**Benefit Payments**

Benefits are recorded when paid.

**Date of Management’s Review**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**3. Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America (See Note 1), the trustee of the Plan and qualified institution, has certified certain information included in the accompanying financial statements and supplementary schedules as complete and accurate with respect to investments as shown on the statement of net assets available for benefits as of December 31, 2024 and 2023, and net investment activity as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the trustee.

**4. Related Party Transactions and Party in Interest Transactions**

Certain Plan investments are managed by the trustee (See Note 1). These transactions qualify as party in interest transactions. The Plan also uses third-party service providers to perform administrative functions. Transactions with such providers are considered an exempt party in interest transactions under ERISA.

**5. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of any termination of the Plan, or upon complete or partial discontinuance of contributions, participants would become 100% vested in their accounts, including all employer discretionary profit-sharing contributions and actual earnings thereon.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term

and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and statement of changes in net assets available for benefits.

#### 7. Tax Status

The Plan has adopted a non-standardized pre-approved profit-sharing plan sponsored by The Pension Studio, which was acquired by Definiti, LLC, the Plan's third-party administrator. The Internal Revenue Service ("IRS") has determined and informed The Pension Studio by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, the Plan has no liabilities for uncertain tax positions. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 8. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The following three levels of fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled Separate Accounts ("PSA")* – Investments in pooled separate accounts with Empower are valued at NAV, which is a practical expedient for estimating the fair values of these investments. Each of these investments may be redeemed daily with a notice period of one day. The Plan had no

unfunded commitments as of December 31, 2024 and 2023. Because the fair value of the PSAs are not considered to be readily determinable and are measured using net asset value per share as a practical expedient, these investments have been excluded from the fair value hierarchy.

## 9. Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive fixed account with MassMutual Life Insurance Company ("MassMutual"). Empower maintains the contributions in a general asset account ("GIA"), which is primarily invested in investment grade fixed income securities. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were initiated permitted transactions under the terms of the Plan. The investment strategy of the fully benefit-responsive investment contract is to achieve consistent returns to support a competitive credited rate. Bonds invested in the general account segment have an average maturity between three and seven years; are investment-grade in quality; and are diversified across a range of fixed-income asset classes such as asset-backed securities, mortgage-backed securities, commercial mortgage-backed securities, commercial mortgages and private equity. While the group annuity contract is active, the GIA is

subject to competing fund transfer restrictions on participant-initiated transfers. Upon termination of the group annuity contract, if the plan sponsor chooses a book value payout for termination, participant transfer restrictions may apply until the money is paid to the next provider.

Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The effective guaranteed credited interest rate is reviewed on a quarterly basis for resetting. There are no unfunded commitments, and the redemption frequency is daily with a notice period of one day.

**10. Non-Exempt Transactions**

As disclosed in the accompanying supplemental schedule, during 2024 and 2023, employee deferrals of \$10,903 and \$7,642, respectively, were not remitted to the Plan within the timeframe required by the Department of Labor. The Company is currently in the process of remitting any related lost earnings to the affected participants into the Plan for the 2024 and 2023 late employee deferral.
