DECEMBER 31, 2024 AND 2023

### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Goodwill Industries of Ventura and Santa Barbara 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### 1. General

The Plan is a defined contribution plan, established on January 1, 2017. The Plan covers substantially all employees of Goodwill Industries of Ventura and Santa Barbara (the "Organization" or "Employer"), except nonresident aliens, union employees, leased employees, and interns. Employees are eligible to participate in the Plan immediately upon attainment of age 18 and completion of three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### 2. Contributions

Participants may elect to contribute, on a tax-deferred basis or on an after-tax Roth basis, up to 90% of compensation (50% for Roth), up to the maximum annual deferral limit under section 402(g)(1) of the Internal Revenue Code ("IRC"). Participants attaining age 50 before the end of the calendar year are eligible for catch-up contributions.

The Organization may, at its discretion, make matching and non-elective profit-sharing contributions to the Plan. For the year ended December 31, 2024, the Organization elected to provide a matching contribution of 50% of participants' contributions up to a maximum of 6% of employees' compensation for a maximum match equal to 3% of participant compensation. The Organization did not elect to provide non-elective profit-sharing contributions to the Plan for the year ended December 31, 2024.

#### 3. Rollover Contributions

An employee who qualifies as part of an eligible class of employee can make rollover contributions subject to the guidelines of the Plan.

#### 4. Investment Options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions as desired, in any of a variety of options held by Matrix Trust Company (the Plan custodian), as chosen by the Organization. Participants may change their investment options daily.

#### 5. Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Employer matching contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### 6. Vesting

Participants are fully vested in their elective deferral contributions and rollover contributions, plus actual earnings thereon, at all times.

Vesting of the discretionary Employer contribution portions of participant accounts, plus actual earnings thereon, is based upon the participant's years of service with the Employer as follows:

#### 7. Benefit Payments

Upon termination of service or attainment of the age of 59 ½ years, a participant is entitled to receive a lump sum payment, installments, or a partial withdrawal of the total value of the participant's vested account balance. The Plan permits hardship distributions if certain criteria are met. In the event of death, disability, or normal retirement while employed, a participant or a participant's beneficiary is entitled to the total value of the participant's account.

#### 8. Forfeitures

Forfeitures of terminated participants' nonvested accounts may be used to pay administrative expenses, be applied against future Employer contributions, or be reallocated to participants. Forfeitures totaling \$3,161 were applied during the year ended December 31, 2024. As of December 31, 2023, and December 31, 2024, the Plan reported no forfeiture account balances.

##### 9. Plan Termination

While the Employer has not expressed any intent to terminate the Plan, the Employer reserves the right to terminate the Plan at any time. Upon termination, future contributions to the Plan cease, and the assets are distributed among the participants of the Plan in accordance with the provisions of the Plan.

##### 10. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest combined balance of all loans during the preceding 12 months. Generally, loans have a five-year maximum term. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% plus the prime rate. Principal and interest are paid ratably through payroll deductions. Participants may only have one loan outstanding at any time.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### 1. Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

##### 2. Plan Administration

The Employer is the Plan Sponsor and Plan Administrator. The Plan Administrator is responsible for carrying out the duties imposed under ERISA.

##### 3. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### 4. Payment of Benefits

Benefits are recorded when paid.

5. **Administrative Expenses**

Administrative expenses, consisting of investment advisory and recordkeeping expenses, incurred by the custodian and recordkeeper in performance of their duties are paid from the assets of the Plan. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Substantially all other out-of-pocket administrative expenses of the Plan are paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements.

6. **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

7. **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

8. **Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### NOTE C - CERTIFIED INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held at December 31, 2024, and net appreciation in fair value of investments, and interest and dividends (if any) for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the Plan custodian).

#### NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - TAX STATUS**

The Organization adopted a non-standardized pre-approved profit-sharing plan ("pre-approved plan") which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the preapproved plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter; however, the administrator and advisors believe that the Plan is currently designed and operated in compliance with the applicable provisions of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction programs. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are held and managed by Matrix Trust Company. Matrix is the Plan custodian, as defined by the Plan. Human Interest Inc. is the Plan's recordkeeper. All investments are held with the custodian. Therefore, transactions with these entities qualify as party-in-interest transactions. Notes receivable from plan participants and the related interest income are also considered party-in-interest transactions as defined in Section 3(14) of ERISA, for which a statutory exemption exists.

#### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan invests in mutual funds which invest in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

#### **NOTE H - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
