Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Nursing ABC, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 – Description of Plan

The following description of Nursing ABC, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General – The plan is a defined contribution plan covering all employees of Nursing ABC, Inc. (the Company), excluding non-resident aliens, union employees, and certain other employees as defined in the Plan agreement. Employees become eligible to participate in the Plan on the first day of the month following completion of one month of service. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA), as amended.

Employee Contributions – Participants may contribute pre-tax and Roth amounts as defined by the Plan in accordance with the Internal Revenue Code section 415 limits. Participants may also contribute rollovers from other qualified plans. All contributions, including the employer contributions, may be directed at the discretion of each participant into the various investment options offered by the Plan.

Safe Harbor Contributions – The Company provides a matching contribution of 100% on the first 3% of employee deferrals and 50% on the next 2%. This contribution is fully vested immediately and allocated throughout each pay period. The safe harbor contribution was \$311,174 in 2024.

Employer Profit Sharing Contributions – The Company may make a discretionary profit-sharing contribution to the plan each year. Eligible participants must work at least 1,000 hours during the plan year to be eligible. The profit sharing contribution percentage was 10% of eligible wages and totaled \$933,228 in 2024.

Participant Accounts – Each participant’s account is credited with (a) the participant’s contributions, (b) the Company’s contributions, (c) forfeitures, and (d) any earnings or losses thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately 100% vested in their own contributions, rollovers, safe harbor contributions, qualified non-elective contributions, and qualified matching contributions. All service with the employer is counted toward vesting, unless excluded due to a break in service.

The vesting schedule outlined below applies to the Company’s profit-sharing contributions:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than one	0%
One to two	40%
Two to three	70%
More than three	100%

Forfeitures – Forfeitures represent participant account balances that are not vested upon the termination of an employee. Forfeitures may be used to offset employer contributions or to pay administrative expenses of the Plan, at the Plan administrator’s discretion. At December 31, 2024 and 2023, there were unallocated forfeitures of \$30,000 and \$4,797, respectively. The plan document permits the use of forfeitures to reduce employer contributions. No forfeitures were used to reduce the employer contribution in 2024.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant’s account, or various annuity options. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Note 1 – Description of Plan (continued)

Notes Receivable from Participants – Participants may request a loan from the Plan for any purpose, subject to certain limitations. The minimum loan amount is \$1,000, and only one loan may be outstanding at any given time; refinancing is not permitted. The maximum loan allowed is the lesser of 50% of the participant’s vested account balance, or \$50,000 reduced by the highest outstanding loan balance in the past 12 months.

Loans are participant-directed investments, and repayments of principal and interest are credited back to the participant’s account. The interest rate is based on the Wall Street Journal prime rate plus 1%, determined on the date the loan is issued. Loans are amortized with equal installments of principal and interest over the loan term. The interest rate on loans outstanding in 2024 was 9.5%.

Administrative Expenses – Plan-related expenses not covered by the Company are paid by the Plan. To the extent available, forfeitures may be used to offset these expenses. Any remaining administrative expenses are allocated among participants with account balances. Both terminated and active participants share in these costs, with expenses allocated proportionally based on each participant’s account balance.

Termination - Although there is not a present intent to do so, the Company has reserved the right to terminate or partially terminate the Plan and, upon termination, all participants will become fully vested in any funds which have been allocated to them.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Contributions - Employee contributions and Company contributions are recognized as additions to Plan assets in the year designated by the employee and Company, respectively.

Investment Valuation and Income Recognition – Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price), (Note 4). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold, as well as held during year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses - All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Employer.

Subsequent Events – The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note 3 – Information Certified by the Custodian

For the year ended December 31, 2024, the plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Voya Retirement Insurance and Annuity Company, the custodian of the Plan, as complete and accurate, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedule.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets held at end of year as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

Note 4 – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, “Fair Value Measurements and Disclosures,” establishes a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs into three broad levels. Level 1 inputs are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are quoted prices for similar assets in active markets or inputs that are observable for the asset, either directly or indirectly through market corroboration, for substantially the full term of the asset. Level 3 inputs are unobservable and significant inputs developed by the plan sponsor based on the best information available about the assumptions market participants would use in pricing the asset. A financial asset’s classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used in measuring Plan assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts - Pooled Separate Accounts (PSAs) invest in mutual funds and equity securities. PSAs are valued daily at their accumulation unit value multiplied by number of units held. The accumulation unit value is determined daily based on the net asset value of shares of the underlying fund as provided by the Custodian.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related-Party Transactions

The Plan’s assets are invested in pooled separate accounts managed by the Custodian who holds all of the Plan's investment assets in an annuity contract. The Plan issues loans to participants, which are secured by the participant’s account balances. Additionally, the Plan paid certain administrative fees for custodial and recordkeeping services. These transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under Section 408(b) of ERISA regulations.

Note 6 – Tax Status

The Internal Revenue Service has determined by a letter dated June 30, 2020 that the plan used to set the guidelines of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), as amended, and the regulations thereunder, and the Plan is thereby tax-exempt within the meaning of Section 501(a) of the IRC. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and to recognize a tax benefit if it is more likely than not the tax position would be sustained upon examination by the applicable authorities. The remainder of the tax position is required to be recorded as a tax liability. The Plan’s tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed. The Plan currently has no uncertain tax positions and, therefore, no liabilities have been recorded.

Note 7 – Risks and Uncertainties

The Plan provides for various investment options into any number of pooled separate accounts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
