***Opinion***

We have audited the financial statements of the Verista, Inc. Group Medical Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits - modified cash basis as of December 31, 2024, and the related statement of changes in net assets available for benefits - modified cash basis for the year then ended and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits - modified cash basis of the Verista, Inc. Group Medical Plan as of December 31, 2024, and the changes in its net assets available for benefits - modified cash basis for the year then ended, in accordance with the modified cash basis of accounting described in Note 2.

***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. ### NOTE 1 - Description of the Plan

The following description of the Verista, Inc. Group Medical Plan (the “Plan”) provides only general information about the Plan’s provisions. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan provides health benefits as defined in the Plan document, covering all eligible employees of Verista, Inc. (the “Company”), and their eligible dependents. The Plan has a trust to hold Plan assets with a December 31<sup>st</sup> Plan year end. The Plan is subject to provisions of the Employee Retirement Security Act of 1974, as amended (ERISA). The Plan was established January 1, 2024 (Inception).

The Plan is a member of Veris Benefits Consortium, LLC, which operates as a health insurance consortium under which the members negotiate and establish employee welfare benefit plans for their employees. Some expenses of the health plan are paid through the Veris Benefit Trust. The employees may be required to pay for a portion of the cost of the benefit.

Benefits - The Plan provides health benefits (medical and prescription drugs) to the full-time employees and their eligible dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions - The Company and the participants’ share the premiums for the self-funded medical insurance with the participants contributing based on bi-weekly payroll deductions in accordance with the provisions of the Plan.

Stop Loss Coverage - The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure of self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-Insured Benefits - The claims for self-insured benefits are processed by the Plan’s third-party claims processor under administrative services only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by the Plan’s Veris Benefit Trust. Despite the Plan’s utilization of a third-party claim’s processor, ultimate responsibility for the payments to providers and participants is retained by the Plan.

### NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions are recorded when received and are not accrued and certain expenses are recognized when paid rather than when incurred. Accordingly, the accompanying financial statements are not intended to present net assets available for benefits and changes in net assets available for benefits in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein; claims incurred but not reported; eligibility credits; claims payable; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Concentration of Credit Risk - Financial instruments that potentially subject the Plan to concentrations of credit risk consists principally of cash deposits. Accounts at the institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At December 31, 2024, the Plan had no balances exceeding the limit.

The Plan believes it mitigates the risk of holding uninsured deposits by only depositing funds with a major financial institution. The Plan has not experienced any losses in such accounts, and believes it is not exposed to any significant risk.

Payment of Benefits - Premiums are reported when paid. Premiums paid are recorded as insurance company premiums in the accompanying statement of changes in net assets available for benefits - modified cash basis.

Claim payments are recorded when paid by the third-party claims processor and recorded as self-insured benefits paid, net in the accompanying statement of changes in net assets available for benefits - modified cash basis.

Stop Loss - Premiums for stop loss insurance are included in insurance company premiums in the accompanying statement of changes in net assets available for benefits - modified cash basis. During the year ended December 31, 2024, stop loss reimbursements netted against self-insured benefits paid on the statement of changes in net assets - modified cash basis was \$886,481.

### NOTE 2 - Summary of Significant Accounting Policies (continued)

Subsequent Events - The Plan management has evaluated those events and transactions that occurred from January 1, 2025 through July 17, 2025, the date the financial statements were available to be issued.

### NOTE 3 - Claims Incurred but Not Reported

Plan obligations at December 31, 2024 for claims incurred by active participants, but not reported at that date are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment. Claims incurred but not reported are approximately \$330,000 as of December 31, 2024. There were no reportable claims payable at December 31, 2024.

### NOTE 4 - Administrative Expenses

The Plan pays administrative expenses that consists primarily of administrative fees paid to the third-party claims administrators, brokers, patient advocates, and actuary. These expense are reported on the statement of changes in net assets available for benefits - modified cash basis as administrative expenses. All other administrative expenses such as professional fees, are paid by the Company on behalf of the Plan.

### NOTE 5 - Tax Status

The Plan is funded through Veris Benefits Consortium, LLC. The Veris Benefits Consortium, LLC is included on the U.S. Income Tax Return for a limited liability company Form 1065 of the third-party claims administrator for the Plan. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code.

### NOTE 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.
