Independent Auditors' Report

To the Participants and Trustees of
South Dayton Acute Care Consultants, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of South Dayton Acute Care Consultants, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the South Dayton Acute Care Consultants, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by South Dayton Acute Care Consultants, Inc. (the Company, Plan Sponsor or Employer) and covers substantially all eligible employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Under the terms of the Plan, covered employees are eligible to become participants on the first day of the month following or coincident with completion of 83.33 hours of service each month during 3 consecutive months of employment and upon reaching age 21. If an employee does not complete 83.33 hours of service each month during 3 consecutive months of employment, then the employee will satisfy the service requirement if credited with a year of service (1,000 hours).

Contributions

- (a) *Participant's voluntary salary reductions.* Participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan, subject to IRS limitations. Pre-tax elective deferrals and after-tax Roth contributions are available. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan also provides for catch-up contributions for participants age 50 or older.
- (b) *Safe Harbor employer-matching contributions.* The Plan is a safe harbor plan. Under the safe harbor provisions, the Plan Sponsor provides a matching contribution in an amount equal to 100% of participant deferrals up to 6% of the participant's eligible compensation. Matching contributions of \$1,272,460 were made for the year ended December 31, 2024.
- (c) *Discretionary nonelective contributions.* The Plan Sponsor may make discretionary nonelective contributions. This amount will be allocated using a four-tiered formula. To qualify for the discretionary nonelective contribution, a participant must have completed at least 1,000 hours of service and be employed on the last day of the Plan Year. Employees who become retired, disabled, or deceased during the Plan Year are also eligible to receive the contribution. For the year ended December 31, 2024, the Plan Sponsor authorized nonelective contributions of \$786,527.

Participant Accounts

Each participant's account is credited or charged with the above contributions, rollover contributions, Plan earnings thereon, and an allocation of Plan expenses.

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions and the employer contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, money market funds, a collective trust fund and a self-directed brokerage account as investment options for participants.

Vesting

Participant vesting is based on service years. A year of service is defined as at least 1,000 hours worked during a Plan Year. Participants are 100% vested in the voluntary salary deferrals, safe harbor matching and rollover contributions. The discretionary non-elective contributions vest according to the following schedule:

Years of Service	Vested Percentage
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Forfeited Accounts

Forfeitures of non-vested contributions will be used to reduce future employer contributions or to pay Plan expenses. During the year ended December 31, 2024, forfeitures of \$6,528 were used to fund employer contributions. Unallocated forfeitures at December 31, 2024 and 2023, were \$29,218 and \$6,528, respectively.

Payment of Benefits

Participants become eligible for benefit payments upon retirement, termination of employment, disability or death. Additionally, the Plan provides for in-service distributions after a participant has reached age 60 up to their fully vested account balance. Participants may also receive distributions from the employee deferral or rollover balance for qualified financial hardships. Distributions may be made as a single lump-sum payment or installments over a period of not more than the participants' assumed life expectancy (or the assumed life expectancies of the participant and their beneficiary). Vested account balances that do not exceed \$5,000 may only be distributed in a single lump-sum payment. Rollovers are not included when determining whether a cash-out distribution may be paid to a terminated participant. If a participant has terminated employment, he or she must begin receiving benefits no later than April 1 of the calendar year following the year in which he or she reaches age 73.

Amendments

Effective January 1, 2025, the Plan was amended to include an Automatic Contribution Arrangement provision for all newly-eligible employees.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in interest and dividends. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan are allocated to the participants' accounts and are included in administrative expenses. Certain withdrawal expenses are paid for by the affected participant. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE C - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at fair value of \$57,374,399 and \$47,728,016 held at December 31, 2024 and 2023, respectively, net appreciation in fair value of investments of \$6,368,850, and interest and dividends of \$1,798,394 for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the Custodian of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below.

Level 1: Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodologies include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at the daily closing price as reported by the fund.

Mutual funds: Valued at the daily closing price reported on the active market on which the individual securities are traded.

Collective trust fund: Valued based on the NAV of units of the collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Self-directed brokerage accounts: Valued based on the underlying interest-bearing cash, mutual funds and common stocks as traded on the active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's administrative expenses result from services rendered by parties-in-interest.

NOTE F - INCOME TAX STATUS

The Company has adopted The Retirement Plan Company, LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan which has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype Plan Document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with the IRC. Therefore, no income taxes have been provided for in the financial statements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, participants will become one hundred percent (100%) vested in their accounts.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - NONEXEMPT TRANSACTIONS

During 2023, the Company inadvertently failed to deposit \$982 of participant deferral contributions to the Plan within the required time period described in 29 CFR 2510.3-102, as stated by the United States Department of Labor regulations. During 2024, the Company discovered this error and transmitted to the Plan the delinquent participant contributions and amounts representing lost earnings to the participants.

NOTE J - SUBSEQUENT EVENTS

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
