Opinion

NOTE A – DESCRIPTION OF PLAN

The following description of the Westminster Services, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan which covers substantially all employees of Westminster Services, Inc. (the Organization/Employer) and those employees of certain of its affiliates who have attained twenty-one years of age and are employed for a 12 consecutive month period during which they complete at least 1,000 hours of service as an employee. Ordained pastors who are employees of Westminster Services, Inc. and certain of its affiliates have elected to continue to participate in a denominational plan and are not included in the Plan. The original effective date of the Plan was March 1, 1994. The amended provisions of the Plan became effective on February 1, 2023. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The employer contributes to the Plan a percentage of the participants’ qualified compensation as determined annually by the Board of Directors of Westminster Services, Inc. The Plan does not provide for participant contributions. For the year ended December 31, 2024, a contribution of approximately 1.0% of participants’ qualified compensation was contributed to the Plan.

Participant Accounts

The Plan permits participants to direct their account balances among various investment options in the form of mutual funds and a fixed income investment contract. Each participant’s account is credited with the employer’s contribution and an allocation of the Plan’s earnings. Participants may change their investment options periodically. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants do not contribute to the Plan, therefore, immediate vesting is not allowed to their account. Vesting in the Organization’s contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after two years of service and vest 20% per year thereafter, until becoming fully vested after six years of service.

Participant Loans

Participants may borrow from their accounts up to the lesser of \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans during the one year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date that the loan is made, or 50% of their vested account balance. The term of the loan is limited to five years. The loans are secured by the balance in the participant’s account and bear interest at a rate of 3.00%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through biweekly payroll deductions. The minimum loan amount is \$1,000.

Payment of Benefits

Participants are eligible to receive the vested portion of their Plan account upon retirement, termination of employment, disability or death. Payment may be made in a lump-sum.

Forfeitures

The nonvested portion of a participant's account is forfeited as of the earlier of: (a) termination of employment, or (b) the date the participant incurs five consecutive vesting breaks in service, as defined in the Plan document. Forfeitures are used to pay plan expenses or to reduce employer contributions. During the year ended December 31, 2024, \$56,845 of non-vested accounts was forfeited; \$55,143 of forfeited plan assets was used to reduce employer contributions. As of December 31, 2024 and 2023, \$58,954 and \$71,932 of forfeited Plan assets were unallocated, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Administrative expenses of the plan are allocated to participant accounts.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are quoted prices (unadjusted) in active markets of identical assets or liabilities that the Plan can access at the measurement date.
Level 2	Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs that are unobservable inputs for the asset or liability.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Income Investment Contract: The Principal Guaranteed Option (PGO) is a guaranteed general-account backed group annuity contract issued by Principal Life Insurance Company to Principal Trust Company as custodian. A composite crediting rate contractually guaranteed by Principal Life Insurance Company is credited to participant account balances. Participants can generally transfer assets into or out of the contract without early termination or surrender charges.

NOTE D – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal. Principal is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administration fees were paid to Principal during the years ended December 31, 2024 and 2023 by both the Plan and the Organization.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE E – PLAN TERMINATION

On July 24, 2025, Westminster Services, Inc. Retirement Plan merged into Westminster Services, Inc. 403(b) Retirement Plan. At this date, participants became 100% vested in their accounts.

NOTE F – FEDERAL INCOME TAX STATUS

The Internal Revenue Service has informed the Organization by an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

NOTE F – FEDERAL INCOME TAX STATUS – CONTINUED

Accounting principles generally accepted in the United States of America require plan management to evaluate tax provision taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examination for years prior to 2021.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company.
