1. DESCRIPTION OF PLAN

The following description of the Darling Consulting Group 401(K) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering all full-time employees as defined by the Plan agreement of Darling Consulting Group, Inc. (the Plan Sponsor) and are twenty-one years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

B. Contributions

Each year, participants may contribute up to the maximum allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate at 3 percent of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Participants may change their investment deferral options twice a year in January and July and their investment account options daily.

The Plan Sponsor elected to make a safe harbor matching contribution in 2024 in accordance with statutory requirements. Participants are entitled to receive safe harbor matching contributions equal to 4% of each participant's deferred compensation. During the year ended December 31, 2024, the Plan Sponsor made safe harbor matching contributions of \$854,861.

The Plan Sponsor may also, at its discretion, make discretionary matching and profit-sharing contributions, as defined in the Plan agreement. During the year ended December 31, 2024, the Plan Sponsor made profit-sharing contributions of \$448,648.

C. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contributions, (b) Plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN (CONT.)

D. Vesting

Participants are vested immediately in their employee contributions and the Plan Sponsor's safe harbor matching contributions plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary contributions and actual earnings thereon is based on years of credited service. A participant is 100% vested after three years of credited service.

E. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator at the time the loan application is submitted. At December 31, 2024 and 2023, the interest rates on outstanding notes receivable ranged from 4.25% and 9.50%. Principal and interest is paid ratably through monthly payroll deductions.

F. Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

G. Hardship Withdrawals

Hardship withdrawals may be allowed in the case of heavy and immediate financial need that cannot be satisfied by other sources. Such withdrawals may be granted upon receipt of documented evidence. During the year ended December 31, 2024, hardship withdrawals amounted to \$1,566.

H. Forfeited Accounts

Forfeitures of employer contributions can be used to pay Plan expenses or are applied to reduce subsequent employer matching contributions. In 2024, there were no forfeitures. The balance in the forfeiture account as of December 31, 2024 and 2023 totaled \$10,765 and \$10,417, respectively.

I. Administration Expenses

The Plan Sponsor provided certain administrative and accounting services to the Plan at no cost. Any expenses not paid by the Sponsor shall be paid by the trustees out of the principal or income of the Plan. During the year ended December 31, 2024, expenses paid by the trustees out of the principal or income of the Plan were \$168,984.

In addition, the Plan Administrator can elect, on a quarterly basis, to make a disbursement from the account for necessary and reasonable plan-related expenses. Included in administration expenses related to this addendum was \$31,500 in Plan audit fees during the year ended December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis, which is a comprehensive basis of accounting other than generally accepted accounting principles. Consequently, investment income is recognized when received and disbursements are recognized when made. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with generally accepted accounting principles.

B. Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of Plan assets and changes therein at the date of the financial statements. The most significant estimate affecting the financial statements is the fair value of investments (Note 3). Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value.) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received by the Plan. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Participants pay principal and interest through payroll deductions each pay period. Interest income is recognized by the Plan when it is received.

If a participant fails to make scheduled repayments and does not cure the delinquency within the required time period, the loan is treated as a deemed distribution in accordance with Internal Revenue Code requirements and is removed from the Plan's loan balance.

Loan origination and administrative fees related to participant loans are directly charged to the individual participant's account and do not affect the Plan's net assets. The Plan does not capitalize or defer any fees or costs associated with participant loans. Accordingly, there is no amortization of deferred loan fees or costs in the Plan's financial statements.

E. Payment of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under this framework are described as follows:

Level 1 Inputs to the valuation methodology are quoted prices (unadjusted) in active markets or identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds managed by State Street and Transamerica. State Street is the custodian of the Plan assets and Transamerica is the Plan recordkeeper, and therefore, these are transactions that qualify as party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. TAX STATUS

The Internal Revenue Service has determined and informed the Custodian by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

The provisions of Accounting for Uncertainty in Income Taxes require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
