Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Company Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Company Savings Plan (the Plan) provides only general information. Participants should refer to the *Plan document* for a more complete description of the Plan's provisions, which is available from Plan management.

General

The Plan is a defined contribution plan sponsored by Buc-ee's, Ltd. (the Company) to provide employees with the opportunity to save for retirement on a tax-advantaged basis. All employees who have attained the age of 21 and have completed at least 1,000 hours of service in the employee's initial 12 months of employment are eligible to participate in the Plan. The entry date is the first day of the month that coincides with or follows the date eligibility requirements are satisfied.

The Plan was formed on July 1, 2018 and covers individuals who are employed by the Company, as well as participating employers who have adopted the provisions of the Plan: Buc-ee's Alabama, LLC; Chase Construction, Inc.; La Salle County Outfitters, LLC; and R.B. Stewart Petroleum Products, Inc. The Plan was amended on May 31, 2019 to add Buc-ee's Georgia, LLC; Buc-ee's Ennis, LLC; Buc-ee's Alabama II, LLC; Buc-ee's Florida, LLC; Buc-ee's North Carolina, LLC; Buc-ee's South Carolina, LLC; and Buc-ee's Tennessee, LLC as adopting employers. The Plan was amended on January 1, 2022 to add Buc-ee's Tennessee II, LLC, Buc-ee's Johnstown, LLC, and Buc-ee's Springfield, LLC as adopting employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Vice President is responsible for oversight of the Plan. The 401(k) Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Vice President.

Contributions

Participants may elect to reduce their compensation by a specific percentage or dollar amount up to 75 percent of their eligible compensation and have that amount contributed to the Plan as an elective deferral. There are two types of contributions: pre-tax elective deferrals and Roth elective deferrals. Total elective deferrals in any taxable year may not exceed a dollar amount that is set by law. For any calendar year in which participants are age 50 or older, participants can also make additional catch-up elective deferrals in excess of the annual dollar limit on elective deferrals. Participants may modify or revoke their salary deferrals at any time.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2022, the Company will make a safe harbor matching contribution to the Plan that is equal to the sum of 100 percent of an eligible participant's elective deferrals that do not exceed six percent of their compensation for the allocation period.

The matching Company contribution is invested as directed by the participant. By making the safe harbor matching contribution, the Plan will automatically satisfy the nondiscrimination requirements that otherwise would apply to 401(k) contributions made by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, rollovers, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals, rollover contributions, Company safe harbor matching contributions and any earnings thereon.

Payment of Benefits

Upon termination of employment, participants may take a payout of the vested portion of their account balance. Distributions from the Plan will be made in a lump-sum, partial payments, or installment payments. If the vested account balance at the time of termination does not exceed \$1,000, the participant must take it out of the Plan or the Company will distribute the participant's account as a lump - sum. If the vested account balance is between \$1,000 and \$5,000, the participant must take the vested account balance from the Plan or the Company will roll it over to an IRA. If the vested account balance exceeds \$5,000, the participant is not required to take a distribution from the Plan until the required minimum distribution rules apply.

Participants are entitled to receive an in-service distribution. Generally, a participant may receive a distribution from the Plan prior to termination upon attaining age 59½. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Forfeited Accounts

If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. The Company may use forfeitures to pay Plan expenses or reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,338 and \$0, respectively. During 2024 and 2023, Company contributions were reduced by \$5,740 and \$1,169 respectively from forfeited non-vested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires the Company to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the record keeper and trustee for the Plan and, therefore, these transactions qualify as party in interest transactions. Certain administrative fees related to the administration of the Plan were repaid by the Plan or by the Company. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transactions rules under ERISA.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

Note 7. Tax Status

Effective July 1, 2018, the Plan adopted a non-standardized prototype defined contribution profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated September 21, 2020. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
