### *Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Humane Society of Missouri 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of the Humane Society of Missouri 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a 403(b) defined contribution plan established by the Humane Society of Missouri (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Teachers Insurance and Annuity Association - College Retirement Equities Fund (TIAA-CREF) is the issuer of investment assets and Plan recordkeeper.

#### **Eligibility**

Substantially all employees of the Employer are eligible to make elective deferrals to the Plan immediately upon hire and are eligible to receive discretionary Employer matching contributions upon completing two years of service with the Employer and attaining 20-1/2 years of age, should the employer elect to reinstate discretionary contributions. Once the service requirements are met, participants are eligible to receive discretionary matching contributions from the Employer on the first day following each quarter end.

#### **Contributions**

Participants may defer a portion of their annual compensation, as defined by the Plan Document, subject to certain limitations. Participants who attain age 50 during the Plan year or have completed 15 years of service, may elect to make catch-up contributions, subject to certain limitations. Participants may also make rollover contributions representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for discretionary matching contributions that are determined by the Employer from year to year. There were no Employer matching contributions during 2024 or 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Employer matching contributions and an allocation of the Plan's earnings. The allocation of earnings is determined by the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Notes Receivable From Participants**

A participant may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's vested account balance and bear interest at a reasonable rate of interest. Loans are for a period not to exceed five years, unless used to purchase a primary residence. Loans are repaid through direct withdrawal through participant bank accounts. There were two participant loans outstanding at December 31, 2024 and one participant loan outstanding at December 31, 2023.

#### **Plan Loans**

Participants are also allowed to take loans directly from TIAA-CREF. These loans require collateral of 110% of the outstanding loan balance in case of default. Participant account balances held as collateral for loans at December 31, 2024 and 2023 amounted to \$6,972 and \$7,491, respectively, and are included in the guaranteed investment contracts balance on the statement of net assets available for benefits. Loans considered in default at December 31, 2024 and 2023 amounted to \$6,972 and \$6,663 respectively. The collateral amounts held on defaulted loans are not payable to TIAA-CREF until a distributable event has occurred.

Effective September 2021, the Plan was amended to require that all new loans be funded directly through participant retirement accounts and will no longer be allowed to be taken directly from TIAA-CREF.

#### **Vesting**

All contributions and earnings thereon are fully vested and nonforfeitable at all times.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct elective contributions and Employer contributions in a variety of investment options. The investment options consist of guaranteed investment accounts, variable annuity contracts, variable annuity accounts, and a pooled separate account.

#### **Benefit Payments**

Amounts in a participant's account and earnings thereon are distributed upon retirement, death, disability, or other termination of employment. In-service withdrawals are allowed at age 59 1/2. Benefit payments in excess of \$1,000 may be distributed as a lump-sum, partial payments, by purchase of annuity contracts, or a series of equal payments over a period of time until fully distributed. Benefit payments of \$1,000 or less may only be distributed as a lump-sum.

#### **Administrative Expenses**

The Employer pays substantially all of the administrative expenses of the Plan. Each participant will pay certain Plan expenses based on the percentage of assets held in their investment accounts. The expenses are netted against earnings and are included in investment income on the statement of changes in net assets available for benefits.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

Investments other than fully benefit-responsive investment contracts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the TIAA fixed income guaranteed option is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at the unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan Document.

#### **Payment Of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

### **3. Certified Investment Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by TIAA-CREF, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from TIAA-CREF that the information provided to the Plan Administrator related to the following information is complete and accurate.

#### 4. Fair Value Measurements

The Plan utilizes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

#### **Guaranteed Investment Contracts**

Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, management evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through utilizing discount rates applied.

#### **Variable Annuity Accounts**

Valued at the daily closing price as reported by College Retirement Equities Fund (CREF). CREF Accounts held by the Plan publish their daily net asset value (NAV), transact at that price and are deemed to be actively traded.

#### **Variable Annuity Contracts**

Valued at NAV based on the value of the underlying assets. The NAV, as provided by TIAA-CREF, is used as a practical expedient to estimate fair value. The underlying assets consist primarily of mutual funds, equity securities, fixed income instruments and short-term investments, which are valued based on market quotations or prices obtained from independent pricing sources that may include various pricing methods to value the investments, including matrix pricing.

#### **Pooled Separate Account**

Valued at the NAV of units held by the Plan at year end. The NAV, as provided by TIAA-CREF, is used as a practical expedient to estimate fair value. The account is primarily invested in real estate properties that are valued based on third-party appraisals. Due to the nature of the investment, changes in the market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of the pooled separate account and, consequently, the fair value of the Plan's investments.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Income Tax Status**

The Plan Sponsor adopted a 403(b) volume submitter prototype plan provided by the Plan's recordkeeper. The prototype plan received a favorable opinion letter dated August 7, 2017, from the IRS that the prototype plan is designed in accordance with the applicable sections of the IRC. The Plan Administrator has determined it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The prototype plan and the Plan have been amended since the date of the opinion letter. However, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirement of the IRC and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan at any time, subject to the provisions of ERISA. Upon termination, participants would remain 100% vested in their accounts.

#### **7. Party In Interest Transactions**

The Plan's investments are managed by TIAA-CREF. Certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as allowable party in interest transactions.

**8. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
