Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Gerber Collision & Glass 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of Gerber Collision & Glass 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) savings plan maintained on a 12-month plan year, which begins on January 1 and ends on December 31 (the "Plan Year"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

All employees of The Boyd Group (U.S.), Inc. and its participating employers (collectively, the "Company"), excluding employees covered by a collective bargaining agreement unless the collective bargaining agreement provides otherwise, nonresident aliens, employees of an affiliate that is not a participating employer, leased employees, and employees who are members of International Union Painters and Allied Trades District Council 91, are eligible to participate in the Plan after attainment of 20 years of age and completion of three months of service. Eligible employees may enroll in the Plan on the first day of the month after the eligibility requirements are met.

Contributions

The Plan provides for employee salary 401(k) contributions up to the maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their compensation on a pretax or Roth 401(k) basis. Participants who have attained age 50 before the end of the Plan Year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Employer matching contributions are determined at the discretion of the Company each Plan Year. During 2024, the employer matching contribution amounted to 50 percent of the participants' deferral contributions, limited to 6 percent of an eligible participant's compensation with a maximum employer matching contribution of \$3,500 each Plan Year.

The Company may also make a discretionary nonelective profit-sharing contribution for participants who are employed as of the last day of the Plan Year and have completed at least 1,000 actual hours of service during the Plan Year. The discretionary nonelective profit-sharing contribution is allocated based on a ratio of each participant's compensation to the total compensation paid to all participants for the Plan Year. There were no discretionary nonelective contributions in 2024.

Certain participant deferral contributions and notes receivable repayment amounts in 2023 were remitted to the Plan after the time frame required by the Department of Labor. The Company remitted the affected deferral contribution and notes receivable repayment amounts to the Plan in 2023 and calculated and remitted associated lost earnings to the Plan in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

December 31, 2024 and 2023

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Participants are also fully vested if employed with the Company upon reaching normal retirement age (age 59½) or due to death or permanent disability. Vesting in the Company's contributions, plus actual earnings thereon, is based on years of service. Participants are vested in the Company's contributions as follows: less than two years of service: 0 percent; two years of service but less than three years of service: 20 percent; and three years of service or more: 100 percent. A participant will be credited with a year of service for vesting purposes if the participant completes at least 1,000 actual hours of service during the Plan Year.

Forfeitures

If a participant terminates employment prior to becoming 100 percent vested in the employer matching and profit-sharing contributions and receives a distribution of the vested portion of the account, the nonvested portion will be forfeited. However, if a participant resumes employment with the Company within five years after termination, the forfeited amount will be restored to the participant's account provided the participant repays the amount previously distributed within five years of resuming employment. Forfeitures are first used to pay for plan expenses and then used to reduce employer matching contributions for the Plan Year in which the forfeiture occurs. Any remaining forfeitures will be allocated to participants of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$649,271 and \$204,776, respectively.

Benefit Payments

Upon retirement, termination of service, financial hardship, certain military service described in the plan document, disability, or the attainment of age 59½, a participant may receive all or part of the vested interest in his or her account as a lump-sum distribution. Rollover contributions may be requested at any time.

Benefit payments are generally paid in a lump-sum payment as soon as practicable after employment with the Company has ended. Participants may elect to defer commencement of distributions until April 1 of the calendar year after they attain the age of 72. Until such time as the funds are distributed, the participant is entitled to receive a pro rata share of fund earnings. Benefits may also be paid to an eligible participant as an eligible rollover distribution.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Repayment of notes receivable shall be determined by mutual agreement, but in no event will the term exceed 5 years unless the loan is used to purchase a principal residence, and then the term will not exceed 30 years. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 3.25 to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) or its affiliates. Principal is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 1 - Plan Description (Continued)

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value except as noted below.

Mutual funds are valued based on quoted market prices.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on this investment.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

See Note 4 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. As of December 31, 2024 and 2023, the Plan recorded a liability of \$150,918 and \$234,208, respectively, for excess contributions payable. The Plan distributed 2024 excess contributions in 2025 and 2023 excess contributions in 2024.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 29, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal Trust Company.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Tax Status

The Plan, as adopted, is an Internal Revenue Service (IRS) preapproved plan, which does not require an application for a determination letter from the IRS. The preapproved plan has received a favorable opinion letter dated June 30, 2020 from the IRS indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 6 - Investment Contracts

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting, but may not be less than 1.55 percent. When establishing interest crediting rates for this product, Principal Life Insurance Company considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable.
