**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of Delta Dental of Illinois Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

**Opinion**

### **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

#### **NOTE A - PLAN DESCRIPTION**

The following brief description of the Delta Dental of Illinois Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

##### ***General***

The Plan is a defined contribution plan maintained on a calendar-year basis. The Plan was established by Delta Dental of Illinois (the Employer or Company) on January 1, 1997, and covers all employees of the Company, except for those who are governed by a collective bargaining agreement, non-resident aliens, or those classified as leased employees or independent contractors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

##### ***Eligibility***

Any employee who is 18 years of age or older is eligible to enter the Plan on the first day of the month following the date of hire. In order to be eligible for the Company's discretionary profit-sharing contribution, the employee must be employed on the last day of the Plan year for which the contribution is being made, unless their termination during the year was due to death, disability or normal retirement.

##### ***Contributions***

The Plan provides for employee salary 401(k) contributions up to the maximum tax-deferred limitations established by the Internal Revenue Code (IRC). Participants may also make Roth 401(k) deferral contributions and contributions to the Plan in the form of a rollover of funds from another qualified plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

New employees are automatically enrolled in the Plan at 5%, unless an employee elects otherwise. In addition, a participant's elective deferral contribution shall be increased by 1% annually up to a maximum of 8%, unless a participant elects otherwise.

The Plan provides for safe harbor Company matching contributions equal to 100% of participant contributions up to 5% of eligible compensation for each participant. The Plan also provides for Company discretionary profit sharing contributions.

The Company elected to make a discretionary profit-sharing contribution of \$285,437 and \$404,962, net of forfeitures, for the 2024 and 2023 Plan years, respectively.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's matching contribution, the Company's profit-sharing contribution, allocation of the Plan's earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

##### ***Vesting***

Participants are always 100% vested in their 401(k) deferral, Company matching contributions, voluntary after-tax and rollover accounts, and earnings thereon. Participants otherwise vest in their Company

discretionary profit sharing contribution at 33% for each year of service until becoming fully vested upon completion of three years of service.

***Forfeitures***

If a participant is not fully vested on their termination date, the nonvested amount of their account is forfeited. Forfeitures are used to reduce future Company contributions or to pay administrative expenses of the Plan. There was \$2 and \$396 in unused forfeitures at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$15,672 of forfeitures were used to reduce Company contributions.

***Benefit Payments***

A participant or beneficiary is entitled to receive, as benefits, the vested balance in their accounts in the form of a lump-sum payment, periodic installments, a joint and survivor annuity, or some other form of annuity. Benefits may also be paid directly to an eligible retirement plan as an eligible rollover distribution. In addition, hardship withdrawals are permitted in certain situations, as described in the Plan agreement. Participants may elect to defer commencement of distributions until they attain the age of 72. Vested balances under \$5,000 are automatically distributed upon termination.

***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. Participants may only have one loan outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at a market rate as determined by the loan administrator. The interest rate and loan term are fixed at the inception of each loan based on the requirements of the Plan agreement with loan terms not to exceed five years unless the loan is used for the purchase of a primary residence. Principal and interest are paid ratably through monthly payroll deductions.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for further discussion of fair value measurements.

The Plan's fully benefit-responsive guaranteed investment contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include gains and losses on investments bought and sold, as well as held, during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as benefit payments based upon the terms of the Plan.

***Payment of Benefits***

Benefits paid to participants are recorded when paid.

***Administrative Expenses***

Third party expenses associated with the administration of the Plan are charged to the participants' accounts and paid to the Plan's recordkeeper, to the extent not paid by the Company. Certain investment related expenses are deducted from net appreciation in fair value of investments presented in the accompanying statement of change in net assets available for benefits.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE C - FAIR VALUE MEASUREMENTS**

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for instruments measured at fair value and their classification in the valuation hierarchy as of December 31. There have been no changes in valuation methodologies with the exception of collective trust funds.

***Mutual Funds***

Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end, which is obtained on an active market.

***Collective Trust Funds***

Collective trust funds are valued based on the fair value of the collective trusts' underlying investments. The NAV, as provided by Principal Trust Company (Principal Trust), which is obtained on an active market.

***Pooled Separate Accounts***

Pooled separate accounts are valued at NAV per share or its equivalent, based on the fair value of the funds' underlying assets and liabilities. The NAV, as provided by Principal Life Insurance Company (Principal Life), is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - GUARANTEED INVESTMENT CONTRACT**

The Plan has entered into a fully benefit-responsive investment contract issued by Principal Life. Principal Life maintains the Plan's contributions in a general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement for that portion of net assets available for plan benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision; (iii) bankruptcy of the Plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) which cause a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that the occurrence of any such events which would limit the Plan's ability to transact at contract value with participants are not probable of occurring. There are no events that allow the issuer to terminate the contract and which require the Plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

**NOTE E - INFORMATION CERTIFIED BY CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust as previously defined) and Principal Life Insurance Company (Principal Life as previous defined) have certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments at fair value, notes receivable from participants and the fully benefit-responsive investment contract, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by affiliates of the Custodians and, therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants are considered party-in-interest transactions.

Certain administrative expenses are paid directly by the Company.

**NOTE G - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE H - TAX STATUS**

The Company is a participating employer in the Principal Trust Company Directed Trust Prototype Plan approved by the Internal Revenue Service (IRS). The prototype plan obtained its latest approval letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was qualified under Section 401 (a) of the IRC. The Plan has been amended since receiving the opinion letter. The Company believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC in all material respects.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
