We have performed audits of the financial statements of Otter Products, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### 1. Plan Description

#### *General*

The following description of the Otter Products, LLC 401(k) Plan (the Plan), as amended, provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan was established and adopted by Otter Products, LLC (the Company), effective January 1, 2014. The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee and Administration of the Plan*

The trustee of the Plan is Charles Schwab Trust Company (Trustee). The Trustee holds all assets of the Plan in accordance with the Service Agreements with the Company. The recordkeeper of the Plan is Schwab Retirement Services, Inc. (Schwab). The Compensation Committee of the Company determines the appropriateness of the investment offerings and monitors investment performance.

#### *Eligibility*

Each employee is eligible to participate in the Plan after one month of employment with at least one hour of service and attainment of age 18. Entry dates are the first day of each month after meeting the eligibility requirements. Leased, contract employees, and non-resident aliens are not eligible to participate in the Plan.

Prior to April 1, 2024, interns and other part-time employee were eligible to participate in the Plan after completion of a year of service in which the employee is credited with 1,000 hours. Effective April 1, 2024, these employees were eligible after one month of employment.

#### *Contributions*

Eligible participants can contribute to the Plan on a pre-tax or after-tax (Roth) basis up to 100% of their qualifying annual compensation, subject to certain IRC limitations. The Plan also allows catch-up contributions for participants age 50 and over based on IRC limitations. Participants can terminate or change their salary deferral agreements according to procedures and limitations as determined by the Plan Document.

The Company contributes a Safe Harbor matching contribution of 100% of the first 4% of eligible compensation contributed to the Plan. The Company can make an additional discretionary employer matching contribution or discretionary non-elective employer contribution. Employees must be employed on the last day of the plan year in order to receive the discretionary non-elective contribution. The Company did not elect to make an additional discretionary employer matching or discretionary non-elective employer contribution for the year ended December 31, 2024.

Rollover contributions to the Plan can also be made from other qualified plans if certain criteria are met.

### ***Participants' Accounts***

Participants' accounts are credited with participant salary deferral (pre-tax, catch-up, and Roth) contributions, rollover contributions, Safe Harbor matching contributions, additional discretionary employer matching and non-elective contributions, and an allocation of plan earnings or losses. Participants can direct the investment of their account balances into various investment options offered by the Plan. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are 100% vested in their employee salary deferral contributions, rollover contributions, and Safe Harbor matching contributions and the allocated earnings thereon. Additional discretionary employer matching contributions and discretionary non-elective employer contributions vest at 33% per year after year one, becoming fully vested after three years. Prior service credit for vesting service is applied for certain companies as further described in the Plan Document. Participants become fully vested upon death, disability (as defined), reaching normal retirement age, or termination of the Plan.

### ***Forfeitures***

Forfeitures can be used to pay administrative expenses or offset employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts were de minimis. During the year ended December 31, 2024, no forfeitures were used to offset employer contributions and none were used to pay plan expenses.

### ***Payment of Benefits***

Upon termination or separation of service; death; attainment of normal retirement age (age 65); or disability, as defined, participants can elect to receive their benefit payment in the form of a lump-sum amount equal to the vested portion of the participant's account, a partial withdrawal, or remain in the Plan if their vested account balance had a minimum of \$5,000. A participant can also roll over the amount to another qualified retirement plan or individual retirement account. Balances less than \$5,000 are subject to mandatory distribution as further described in the Plan Document. Hardship withdrawals and certain other in-service withdrawals at age 59½ are also allowed by the Plan if certain criteria are met. Effective July 1, 2024, the Plan added in-service distributions due to domestic violence, as permitted in SECURE 2.0.

### ***Notes Receivable from Participants***

An employee may borrow a minimum of \$1,000 up to the lesser of \$50,000 or one-half of their vested account balance. Participants may not have more than two notes outstanding at any time. The note term ranges from 12 to 60 months, unless it is for a principal residence and then the term ranges from 12 to 120 months. The notes are secured by the participant's account balance and bear interest at prime plus 1%. Interest is fixed for the term of the note. A participant's note shall immediately become due and payable if such participant terminates employment for any reason or fails to make a principal and/or interest payment as provided in the note agreement. The note is considered to

be defaulted if it is not made current by the end of the quarter following the quarter when the missed payment was due. Principal and interest are paid ratably through regular payroll deductions.

### *Expenses of the Plan*

Administrative expenses of the Plan are paid by the Company, through the Plan, through the use of forfeitures, or paid from participant accounts. Expenses paid by the Plan include loan origination and maintenance fees, distribution fees, legal fees, and Plan administration and investment advisory fees. These totaled \$66,352 for the year ended December 31, 2024. Certain investment fees (in the form of an expense ratio) may also be netted with investment earnings or losses of the registered investment companies. All other expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements.

### *Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the terms of the Plan Document to terminate the Plan, subject to the provisions of ERISA. Upon termination of the Plan, participants would be fully vested.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments in mutual funds, including a money market mutual fund, and collective investment trusts are stated at fair value as further discussed in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Compensation Committee of the Company determines the Plan's valuation policies utilizing information provided by the investment advisor, and Trustee.

Interest income is recorded as earned on the accrual basis. Dividend income (and capital gains) is recorded on the ex-dividend date. Purchases and sales are recorded on a trade-date basis. The net appreciation (depreciation) in the fair value of investments represents the realized and unrealized gains and losses on the investments and capital gains reinvested.

### ***Contributions***

Participant contributions and related Safe Harbor matching contributions are recognized in the period during which the Company made the respective payroll deduction from the participant's compensation.

### ***Payment of Benefits***

Benefit payments are recorded when paid to participants. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid as of year-end.

### ***Notes Receivable from Participants***

Notes receivable from participants are recorded at their unpaid principal balance plus accrued and unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

## **3. Fair Value Measurements and Disclosures**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs are the highest priority and consist of unadjusted quoted prices in active markets for identical assets and liabilities. Level 2 inputs are inputs for quoted prices for similar assets or liabilities in active markets; inputs for quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are the lowest priority and are unobservable and significant to the fair value measurement of an asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds and Money Market Mutual Fund* - These assets are valued at the daily closing price as reported by the mutual fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trusts* - The collective investment trusts are valued at the net asset value of the units of the trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell

the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. These investments are direct filing entities.

Furthermore, although the Company believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Administrative fees were paid to the Trustee, recordkeeper, investment advisor, legal counsel, and third-party administrators during the year ended December 31, 2024. The Plan also issues loans to participants which are secured by the vested balance of the participant's accounts. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 6. Risks and Uncertainties

The Plan invests in various investment securities. Investments, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risk. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 7. Income Tax Status

The Plan adopted a pre-approved profit sharing plan document for which an opinion letter was obtained from the Internal Revenue Service (IRS) dated September 21, 2020, indicating the plan document was designed in accordance with applicable sections of the IRC. The Plan has been amended since the adoption; however, the Company and plan administrator believe the Plan is being operated in compliance with the applicable requirements of the IRC and the Plan and related trust is tax-exempt. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Subsequent Events

The Company has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements.
