DECEMBER 31, 2024

NOTE 1 - DESCRIPTION OF PLAN

The following description of the inMarket Media LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution plan covering employees of inMarket Media LLC (the Company) who have attained age twenty-one. There are no service requirements to be eligible for participation in the Plan. Union employees, leased employees, and non-resident aliens who do not receive any earned income from the Employer are not eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100% of their annual compensation up to the maximum allowable limits of Code Section 401(k). The Company also has the option to make a discretionary employer matching contribution based on an annual election. For the plan year ended December 31, 2024, the Company matched 50% of each participant's contributions up to the first 4% of eligible compensation.

Participant Accounts

Each participant's self-directed 401(k) account is credited with the participant's contributions and earnings on the participant's contributions, and is charged with plan expenses. Each participant has a separate self-directed 401(k) account for employer matching contributions, which consists of the Company's contributions and earnings on the Company's contributions, and which is charged with plan expenses.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company discretionary contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited service.

Description of Investment Options

The Plan's assets are held in a trust administered by Fidelity Management Trust Company. Participants may elect to have their account contributions invested in one or a combination of investment options provided by the Plan. The investment options consist of various mutual funds and a money market fund as selected by the Plan Administrator.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

The Plan contains provisions which allow for loans to participants, subject to certain restrictions. The maximum loan amount is the lesser of one half of the vested balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12 month period. Up to 50 percent of the vested balance may be used as collateral for the loan. These loans, which have a maximum term of five years (longer, if used to acquire a participant's principal residence), are to be repaid through regular payroll withholdings. The interest rate charged for loans from the Plan is established by the Plan Administrator.

Payment of Benefits and Distributions

Upon termination of service due to death, disability, retirement, or other reasons, a participant is entitled to the value of their vested account balance. Accounts of \$1,000 or less will be distributed to the participant as a lump sum. Accounts over \$1,000 but not exceeding \$5,000 will be rolled into an Individual Retirement Account or Annuity for the participant's benefit. Accounts exceeding \$5,000 may remain in the Plan, be paid directly to the participant, or be rolled over to another IRA or eligible retirement plan. Additionally, the Plan allows in-service withdrawals under certain circumstances. Prior to any distribution, the participant has the right to request the vested balance be distributed directly as a lump sum payment, rolled-over to another IRA provider, or eligible retirement plan.

Administrative Expenses

Certain administrative expenses have been paid by the Company. Administrative expenses paid by the Plan include investment advisory and management fees.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$45,599 and \$109,382, respectively. These forfeitures may be used to pay administrative expenses or reduce employer contributions. During the year ended December 31, 2024, forfeitures of \$116,970 were used to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Administration

The Plan is administered by the Plan Administrator.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and that also affect revenues and expenses during the reporting period. Actual results could differ from those estimates.

Date of Management's Review

For the current reporting period, subsequent events were evaluated through TBD, which represents the date the financial statements were available to be issued.

NOTE 3 - INVESTMENTS

The financial information relating to the Plan's investments is included in the accompanying financial statements based on information provided by the custodian. Fidelity Management Trust Company was the custodian of the Plan's investments at December 31, 2024 and 2023. All investments are participant directed utilizing the investment options provided by the Plan.

For the year ended December 31, 2024, the custodian also certified to the completeness and accuracy of \$2,501,403 of net realized and unrealized appreciation in fair value of investments and \$607,665 in interest and dividends investment income related to the aforementioned investments, as well as \$11,152 in interest income related to the aforementioned notes receivable from participants.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Fair Value Measurements and Disclosure Topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the end of the plan year by obtaining quoted prices on nationally recognized securities exchanges.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - TAX STATUS

The pre-approved plan sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the pre-approved non-standardized plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the restated pre-approved non-standardized plan. The Plan Administrator believes that the Plan is being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and a money market fund managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the custodian of the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan to the custodian are included as a reduction of the return earned on the mutual funds and money market fund.
