## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MacInnis Group, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the MacInnis Group, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of MacInnis Group, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974. The Trustees are responsible for oversight of the Plan, monitoring the Plan's investment offerings, and monitoring investment performance.

**Contributions:** The Plan permits employee salary deferral contributions up to \$23,000 plus any catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a fixed rate fund as investment options for participants. The Company contributes 100% of the first 3% of base compensation that a participant contributes to the Plan. In accordance with the collective bargaining agreements the company also contributes \$1.00 per hour for each hour a union employee works. A discretionary contribution of \$120,924 and \$60,066 was paid for the years ended December 31, 2024 and 2023, respectively.

**Participant Accounts:** Each participant's account is credited with the participant's contribution and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings is based on years of continuous service. A participant is 100% vested after five years of credited service.

**Payment of Benefits:** On termination of service for any reason, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Vested accounts of separated participants included in investment balances as of December 31, 2024 and 2023, were \$735,696 and \$397,918, respectively.

**Loans to Participants:** A participant may borrow a maximum of \$50,000 or 50% of the present value of his or her vested account balance with a minimum loan of \$1,000. Loans are secured by the participant's account and bear a reasonable rate of interest as determined by the Trustees. The loans are subject to certain restrictions, as defined by the Plan document and applicable restrictions under the IRC. A participant may have only one loan outstanding and must be repaid over a period not extending beyond five years. A participant loan will be deemed default if installment payment not paid by the last day of the calendar quarter following the calendar quarter the payment was due.

**Forfeited Accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,413 and \$40,666, respectively. Forfeited accounts will be used to offset administrative expenses of the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the investment advisor and trustees. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the accrual basis. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from employees are recorded as they are withheld from participant wages.

**Excess Contributions Refundable:** Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

**Benefit Payments:** Benefit payments are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant’s account.

**Date of Management’s Review of Subsequent Events:** Subsequent events were evaluated through September 22, 2025, which is the date of financial statement issuance.

**NOTE 4 – TAX STATUS**

The Internal Revenue Service has determined and informed the company by a letter dated January 2015, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

The plan administrator believes the plan is no longer subject to income tax examinations for years prior to 2020.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6 – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

As of December 31, 2024, the Plan held a group annuity contract with Empower Annuity Insurance Company of America. The group annuity contract, Key Guaranteed Portfolio Fund, is a fixed account that is part of the general account of Empower Annuity Insurance Company of America. The methodology for calculating interest credit rate is based on the earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest crediting rate, and prevailing market conditions. Interest crediting rate is reset quarterly. At December 31, 2024 and 2023, the Key Guaranteed Portfolio Fund's fair value equaled its contract value of \$605,511 and \$501,843 respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 7 – FAIR VALUE MEASUREMENTS**

Accounting standards require certain assets and liabilities to be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value. The following tables present information about the Plan's assets measured at fair value on a recurring basis at December 31, 2024 and 2023:

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

*Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

*Level 3*

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances whereby inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Annuities: Valued daily based on the annuity contract, as calculated by the annuity provided.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

The Plan’s policy is to recognize transfers into and out of Level 1 and 3 as of the date of the event or change in circumstances that caused the transfer. There were no transfers into or out of Level 1 and 3.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan maintains a traditional, fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America. Empower Trust Company and Empower Annuity Insurance Company of America also serve as the Plan’s custodian and recordkeeper; PA Retirement Solutions is the third-party administrator; and CBIZ Financial Solutions provides investment advisory services, each considered party-in-interest to the Plan. Fees paid by the Plan totaled \$44,303 for the year ended December 31, 2024.

Party-in-interest transactions also include loans made to participants of the Plan.
