INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the
Vertical Earth 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Vertical Earth 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements December 31, 2024 and 2023

1. Description of Plan

The following description of the Vertical Earth, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

Eligibility

The Plan is a defined contribution plan covering all employees of Vertical Earth, Inc. (the Company) except those employees who are members of a collective bargaining agreement, leased employees, or nonresident aliens. Employees become eligible to participate in the Plan on the first day of each Plan quarter after attaining age 18 and 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each participant may elect to make pre-tax and/or Roth contributions of up to 100% of eligible compensation, as defined in the Plan document, not to exceed \$23,000 in 2024, plus a catch-up contribution of up to \$7,500 for participants age 50 and older. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants are automatically enrolled in the Plan upon meeting eligibility requirements at a rate of 3% of eligible compensation unless they direct otherwise. This automatic contribution rate will increase 1% annually on the first day of the Plan year up to a maximum of 6% unless the participant elects otherwise.

The Company makes safe harbor matching contributions of 100% of participant deferrals for the first 1% of eligible compensation plus 50% of the portion of participants' elective deferrals from 2% to 6% of participants' eligible compensation. In addition, the Company may, at their discretion, authorize an additional discretionary nonelective profit-sharing contribution for participants who have completed 1,000 hours of service and are employed on the last day of the Plan year. There were safe harbor matching contributions and discretionary nonelective profit-sharing contributions, net of forfeitures, during 2024 of \$440,195 and \$484,419 respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, any Company contributions, and earnings and losses on the investments in their account and is charged with transaction fees for services received by the participant and certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings and losses thereon. Participants are fully vested in the Company safe harbor matching contributions after two years of service. For Company discretionary nonelective profit-sharing contributions, participants vest 20% after 1 year of service, then 20% per year thereafter until they are fully vested after 6 years of service.

Forfeitures

Forfeited non-vested accounts were \$0 and \$3 as of December 31, 2024 and 2023, respectively. Forfeitures may be used to pay administrative expenses of the Plan or to reduce future Company contributions. In 2024, \$3 was used to reduce Company contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account balance. Participants may only have one note receivable outstanding at a time. The notes receivable are secured by the balance in the participant's account and bear interest at a reasonable rate, as defined by the Plan document. At December 31, 2024, notes receivable had fixed interest rates ranging from 5.25% to 9.50% for the term of the notes receivable, not to exceed five years, unless used for the purchase of a residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, termination of employment or retirement, a participant or beneficiary may elect to receive a payment of the vested interest in their account in a lump sum distribution. In-service withdrawals are also permitted for participants who have attained age 59½. A participant's account balance between \$1,000 and \$7,000 may be paid as a direct rollover to an individual retirement account established by the Company for the benefit of the participant. Participants are also eligible to receive hardship withdrawals when certain conditions are met.

Administrative Expenses

Administrative expenses paid by participants include distribution fees, loan fees, and other transaction fees. Investment related expenses are paid by participants based on the specific expense ratio for each fund invested in through a direct payment. The Plan document permits certain administrative expenses to be paid by the Plan. Expenses paid by the Plan in 2024 included recordkeeping fees paid to a service provider of the Plan. These expenses paid to the service provider qualify for party-in-interest transactions. The Company pays all other administrative expenses of the Plan. The Company does not expect reimbursement from the Plan for these expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The Company's discretionary nonelective profit-sharing contributions are payable to the Plan after they have been approved by the Company. Any unfunded participant or Company safe harbor matching or discretionary profit-sharing contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current risk associated with the employer contribution receivables. The Company determined that no allowance for credit losses was necessary as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Net change in fair value of investments include realized and unrealized gains and losses, interest and dividends on those investments, and fees charged for investment management services on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan

administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded as a deemed distribution. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and the supplemental schedule of assets (held at end of year), including investments held and notes receivable from participants at December 31, 2024 and 2023, net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal), the Plan's qualified institution.

4. Investments

Plan investments include common/collective trust funds and pooled separate accounts that are managed by Principal. Principal is a service provider to the Plan; therefore, transactions in these securities qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in the net change in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

Investments in pooled separate accounts and common/collective trust funds are valued daily using their net asset value (NAV). The NAVs are based on the fair value of the underlying securities in each investment. Participants can trade pooled separate accounts and common/collective trust funds daily at the published NAV (Level 1).

5. Income Tax Status

The Plan is operating under a prototype plan document offered by ERISA Services, Inc. (ERISA Services). The Internal Revenue Service has determined and informed ERISA Services by a letter dated June 1, 2021, that the prototype is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in the employer matching and discretionary profit-sharing contributions.
