## **INDEPENDENT AUDITORS' REPORT**

To the Participants and the Trustees,

### **Opinion**

We have audited the accompanying financial statements of the Burke, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Burke, Inc. Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## 1. PLAN DESCRIPTION:

The following description of the Burke, Inc. Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

### General

Burke, Inc. (the Company or Employer) established the Plan as of December 28, 2004 and effective January 1, 2004. It is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (the Code), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan purchased Company common shares and holds the stock in a trust fund (the Trust) established under the Plan. At December 31, 2024 and 2023, and for the years then ended, all outstanding shares of common stock were allocated to eligible participants' accounts in accordance with applicable regulations under the Code.

### Administration

The governing body for administration of the Plan is the Burke, Inc. ESOP Administrative Committee and consists of Company employees selected to participate by the Board of Directors of the Company. The trustee of the Plan is Alturas Fiduciary Services.

### Eligibility

Effective January 1, 2021, on-call employees are eligible to participate in the Plan upon reaching age 21 and completing 1,000 hours of service in their first year of service. All other non-excluded employees are eligible to participate in the Plan immediately. Employees covered by a collective bargaining agreement, employees who are non-resident aliens, or leased employees are not eligible.

### Vesting

Company contributions, as adjusted for earnings and losses thereon, vest 100% after three years of service. There is no vesting for less than three years of service.

Participants become 100% vested in all Company contributions immediately upon reaching early retirement age (the earlier of reaching age 60 with 10 years of service or reaching age 55 with 20 years of service) or normal retirement age (the later of attaining age 65 or five years of vesting service), death or total disability. Any forfeited Company contributions are allocated to active Plan participants on the December 31st following five consecutive one-year breaks in service by the forfeiting participant.

### Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are age 55 with at least 10 years of participation in the Plan and are still employed by the Employer may elect to diversify up to 50% of the total allocated shares in their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to

diversify, transfer the cash equivalent of the shares diversified, to the participant's account in the Burke, Inc. Profit Sharing and Pay Deferral Savings Plan.

Participants who are age 50 with at least 5 years of participation in the Plan and are still employed by the Employer, who do not qualify for diversification under the above provisions, may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a five-year period, unless the participant reaches 10 years of participation in the Plan, at which point they become eligible to diversify under the options noted above. In each of the five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. Participants who elect to diversify, transfer the cash equivalent of the shares diversified, to the participant's account in the Burke, Inc. Profit Sharing and Pay Deferral Savings Plan. For the years ended December 31, 2024 and 2023, \$714,088 and \$1,228,912, respectively, were transferred from the Plan to the Burke, Inc. Profit Sharing and Pay Deferral Savings Plan. These balances are included in distributions to participants on the statements of changes in net assets available for benefits.

### **Reshuffling**

The Plan permits the reshuffling of accounts of non-active participants. On an annual basis, following the processing of the diversification elections noted above, the stock accounts for non-active participants, who have reached a five-year break in service, may be reshuffled and replaced with amounts from active participants' other investment accounts of an equivalent value determined as of the last valuation date of the Plan. Following the reshuffling of non-active participants' stock accounts, the other investment account of all non-active participants shall be transferred to the Burke, Inc. Profit Sharing and Pay Deferral Savings Plan.

### **Participant accounts and forfeitures**

Each participant's account is credited with the participant's share of the Company's contributions and forfeitures available as determined by the recordkeeper. The participant's account is allocated the Company contributions and forfeitures based on the proportion of the participant's compensation to the total of all participants' compensation (capped at \$100,000 for 2024 and 2023) for the Plan year. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation of Company contributions for such year. Forfeitures for 2024 and 2023 were not material.

Plan earnings are allocated to each participant's account based on the proportion of the participant's account balance to the aggregate of all participants' account balances prior to the allocation of the contribution and forfeitures described above.

### **Employer contributions**

Upon approval by the Company's board of directors, the Company may make discretionary contributions of cash or stock to the Plan. These discretionary contributions were \$5,085,958 and \$5,054,355 for the years ended December 31, 2024 and 2023, respectively.

### **Distributions**

Distributions from the Plan will be made when a participant retires at early retirement age, normal retirement age of 65 with a minimum five years of service, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or becomes permanently disabled. Participants who otherwise terminate employment with the Company are eligible for distribution of their

ESOP account in the sixth plan year after the year in which the participant terminates employment if their vested participant account balance is greater than \$10,000. If a terminated participant's vested account balance is less than or equal to \$10,000, the account balance may be distributed as soon as administratively practicable during the year following termination. The amount to be distributed is based upon the account valuation date immediately preceding the distribution. Distributions are made in cash or employer stock as determined by the plan administrator.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

### **Voting rights**

The Trustee is responsible for voting all employer stock held as part of the Plan assets. Each participant or beneficiary shall be entitled to direct the Trustee as to the manner in which voting rights on shares of allocated employer stock are to be exercised.

### **Put option**

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants (and is not readily tradable on an established market or is subject to trading limitations) includes a put option. The put option is a right to demand that the Company or the Plan buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company may finance the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### **Plan termination**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the Trust will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Burke, Inc. ESOP Administrative Committee should direct the Trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed common stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loans, if any.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties**

The Plan invests in common stock of the Company. This common stock is exposed to various risks, including a variety of risks associated with investing in an operating entity and the liquidity risk associated with investing in a private company. Due to the level of risk associated with the common stock, it is at least reasonably possible that changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

**Investment valuation and income recognition**

The common shares of the Company are reported at fair value, which is determined by an annual independent appraisal. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. The Plan presents in its statements of changes in net assets available for benefits the net appreciation in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation on those investments.

**Payment of benefits**

Benefits are recorded when paid.

**Administrative fees**

Administrative expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Fees included in the statements of changes in net assets available for benefits represent payments on behalf of participants to cover distribution costs.

**Subsequent events**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

**3. INCOME TAX STATUS:**

The Plan obtained its latest determination letter on June 15, 2016, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**4. ADMINISTRATION OF PLAN ASSETS:**

The Plan's assets, which consist entirely of Burke, Inc. common shares, are held by the Plan Trustee. Company contributions are held and managed by the Company, which invests cash received, and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**6. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Changes in Fair Value of Level 3 Assets**

The Plan distributed 31,641 shares valued at \$13,777,293 of the Plan's level 3 assets for the year ended December 31, 2024. The Plan distributed 17,443 shares valued at \$7,259,163 of the Plan's level 3 assets for the year ended December 31, 2023.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

The fair value of Burke, Inc. common stock held by the Plan is valued based upon an independent appraisal. This appraisal is based upon a combination of the market and cash flow valuation techniques consistent with prior years as illustrated in the following table.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**7. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS:**

The Plan invests in Company common stock. These transactions qualify as party-in-interest transactions. As described in Notes 1 and 4, the Plan has a number of service providers. These service providers qualify as parties-in-interest.
