## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Dynamic Aviation Group, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1. Plan Description

The following description of the Dynamic Aviation Group, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Dynamic Aviation Group, Inc. (the Company or Plan Sponsor). Effective March 29, 2022, the Plan was amended and restated to adopt certain regulatory changes. Plan provisions remained substantially unchanged from the amendment and restatement that was effective on January 1, 2020. The Plan is intended to satisfy all requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** Employees of the Company who have reached 18 years of age and who have completed six months of qualifying service in an eligible position or classification may participate in the Plan.

**Contributions:** Employees are automatically enrolled in the Plan on the date they become eligible at a salary deferral rate of 6% unless they elect a different deferral rate or choose not to defer. Participants may make salary deferral contributions from pre-tax and after-tax annual compensation, as defined in the Plan, up to limits established by the Plan and the IRC. Deferral rates may be changed from time to time according to Plan provisions. The Company may match contributions and may make discretionary contributions as determined by the Board of Directors. For the year ended December 31, 2024, the Company matched contributions to the Plan at 25% of the first 8% of participant's salary contributed to the Plan as a base match. The Plan did not make any other discretionary contributions for the year ended December 31, 2024. The Plan accepts rollovers from other qualified plans.

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits:** On termination of service due to retirement at age 65, disability, death or termination of employment, a participant (or participant's beneficiary in the event of death) may elect to receive a distribution. Hardship withdrawals and in-service withdrawals at age 59½ are also permitted, subject to provisions described in the Plan document. Benefits are payable in lump sum payments. Benefits are recorded when paid.

**Participant accounts:** Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant investment options:** Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options anytime throughout the year.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participants' account attributable to the Company's matching contributions also vests immediately. The portion of the participants' accounts attributable to the Company's non-elective contributions is vested according to a three-year cliff vesting schedule. Participants also become 100% vested upon attainment of normal retirement age, upon total disability or death.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance of the participant's account. The loan interest rates are commensurate with prevailing rates.

**Forfeited accounts:** Forfeitures are first used to pay administrative expenses, then to offset Company contributions. There were no forfeitures for the year ended December 31, 2024.

### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and expenses during the reporting period. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans, considered deemed distributions, are reclassified as distributions based upon the terms of the Plan agreement. At December 31, 2024 and 2023, there were no deemed distributions included in notes receivable from participants in the accompanying statements of net assets available for benefits.

**Payment of benefits:** Benefits are recorded when paid.

**Risks and uncertainties:** Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Reclassifications:** Certain amounts on the statements of changes in net assets available for benefits have been reclassified, with no effect on net assets, to be consistent with the current period presentation.

**Subsequent events:** The Plan has evaluated subsequent events through October 3, 2025 the date the financial statements were available to be issued.

### Note 3. Plan Administration

A substantial portion of the costs of Plan administration are absorbed by the Plan Sponsor.

### Note 4. Information Certified and Provided by the Custodian

### Note 5. Collective Investment Trust

The custodian's Stable Value Fund (the Fund) offered to participants of the Plan is managed by The Principal Group. The Fund seeks to provide a low-risk, moderate-yield investment by earning returns and preserving capital, high credit quality and liquidity to pay Plan benefits. Income is accrued daily and reinvested in the Fund. The accrual of income is reflected in the Fund's unit price which is priced daily and is not held constant.

The gross crediting rate formula is negotiated in the wrap contract and is typically represented as:

$$\begin{aligned} \text{CR} &= (\text{MV}/\text{BV})^{(1/\text{D})} * (1 + \text{YTM}) - 1 \text{ where:} \\ \text{MV} &= \text{market value of portfolio} \\ \text{BV} &= \text{book value of portfolio} \\ \text{D} &= \text{weighted average duration of portfolio} \\ \text{YTM} &= \text{annualized dollar or duration weighted yield to maturity of the portfolio} \end{aligned}$$

The net crediting rate is equal to the gross crediting rate minus the wrap fee due the contract issuer and if applicable, minus the sub-advisor fees for specific investment strategies. Crediting rates reflect the amortization of realized and unrealized gains and losses in the underlying portfolio over the duration of the portfolio and, in consequence, may not reflect the actual returns achieved in the portfolio. From time-to-time the crediting rate may be significantly greater or less than current market interest rates.

A number of factors can influence future crediting rates, which may include but are not limited to: portfolio cash flows, underlying portfolio performance, current market interest rates for reinvestment, duration posture, change in credit ratings, default or bankruptcy by an asset or wrap issuer, the unexpected receipt of principal and interest payments, extraordinary withdrawals and certain wrap contract terms, including wrap fees.

The gross crediting rate formula is also subject to re-negotiation by the contract issuer and/or the contract holder. Events which may warrant the use of a different crediting rate formula or variables utilized in the formula illustrated above include, but are not limited to, depressed market value to book value ratios, credit events or pricing pressures within the wrapped portfolio that impacts market valuation.

**Events limiting contract value treatment:** Market value events may limit the ability of the Fund to transact at contract value with the issuer. Market value events are events or conditions that occur which are outside of the normal operation of the Fund and lead to any Fund disbursements which have or will have a material adverse effect on the operations of the Fund and a financial effect on the investment contract or wrap issuer's interest hereunder.

Such events may include but are not limited to: Fund administration is amended or changed, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of the Fund, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the Fund, transfers to competing options without meeting the equity provisions of the Fund, and Plan Sponsor withdrawals without the appropriate notice to the Fund and/or issuer.

In the normal course of business, such events or conditions described above would not limit the ability of the Fund to transact at contract value with the participants in the Fund. The Fund is managed to maintain a certain amount of liquidity to provide for the day-to-day liquidity needs of participants as well as the occasional market value event.

**Termination events by the issuer:** An issuer can terminate an investment contract upon the event of default by the contract holder, adviser, or trustee if the issuer determines in its reasonable discretion such event has had, or is likely to have, a material adverse effect on the issuer's interest with respect to the contract.

**Termination events by the issuer (continued):** Such events may include but are not limited to: management of the portfolio is not in accordance with investment guidelines, a breach of any material obligation under the wrap agreement, any representation or warranty made by the contract holder becomes untrue in any material way, a replacement of the adviser without prior consent of the issuer, the Fund is terminated or ceases to qualify as a group trust or plans cease to meet the appropriate tax qualifications, or the wrap becomes a prohibited transaction within the meaning of Section 406 of ERISA.

#### Note 6. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Mutual funds, for which a quoted market price is available on an active market, are classified as Level 1 in the fair value hierarchy.

**Pooled separate accounts:** Valued at the net asset value (NAV) per share held by the Plan at year-end.

*Common collective trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Pooled separate accounts are invested in a number of underlying investments whose investment strategies are as follows. The investment objective of the small-cap, mid-cap and large-cap investments is capital appreciation through growth of capital and current income. The international/global investments seek to provide high total investment return and long-term growth of capital, through investment in United States and foreign companies. The balanced investments seek the highest total return over time consistent with an emphasis on both capital growth and income. The objective of bond investments is to maximize total return by investing primarily in a diversified portfolio of intermediate and long-term debt securities.

#### Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

#### Note 8. Tax Status

The Plan adopted a standardized form of a prototype plan sponsored by the Company. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Management evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.
