Independent Auditors' Report

To the Participants and Plan Administrator of
United Electric Supply Company Employee Stock Ownership Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of United Electric Supply Company Employee Stock Ownership (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the United Electric Supply Company Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is an leveraged employee stock ownership plan (ESOP) established effective January 1, 1995. In 2011, the Plan was amended and restated. The Plan covers substantially all employees of United Electric Supply Company, Inc. (the Company) who (1) were participants of the 401(k) Plan on December 29, 1995, (2) were certain employees of Mohawk Electric Supply on or after September 2, 2002, or (3) who have completed at least one year and 1,000 hours of service and who have attained age 21. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by a committee of individuals appointed by the Company's Board of Directors (the Committee). The Plan's Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Administrator. The Plan is administered under a written plan adopted by the Company and in accordance with a written trust agreement entered into between TI-TRUST, Inc. (the Trustee) and the Company.

On December 29, 1995, the Plan acquired approximately 98% of the outstanding common stock of the Company. On January 9, 1996, the Plan purchased the additional 2% of newly issued common stock from the Company, which was accounted for in 1995 at the inception of the Plan. The acquisition of the outstanding and newly issued Company common stock was financed in part through voluntary employee transfers to the ESOP from the 401(k) Plan and in part through a loan to the ESOP from the Company. This loan was financed through ESOP loans to the Company from a bank which has since been paid in full. All stock in the Plan had been allocated to participants as of December 31, 2023.

On November 1, 2024, the Company completed a merger with Kovalsky-Carr (KC Co.) and as a part of the merger, all issued and outstanding shares of KC Co. common stock converted into the right to receive shares of United Electric Supply Company, Inc. common stock, valued at approximately \$2,200,000. The shares were pledged as collateral for the note payable issued by the Company to the Plan to purchase the stock. Each year, the Company contributes an amount to the Plan required to repay the loan, and the Plan allocates shares to participants in proportion to the principal and interest repaid on the loan on a pro-rata basis, to employee participants based on eligible earnings.

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with their share of the Company's discretionary contributions and an allocation of forfeitures of terminated participants' nonvested accounts. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

If a participant's employment with the Company is terminated for any reason other than retirement, permanent disability, or death, vesting in their contributions is based on years of continuous service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service. In the event of death, disability or attainment of age 59 of the participant prior to termination of employment, a participant is 100% vested automatically.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account by directing the Committee which in turn directs the Trustee, as to the manner in which to vote those shares (including fractional shares), and is notified by the Trustee, prior to the time that such rights are to be exercised. The Trustee is required to vote any shares that are not allocated to participants on behalf of the best interests of the plan participants and beneficiaries. The Trustee, however, is not permitted to vote any allocated share for which instructions have not been given by a participant. There were 937.0929 unallocated shares as of December 31, 2024 and no unallocated shares as of December 31, 2023.

Payment of Benefits

In the event of a participant's normal retirement, death or disability, distributions will commence as soon as possible following that event. Distribution for terminations for other reasons commence as soon as practicable on or about June 30 following the end of the fifth "Allocation Date," defined as December 31 (the last day of each plan year), after termination of service. Distributions will be either lump-sum or installments over five years, based on the provisions of the Plan. If the termination of employment is due to death of the participant, payment shall be made to his or her beneficiary or, if none, his or her legal representatives. Distributions may be made in cash or Company common stock, or a combination of both. The amount to be distributed is based on the appraised stock value immediately preceding valuation date. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. The Company repurchased and retired 6,440 shares during 2024.

All distributions resulting from death of a participant shall be made in two installments. The first installment shall be made as soon as practicable after notice is received of the participant's death and shall be a cash distribution in an amount equal to 50% of the participant's account balance based on the most recently appraised stock value as of that time. The remaining balance of the participant's account shall be distributed on or about the following June 30.

Forfeited Accounts

Nonvested account balances that have been permanently forfeited after a five consecutive one-year break-in-service are reallocated to remaining participants. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$102,907 and \$148,049, respectively. These accounts will be allocated to participant accounts of those employed on the last day of the plan year. During 2024, 31.3057 shares of common stock (valued at \$74,911) were reallocated to participant accounts from forfeited nonvested accounts, in accordance with plan provisions.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to convert the stock to cash.

The put option permits the participant (or beneficiary) to sell such Company common stock to the Company at any time during two option periods, at the then current appraised fair market value. The first put option period is for 60 days beginning on the date of distribution. The second put option period is for at least 60 days beginning after the new determination of appraised fair market value (and notice to the participant thereof in the following plan year). The Company may allow the Plan to purchase shares of Company common stock tendered to the Company under a put option. The payment for any Company common stock sold under a put option shall be made within 30 days if the shares were distributed as part of an installment distribution. If the shares were distributed in a lump sum distribution, payment shall commence within 30 days and may be made in a lump sum or in substantially equal, annual installments over a period not exceeding five years, with adequate security provided and interest payable at a reasonable rate on any unpaid installment balance (as determined by the Company or the Committee).

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who reach age 54 and have completed at least seven years of participation in the Plan are permitted to withdraw 25% of their stock account. In addition, participants are permitted to withdraw 50% of their stock account during the first plan year at the beginning of which the participant has attained at least age 59 and seven years of participation under the Plan. If a participant does not elect diversification that year, then similar provisions are in place for a participant who is age 55 and has ten years of service. Participants who are permitted to diversify receive a cash distribution.

Administration of Plan Assets

The Plan's assets, which consist principally of Company common stock, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest and dividend income and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan for the year ended December 31, 2024.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and based on the remeasurement of the Company's common stock price annually.

Payment of Benefits

Benefits are recorded when paid.

Recent Regulatory Updates

The Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (SECURE 2.0 Act) was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Expenses

Administrative expenses may be paid either by the Company or the Plan. The Company has historically paid the operating expenses of the Plan, which are not included in these financial statements.

Subsequent Events

Subsequent events were evaluated through October 10, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of United Electric Supply Company, Inc. common stock was \$2,392.89 and \$2,269.43 per share at December 31, 2024 and 2023, respectively, as determined based on an appraisal by an independent ESOP valuation specialist and therefore the value of the Company common stock is considered a Level 3 fair value measurement due to the use of significant unobservable inputs. The valuation incorporates the discounted cash flow and guideline public company methodologies (market approach).

The valuation process involves the selection of an appraiser under contract for a term of one year with the right to cancel such contract at any time. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution. The Trustee reviews and approves the report.

The discounted cash flow methodology utilizes a 5-year model that discounts projected annual debt-free cash flows of the Company. This methodology reflects the risk adjusted growth value inherent in the long-term prospects of the business based on a forecast discussed with management.

The guideline public company methodology (market approach) is intended to demonstrate how investors value companies that participate in similar markets and are affected by similar economic factors. Comparable company multiples have been discounted for advantages over the Company such as access to debt and equity markets, size and product diversification.

Money market fund is valued at the quoted net asset value of shares held by the Plan at year end.

Certificates of deposits consisted of investments held by Capital One Bank and Synchrony Bank and were valued at quoted market prices in active markets for similar assets.

5. Note Payable

In 2024, the Plan purchased 969.4064 shares of the Company's common stock with a loan from the Company in the amount of \$12,764,755. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the Plan. The note matures in December 2053 and bears interest at 5.03%. The borrowing is collateralized by the unallocated shares of common stock. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 32.3135 shares being released and allocated for the plan year ended December 31, 2024.

6. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, TI-TRUST, Inc., the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

7. Related-Party and Party in Interest Transactions

The Plan invests in Company common stock. The Company, as the sponsor of the Plan, therefore, is a related party and transactions with the Company qualify as party in interest transactions.

TI-TRUST, Inc. is the Trustee of the Plan and manages the investments of the Plan. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan are performed by employees of the Company. No such employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon termination of the Plan, the Plan Administrator directs the Trustee to pay all liabilities and expenses of the Plan and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the plan agreement and the IRC. In the event of plan termination, participants would become 100% vested.

9. Tax Status

The IRS has determined and informed the Company by a letter dated September 25, 2013, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$112,919,976 and \$118,559,821, respectively that were concentrated in Company common stock.
