Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Rima Manufacturing Company Employees' Retirement Savings Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 – Description of Plan

The following description of the Rima Manufacturing Company Employees' Retirement Savings Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan established for the purpose of providing income upon retirement, death, or disability to full-time non-collective bargaining employees who are age twenty-one or greater and have at least three months of service with Rima Manufacturing Company (the Plan Administrator and Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of the Plan's earnings (losses) based on participant account balances. Participants direct the investment of all contributions among the investment funds offered by the Plan. The benefit to which a participant is entitled to, is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms of the loan are based on the terms of the individual promissory note. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid through payroll deductions.

Contributions

Participants may elect to defer up to a maximum of 100% of their compensation, as defined in the Plan document, as pre-tax and/or Roth contributions, or may elect not to participate in the Plan. If an employee does not make an election, the employee will be automatically enrolled at an initial pre-tax deferral rate of 3%. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

Effective January 1, 2024 and for the year ended December 31, 2024, the Plan was amended to require the Company to make a safe harbor matching contribution equal to the sum of 100% of a participant's elective deferrals that do not exceed 3% of participant's compensation, plus 50% of the participant's elective deferrals that exceed 3% but do not exceed 5% of the participant's compensation. During the year ended December 31, 2023, the Company provided a discretionary matching contribution of 100% up to the first \$2,000 of deferrals. The Company may also contribute a discretionary non-elective contribution, as further defined in the Plan document. There was no discretionary non-elective contributions during the years ended December 31, 2024 and 2023.

Benefit Payments

Upon retirement, death, disability, termination, or as otherwise defined in the Plan document, participants are entitled to receive the value of their account in a lump-sum payment.

Vesting

Participants are immediately vested in their contributions (including related earnings and losses). Company contributions and related earnings (losses) become fully vested after three years of service. Safe harbor matching contributions, which were effective January 1, 2024, are immediately fully vested.

Forfeitures

Forfeited balances of terminated participant's non-vested accounts may be used to pay administrative expenses or to reduce Company contributions, as directed by the Plan Administrator. Forfeited non-vested accounts totaled \$10,855 and \$1,241 at December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Administrative Expenses

Administrative expenses are paid for by the Plan, or the Company, for services rendered by parties-in-interest.

Note 2 – Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There have been no changes in the valuation methods used. The Plan's investments are held by Fidelity Management Trust Company (the Trustee).

Investment Valuation and Income Recognition (continued)

Mutual funds represent investments with various investment managers. The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable equity and fixed-income securities. Shares held in mutual funds are valued at net asset value.

Money market funds are valued using the amortized cost method as permitted by Rule 2a-7 under the Investment Company Act of 1940, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

Note 3 – Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) of investments, and interest and dividends for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee.

Note 4 – Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Note 6 – Income Tax Status

The Internal Revenue Service ruled on June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA (the prototype plan of the Trustee upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that those changes could materially affect the amounts reported in the statements of net assets available for benefits.
