NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Onshore Technology Services, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General: The Plan is a safe harbor defined contribution plan covering employees of Onshore Technology Services, Inc. and other companies related through common ownership (the Company). The Plan was established October 1, 2007, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: There is no age or service requirement for employees to contribute to the Plan. Employees are required to complete one year of service to receive Company contributions. Employees covered by a collective bargaining agreement, nonresident aliens, and residents of Puerto Rico are not eligible to participate in the Plan. Employees must complete more than 500 hours of service during the Plan year to be eligible for a discretionary profit-sharing contribution.

Contributions: Participants may contribute up to 100% of pre-tax or post-tax annual compensation, as defined in the Plan, not to exceed maximum amounts specified by the Internal Revenue Service (IRS), in accordance with a participant salary deferral agreement. Participants who are at least 50 years of age may make an additional contribution to the Plan not to exceed \$8,000 in 2024 and \$7,500 in 2023, under certain conditions. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company is required to make a match equal to 100% of each participant's deferral contributions up to 3% of participant salary, plus 50% of each participant's deferral contributions between 3% and 5% of participant salary. The Company met the required funding minimum. Additional profit-sharing amounts may be contributed at the discretion of the Company. There were no additional discretionary profit-sharing contributions during 2024 and 2023. Participants direct the investment of contributions into various investment options offered by the Plan.

Participant accounts: Each participant's account is credited with the participant's contributions, Company contributions, the participant's rollover contributions from other qualified benefit plans, and an allocation of Plan earnings, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are automatically 100% vested in both their elective salary deferrals and the Company's safe harbor contributions. Participants vest in Company discretionary contributions at a rate of 20% after two years of service and in 20% increments each subsequent year with full vesting in Company contributions occurring after six years of service. A participant is considered to have one year of service for each one-year period in which he or she has worked 1,000 hours or more.

Participants become automatically 100% vested in Company discretionary contributions upon attaining age 59 ½, upon total disability, or upon death.

Forfeitures: Forfeitures are used to pay plan administrative expenses or used to reduce Company contributions. At December 31, 2024 and 2023, forfeited nonvested amounts available for future use totaled \$8,409 and \$0, respectively. During the years ended December 31, 2024 and 2023 no forfeitures were used to reduce Company contributions or pay plan expenses.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are payable ratably through payroll deductions.

Distribution of benefits: Upon termination of service, a participant or his/her beneficiary may receive benefit distributions in one of the following forms:

- 1) A single lump sum payment, which may be in the form of a cash payout or rolled over into another qualified pension plan.
- 2) Partial payments.

Administration: Standard Retirement Services, Inc. (Standard) is the Plan's third-party administrator and record-keeper. The record-keeper maintains the individual participant accounts and provides records of balances and transactions to the Plan administrator and participants. Standard Insurance Company is the Plan's custodian. The custodian holds the Plan's assets, administers investment activity, and invests contributions into funds designated by each participant. Certain administrative and record-keeping costs are being absorbed by the Company. The Company's Board of Directors is responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Valuation of investments: Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the declaration date. Interest is recorded when earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities of the Plan are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions: Contributions from plan participants and the matching contributions from the Company are recorded in the year which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Ineligible contributions payable: Certain employees made contributions to the Plan based on ineligible compensation in previous years. These ineligible contributions were included in the financial statements as a reduction in employee contributions for the year ended December 31, 2023, and refunded to the affected participants during 2024.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent events: Events that have occurred subsequent to December 31, 2024, have been evaluated through October 1, 2025, which represents the date the Plan's financial statements were approved by management and, therefore, available to be issued.

3. TAX STATUS

Effective March 1, 2019, the Plan adopted a volume submitter plan sponsored by Standard. The IRS has determined and informed Standard by a letter dated March 31, 2014, that the non-standardized prototype profit sharing plan sponsored by Standard is in a form acceptable under section 401 of the Internal Revenue Code (IRC). The Plan adopted a Cycle 3 Restatement effective January 1, 2022, as an amendment and restatement of the existing plan to bring the Plan into compliance with legislative and regulatory changes. There were no significant changes to plan provisions as a result of the restatement. The IRS has determined and informed Standard by a letter dated June 30, 2020, that the non-standardized pre-approved profit-sharing plan as amended through December 31, 2018, is in a form acceptable under section 401 of the IRC.

An adopting sponsor may rely on the opinion letters issued by the IRS as evidence that the Plan is qualified under the applicable sections of the IRC. The Plan is relying on the opinion letters. Although the Plan has been amended since receiving the opinion letters, the Plan administrator believes the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan is qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

The Company experienced a significant reduction in staffing during 2024, resulting in a partial plan termination. Accordingly, all affected plan participants became fully vested in their accounts as a result of the partial plan termination.

5. TERMINATED PARTICIPANTS

Net assets available for benefits at December 31, 2024 and 2023 included \$1,777,557 and \$915,402, respectively, allocated to the accounts of individuals who, as of or prior to that date, had withdrawn from actively participating in the operations of the Plan, generally as a result of terminating employment. These amounts may be paid within the next year, at the request of the participants. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

6. CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard Insurance Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate.

- Investments at fair value as shown in the statements of net assets available for benefits,
- Investments at contract value as shown in the statements of net assets available for benefits,
- Investment income as shown in the statements of changes in net assets available for benefits,
- Schedule of assets held at year end.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. FAIR VALUE OF INVESTMENTS

Plan investments are held in a trust managed by Standard Insurance Company, the Plan's custodian, and are unsecured. Therefore, these transactions qualify as party-in-interest transactions.

A fair value hierarchy is used that prioritizes the inputs to valuation techniques used to measure fair value of balances that are required or permitted to be measured at fair value for reporting in financial statements. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets recorded at fair value.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan at year- end. The NAV is used as a practical expedient to estimate fair value. The pooled separate accounts are not publicly traded. Individual participant accounts invested in the pooled separate accounts are maintained on a unit value basis. The pooled separate accounts held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The plan entered into a traditionally fully benefit-responsive guaranteed investment contract with Standard Insurance Company, the custodian, totaling respectively. The custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Transfers out of these contracts are limited to 25% of the contract amount in a calendar year.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statement of net assets available for benefits. Contract value, as reported to the plan by the custodians, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without consent of the issuer

9. ADOPTION OF NEW ACCOUNTING STANDARD

On January 1, 2023, the Plan adopted Accounting Standard Update (ASU) 2016-13 Financial Instruments-Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, as amended. This standard replaces the incurred loss methodology with the current expected credit loss (CECL) methodology. The CECL methodology is used to measure expected credit losses on financial assets at amortized cost, including receivables. The standard specifically excludes participant loan receivables from consideration; however, contribution receivables are subject to the CECL methodology. The adoption of this standard did not have a material impact on the Plan's financial statements.
