Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the IdeaTek Telcom, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the IdeaTek Telcom, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions. The Savings and Retirement Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

General - The Plan is a Safe Harbor defined contribution plan covering substantially all employees of IdeaTek Telcom, LLC (Company) excluding collective bargaining (union) employees, part-time employees and non-resident aliens. Employees are treated as eligible to participate upon hire and enrolled on the first day of each quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions - Each year, participants may contribute up to 75% of eligible pretax annual compensation up to the maximum allowed by the Internal Revenue Code (\$23,000 in 2024). Participants may also contribute after tax Roth elective contributions as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are accounted for in the period the employee contributions are withheld. The Company contributes a Safe Harbor match that is 100% of the first 3% of base compensation that a participant contributes to the Plan, and an additional match of 50% of the next 2% that a participant contributes (an effective 4% match). The Plan also allows for a discretionary additional matching contribution under the Safe Harbor Plan. The discretionary matching contribution will not apply to elective deferrals exceeding 6% of the participant's compensation. Participants direct the investment of their contributions, as well as their portion of the Company's contributions, into various investment options offered by the Plan.

The Plan has elected an automatic escalation to participant contribution rates. The participant's elective deferrals will increase by 1% each year up to a maximum of 75% of compensation unless the participant has filed a contrary election.

Participant Accounts - Each participant's account is credited with the participant's contribution, allocations of the Company's safe harbor match contribution, discretionary match contribution, Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Vesting - Participants are vested immediately in their contributions and safe harbor matching contributions, plus earnings thereon. Discretionary matching contributions are subject to vest and are based on years of service. A participant is fully vested in their discretionary matching contributions after six years of service. Participants become fully vested upon death or disability.

Payment of Benefits - On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial distributions if the balance is greater than \$5,000. In-service withdrawals are allowed for participants over 60 years of age and for financial hardships, as defined by the Plan.

1. DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1% as of the date of the note. Principal and interest are paid ratably through regular payroll deductions. Notes receivable may not exceed five years unless the note is for the purpose of purchasing a personal residence, in which case the term may be up to fifteen years.

Forfeitures - At December 31, 2024 and 2023, there were no forfeited non-vested accounts. Forfeitures may be used to reduce the Company's matching contribution or pay Plan administrative fees.

Normal Retirement - Normal retirement age is the later of age of 65 or the fifth anniversary of the first day of the plan year in which the participant commenced participation in the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Savings and Retirement Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. The purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefits Paid - Benefits are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses - The Company provides certain administrative services and pays administrative expenses on behalf of the Plan. As the Plan does not reimburse the Company for the costs of such services, they are not included in these financial statements. Some investment-related expenses may be included in net change in fair value of investments.

Subsequent Events - The Plan Administrator has evaluated subsequent events through October 2, 2025, the date these financial statements were available to be issued.

3. INFORMATION CERTIFIED BY INTRUST BANK, N.A. (UNAUDITED)

The following is a summary of the information as of December 31, 2024 and 2023, and for the year-ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by INTRUST Bank, N.A. (INTRUST) and furnished to the Plan Administrator. The Plan Administrator has obtained certification from INTRUST that information provided to the Plan Administrator by INTRUST related to the following assets is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information below, the fair values in Note 4, and the values in the supplemental schedule related to the following assets:

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The following describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds - These investments are valued using a quoted price in an active market.

Stable Value Fund - This investment is valued at net asset value (NAV) which is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it's determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly manner. The category invests in guaranteed investment certificates and money market instruments.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the Plan shall be fully vested at the time of termination, and INTRUST shall liquidate all assets of the trust and continue to administer the trust in accordance with its provisions until all obligations have been satisfied.

6. TAX STATUS

The Plan adopted a Prototype Non-Standardized Profit Sharing Plan designed to qualify under Section 401 of the Internal Revenue Code. The Plan has obtained a copy of a favorable determination letter for the prototype profit sharing plan dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon

examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are managed by INTRUST and therefore, these transactions qualify as parties-in-interest transactions. The various funds' operating expense ratios ranged from 0.035% to 0.98%, as of December 31, 2024. Total fees incurred and paid directly by the Plan for the investment management services were \$957.
