Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Arrow Tru-Line, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1 – Description of Plan

The following description of the Arrow Tru-Line, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan, as amended and restated, is a defined contribution plan covering all eligible employees, as defined in the Plan document, of Arrow Tru-Line, Inc. (the Company and Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of the Plan's earnings (losses) based upon participant account balances. Participants direct the investment of all contributions among the investment funds offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms of the loan are based on the terms of the individual promissory note. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid through payroll deductions.

Contributions

The Plan automatically enrolls employees who meet the eligibility requirements at an initial pre-tax deferral rate of 3% if an employee does not make an election. Deferral rates for participants that were automatically enrolled are automatically increased at the beginning of each year by 1%, to a maximum pre-tax deferral rate of 6%. Participants may elect to make pre-tax and Roth deferrals in an amount up to 92% of their eligible compensation, as defined in the Plan document. Participants over age 50 may defer catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

During 2024 and 2023, the Plan provided a safe harbor matching contribution equal to 100% of each participant's contribution up to 3%, plus 50% of each participant's contribution from 3% to 5%, as defined by the Plan document.

Contributions (continued)

Each year, the Company may elect to contribute a discretionary non-elective contribution to those participants with 1,000 hours of service in a Plan year and who are employed on the last day of the Plan year. The contribution is allocated based upon percentages of total eligible wages. For years ended December 31, 2024 and 2023, there were no discretionary non-elective contributions made to the Plan.

Payment of Benefits

The Plan generally provides that upon retirement, death, disability, or termination, participants are entitled to receive the vested value of their account by lump sum payment, or as otherwise described in the Plan document.

Vesting

Participants are immediately 100% vested in all of their accounts, plus actual earnings (losses) thereon.

Forfeitures

Forfeited amounts are applied to matching contributions and/or plan expenses, as defined by the Plan document.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA.

Administrative Expenses

Certain loan administrative expenses are paid by the Plan, as described in the Plan document. The Company paid for other costs of administering the Plan. The services are rendered by parties-in-interest to the Plan.

Note 2 – Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded when paid.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used.

Mutual funds represent investments with various investment managers. The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

The Empower Investments Fixed Account – Series Class I is a fully benefit-responsive investment contract valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan, it is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts.

Common/collective trust funds (CCTs) represent investments with various investment managers. Units held in CCTs, including stable value funds, are fair valued at the net asset value (NAV). The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that could affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Arrow Tru-Line, Inc. was acquired by Chamberlain Group on September 8, 2025. There are no current stated intentions to change the status of the Plan. Management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued, noting no additional subsequent events requiring disclosure.

Note 3 – Investments

Empower Trust Company, LLC and Empower Annuity Insurance Company of America held Plan assets and executed transactions beginning June 16, 2023 through December 31, 2024. The prior trustees, Mid Atlantic Trust Company and Capital Bank and Trust Company, held assets during 2022 and until the transfer was completed in December 2023. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) of investments, and dividends and interest for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Trust Company, LLC, Empower Annuity Insurance Company of America, Mid Atlantic Trust Company, and Capital Bank and Trust Company.

Note 4 – Investment in Empower Investments Fixed Account – Series Class I

The Plan holds a fully benefit-responsive group annuity contract, the Empower Investments Fixed Account - Series Class I, with Empower Annuity Insurance Company of America. The Empower Investments Fixed Account - Series Class I is a general account product of Empower Annuity Insurance Company of America. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest crediting rate is reset quarterly. As described in Note 2, contract value is the relevant measurement attribute for this fund.

Certain events limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Such events include premature termination of the contracts by the Plan, layoffs, Plan termination, bankruptcy, mergers and early retirement incentives. In addition, the Empower Investments Fixed Account - Series Class I investment may delay a Plan Sponsor initiated withdrawal as defined in the contract. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable. There are no reserves against contract value for credit risk of Empower Annuity Insurance Company of America or otherwise.

Note 5 – Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 7 – Income Tax Status

The Internal Revenue Service ruled on November 14, 2022, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA (the document upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
