Opinion

We have audited the financial statements of Great Plains Manufacturing, Inc. Employees' Beneficiary Association Trust (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974*, which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of Great Plains Manufacturing, Inc. Employees' Beneficiary Association Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General The Plan provides health and other benefits to eligible employees of Great Plains Manufacturing, Inc.; Great Plains Logistics, Inc.; Great Plains Trucking, Inc.; and Great Plains Acceptance Corporation (collectively, the Controlled Group). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Benefits The Plan provides health benefits including medical, hospital, surgical, major medical, and dental to regular full-time employees who work 40 hours or more per week, and part-time employees who work less than 40 hours per week. These benefits may also be extended to their covered dependents. Terminated employees, or their qualified beneficiaries, may elect to continue this coverage under the Consolidated Omnibus Budget Reconciliation Act of 1965 (COBRA) by paying required timely premiums.

Contributions In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Controlled Group makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Controlled Group on a pay-as-you-go basis.

Payment of Benefits The third-party claims administrators disburse claim payments that are determined to be due to the person or assignee entitled thereto in accordance with provisions of the Plan. The Plan pays the third-party claims administrators a fee for these services.

Plan Termination The Controlled Group may amend or terminate the Plan at any time subject to the provisions of the Plan and ERISA. No amendment or termination may discontinue or curtail the benefits that have accrued to any participant or beneficiary prior to the adoption of such amendment or termination. Upon termination of the Plan, all funds of the Plan shall be used to pay all benefits accrued under the Plan and to pay additional benefits for participants as determined by the Plan administrator. No assets of the Plan may revert to the Controlled Group or be used for purposes other than for the exclusive benefit of the Plan's participants.

Stop-Loss Coverage The Plan has entered into a stop-loss insurance agreement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount).

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The accounting records of the Plan are maintained on a modified cash basis of accounting. The modified cash basis is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP), wherein transactions arising from cash receipts and cash disbursements are reflected in the reporting of net assets available for benefits and changes in net assets available for benefits. If these statements were prepared on the accrual basis of accounting, such assets and liabilities as contributions receivable and accrued expenses would be included in the accompanying financial statements to present fairly the Plan's financial status and changes in its financial status in accordance with GAAP.

Use of Estimates The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits Claims payments are recorded when paid by the third-party claims administrators.

Expenses The Plan pays administrative expenses that consist primarily of fees paid to third-party claims administrators. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses and reinsurance premiums. All other administrative expenses, such as professional fees, are paid by the Controlled Group on behalf of the Plan and are excluded from these financial statements.

Stop-Loss Coverage Premiums for stop-loss insurance are included in administrative expenses and reinsurance premiums paid in the accompanying statements of changes in net assets available for benefits.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3. BENEFIT OBLIGATIONS

Plan benefit obligations for health claims incurred but not reported are estimated by the Plan's claim administrator at the present value, based on historic claims experience and actual claims reported subsequent to the Plan's year end.

The Plan's benefit obligations consist of amounts currently payable for health claims incurred but not reported for both active employees and separated employees who are participating through COBRA. The obligations will be funded by future participants, contributions from the Controlled Group, and stop-loss reimbursements.

4. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As described in notes 1 and 2, the Plan has several arrangements with service providers which are considered party-in-interest transactions under ERISA.

5. TAX STATUS

The Plan is part of a trust established February 1, 1989, to provide employee benefits as prescribed by the *Internal Revenue Code* (IRC). The trust qualifies as a not-for-profit trust under IRC section 501(c)(9); accordingly, no provision for federal or state income taxes has been made in the accompanying financial statements. The Plan has been amended after it was qualified; however, the Plan administrator believes the Plan, as amended, continues to qualify and is operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the related trust is tax exempt.

6. RISKS AND UNCERTAINTIES

The benefit obligations in note 3 are reported based on certain assumptions pertaining to claims experience and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
