Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Engle Printing & Publishing Company, Inc. 401(k) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of Engle Printing & Publishing Company, Inc. 401(k) Plan (the plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: Engle Printing & Publishing Company, Inc. 401(k) Plan is a defined contribution plan covering all employees of Engle Printing & Publishing Company, Inc., (the Company) who have attained age 21 and meet certain service requirements. The service requirements are: a.) three months of service with no hour requirement, b.) The Plan entrance dates are quarterly and c.) Employer matching has a service requirement of three months. Profit-sharing contributions eligibility requirements consist of 1,000 hours of service required in a twelve-month period and to be employed at the end of the year. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2022, the Plan adopted CCH Incorporated DBA ftwilliam.com Non-Standardized Pre-approved Defined Contribution Plan updated on June 30, 2020. This was due to the prior terminology of "Master," "Prototype" and "Volume Submitter" plans being eliminated and replaced with the single term of Pre-Approved Plan for the required Cycle 3 Restatement.

Contributions: Each year, participants may make pre-tax or after-tax contributions up to 25% of annual compensation as defined in the Plan. Roth contributions (after tax) will be subject to federal income tax in the year of deferral, but any earnings thereon will generally not be taxed upon distribution provided funds are not withdrawn within five years and other conditions are met. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Company contributes 50% of the first 8% of base compensation that a participant contributes to the Plan. The Plan automatically enrolls participants into the Plan whereby employees who are eligible to participate, but are not deferring, shall have elective deferrals withheld in the amount of 5% of compensation unless they opt not to participate in the Plan. Additional profit-sharing contributions may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions. Profit-sharing contributions and forfeitures of terminated participants' nonvested accounts, if elected, are allocated to participants based on eligible compensation. Investment earnings are allocated based upon the participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions and actual earnings on these contributions. Vesting in the Company's contribution is based on years of service. After two years of service, participants become vested at 20%. Vesting increases 20% per year thereafter, until fully vested at six years of service. A participant is fully vested upon death, disability, normal retirement at age 65 and early retirement at age 55 with six years of service.

Participant Loans: Active participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan allows participants to take out two loans at a time for any purpose. Loans are secured by the balance in the participant's account and bear interest at local prevailing rates. Loan terms range from one to five years. Principal and interest are paid ratably through periodic payroll deductions.

Investment Options: Upon enrollment, participants may direct their participant account to any of the selected investments provided by the Plan. Participants may change their investment options anytime throughout the year.

Administrative Expenses: Administrative expenses are paid by the Plan, if not paid by the Plan Sponsor.

Payment of Benefits: Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the vested value of their account, or one of the optional forms of payment provided under the Plan. The Plan provides for in-service distributions from fully vested benefits if the participant is age 59½. Hardship withdrawals are also permitted if participants satisfy the criteria to qualify for such a distribution. Hardship withdrawals are permitted to be withdrawn from all vested money but are not permitted from the employer contribution account transferred from the employer's prior money purchase plan. Participants are allowed to take a hardship withdrawal without first having to take a plan loan.

Forfeitures: Forfeitures represent accounts with unvested Company contributions that arise from the termination of participants with less than fully vested benefits under the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,248 and \$13,073, respectively. Forfeitures can be reallocated to plan participants or used to reduce the employer matching and non-elective contributions. Forfeitures of \$12,803 were used to reduce employer matching contributions and \$1,368 were used for plan corrections during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition (Continued): Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Delinquent loans are treated as distributions based upon the terms of the plan document surrounding defaulted loans.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

Certain information related to investments is disclosed on the accompanying financial statements and ERISA-required supplemental schedules, including investments from participants held at December 31, 2024 and 2023, and net appreciation in fair value and contract value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the Plan's Custodian). Participant loans and related interest income are also certified.

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with FASB codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.

- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

Note 4. Investments and Fair Value Measurements (Continued)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Units of participation in pooled separate accounts are reported at the accumulated value of units held by the Plan at year-end as reported to the Plan by the insurance company. The accumulated unit value is determined daily by John Hancock Life Insurance Company (U.S.A.) and is based on the net asset value of shares in the underlying fund, the fund's dividends and the contract's separate account charges. While some pooled separate accounts may have publicly quoted pricing inputs (Level 1), the account values of pooled separate accounts are not publicly quoted and are, therefore, classified as Level 2 investments.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan has entered into a group annuity contract with John Hancock Life Insurance Company (U.S.A.) which provides for investments in various pooled separate accounts. These accounts are credited with earnings on underlying investments and charged for participant withdrawals and certain administrative expenses. The pooled separate accounts consist of various fund investment options covering multiple asset classes.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

Note 7. Tax Status

On January 1, 2022, the Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by CCH Incorporated DBA ftWilliams.com. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the pre-approved plan's qualified status. The Plan has since been amended; however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods currently in progress.

Note 8. Related Party and Party-In-Interest Transactions

Certain Plan investments consist of units of pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
